### Letter from Oregon Dept. of Forestry to Irene Allison

Dear Ms. Allison:

I appreciate your recent letter regarding the forest operation and subsequent Forest Practices Act violations on the Bussmann property near Port Orford. We are very concerned about the violations on the Bussmann property. This is currently the highest priority situation in the Forest Practices Program on the District in Curry, Coos and western Douglas counties, and will continue to receive our greatest attention possible throughout the course of the corrective repair measures that are required of Mr. Bussmann.

The Oregon Forest Practices Act is a system of laws and rules based upon forest landowner or operator notification to the Department of Forestry that a forest operation is planned to be conducted. The system is not based upon

permits, nor the issuing of permits. The notification of operations must include complete and accurate information about the planned operation, including its location. Unfortunately, in the Bussmann case, the geographic location information of the notification was not correct, and our Forest Practices Forester Dale Sheridan based his initial review of the operation on the incorrect location. Failure to provide complete and accurate information in the notification is a violation of the law. The responsibility for complete and accurate notification information (or for the lack of providing that information) rests squarely with the landowner or operator, in this case Mr. Bussmann. Oregon Revised Statutes (ORS) Chapter 527.670 requires this complete and accurate notification, and it is further defined by Oregon Administrative Rule (OAR) 629-24-108.

Our law enforcement policies and actions for violations of the Forest Practices Act include the issuance of citations, the assessment of civil penalties, and the issuance of corrective repair orders. In the Bussmann case, all three of these elements have been applied, and as we move through the winter and spring, additional enforcement actions will be taken as needed.

Today we have the highest number of forest operations on private land than at any time in the past. Earlier this year, we made several changes to our administration of the Act in the District, including Forest Practices Forester Sheridan's work area, in order to be more effective in our work, including increased access by landowners, operators and the public to our Forest Practices Foresters and to our clerical staff. We recently implemented some additional measures to help us stay ahead of potential problems that landowners or operators may cause as they conduct their operations.

I review all of our law enforcement actions on the District, and approve actions on significant cases such as this. My review always includes proper application of the law, impact to protected resources, appropriate issuance of citations and corrective repair orders, and involvement of all parties, including the work of our own staff. In the case of the Bussmann

situation, I don't find cause for disciplinary action for any member of our staff. Within the District, the Forest Practices Program Manager Ron Fox, his staff and I use every law enforcement action as an occasion to review our processes and procedures, and as necessary, make revisions and changes. As we continue the law enforcement actions with the Bussmann case over the winter and into the spring, we will follow the same procedure.

I would welcome the opportunity to talk with you further if you have additional comments or questions regarding this case or the Forest Practices Act in general. If you would like to talk by phone, please feel free to call my office and ask for me. If I am not available, please leave your phone number and I will call you as soon as possible.

**Editor's note: watershed update as of Wednesday morning, December 29, 1993**

We were informed by a private citizen yesterday that logging had begun on the Bussman property on December 23. Calls were then placed to city manager Dean Madison and the Oregon Department of Forestry. We were informed by Dale Sheridan of Forestry that what had begun was "falling" not logging. Trees had been felled (cut down and left where they landed) but not logged (yarded or moved onto trucks and off the property). However on Monday, December 27, the falling was halted. Bussman has submitted a plan to the Department of Forestry to log the property. The plan was prepared by Stuntzner Engineering of Coos Bay and submitted on December 28 to Forestry. There is a fourteen day waiting and comment period which ends on January 10. Forestry has 3 days after that to approve, reject, or modify the plans. If Forestry doesn't act on the plan within 5 days then it is approved by default. The City of Port Orford was sent a copy of the forest plan to review and make comments on. In the December 2 issue of this paper we reported that Ron Fox from the

Department of Forestry stated he believed logging on the Bussmann property would take place next summer.



printed circuit card is cut to size. Higher quality cards have beveled edges where the raw cut edge has been machined to leave less roughness. The less expensive cut edge cards work fine, but frequent or careless insertion and removal is more likely to damage the motherboard's VL Bus connector resulting in an unusable VL Bus slot. The moral of the story: Be extra careful whenever inserting or removing VL Bus cards!

### Letter to the Editor

#### Poor Management-Poor Response

I agree with Leonard Foster's statement in the December 22 issue of our local newspaper regarding the Sheriff Department's poor response time. He refers to a 90 minute wait for a Deputy. Sheriff Denney states in the article that he hadn't heard of that. Denney also noted that there are two deputies and one detective who reside in the Port Orford community. This would lead us all to believe that we have adequate north coverage. The true facts are that even though three deputies live north, the detective is assigned strictly to the Gold Beach office and works only assigned cases. The other two deputies work 40 hours per week each, and can be assigned anywhere in the county. This includes being assigned to Gold Beach because no other road deputies are working that shift. I have seen cases where a deputy has been called to the Gold Beach office to

take a complaint when there is a Sheriff, two Lieutenants, a sergeant and several detectives in the office that could easily have taken that report. I agree with Mr. Foster's reference to the "Forgotten North". Is there also a forgotten East and South as well? Under our current administration we have inadequate coverage because of poor management, in regard to how assignments are made. I can recall a deputy requesting assistance in the Port Orford area. A sergeant responded from his home in Gold Beach to assist that deputy. Neither of the two north deputies nor the north detective were called out, even though I only live within walking distance from the scene. Another night I got a call from a sergeant asking me to go check on a deputy who was out with a drunk driver and hadn't answered the radio for 45 minutes. The deputy was in Langlois and even though I could respond from Port Orford no other officers had been sent to assist by this time. This is an important issue because

our primary responsibility is to safeguard lives and property. This includes both citizens and our law enforcement officers. These are just two examples..

We have 11 deputies that work patrol. These deputies have the responsibility to respond to calls, and take citizen complaints. We also have a Sheriff, two Lieutenants, two sergeants and three detectives who also should be involved in our basic law enforcement responsibilities.

When I am elected Sheriff, I will make all personnel accountable. I will include the Sheriff and all other supervisors into the work force. I don't feel we need one supervisor for each 2.8 deputies. By adding those supervisors and the detectives to our work force, I can increase manpower by eight people. I can change our current administration policies to allow more flexibility for utilizing our





## Think Twice

Thinking about speeding through Port Orford in excess of the posted speed limit?

If you do it after December 31, 1993, and you are convicted, it can cost you up to \$521!

Why? Because the Oregon Legislature almost doubled the fines and costs on traffic convictions during the 1993 legislative session.

Conviction for failure to use your seat belt, failure to renew your vehicle registration or failure to change your name or address on your driver's license can cost you up to \$135 under the new schedule.

What if you are a commercial truck driver and are convicted of exceeding the speed limit in Langlois by 10 mph or more or are convicted of driving your truck 65

mph or more on Highway 101 outside of town? On top of a fine and costs that can reach \$521 for such a conviction you'll also receive a \$40 Commercial Vehicle Violation Special Unitary Assessment.

Driving while suspended cited as an infraction can now cost up to \$1,029 where under the old law the maximum was \$556. Driving without insurance can now be \$521 while under the old law it was \$282.


August at Cape Blanco State Airport.

I bought a soda at a local store and decided to lighten my purse by spending some pennies. I used 13 and still had a few left. That's a lot of pennies to carry around! Jokingly, I told the clerk, "I wish I had a hundred million of them - then I'd be a millionaire."
