One of the many Jubilee events is the Quilt, Flower and Bonsai show at Driftwood Elementary School. The exhibits open to the public at 9:00am. I've been told the quilt show is also a contest with about 20 quilters starting with the same material and all coming up with something different. The public is invited to vote for their favorite entry in the quilt show. The show is conveniently located in the same building as the ever-popular Rotary pancake breakfast. The Rotary Club serves several hundred people breakfast with all the profits going to the Rotary Scholarship Fund for Pacific High School graduates. You can have a hearty breakfast and then enjoy the exhibits.

sponsored by the Port Orford Fishermen and Wives Association at 3:00pm. The barbecue will be held at Driftwood Elementary School.

One last minute change in the Jubilee schedule is that the Fishing Pond at Battle Rock Park has been cancelled. This was a popular event for children under 12 years old last year but was cancelled because of a lack of support including a problem with getting enough ice.

They say everybody loves a parade and I know I thoroughly enjoy Port Orford's every year. The Grand Marshal of this year's parade is Charles Ells. Other highlights to look for this year include an entry organized by Julie Hawthorne representing women in history. There will be many motorcycles in the parade, including one group of riders from Redding, California and another from Coos Bay. Another group to look for is the colorful Bicycle Ballet.

Big Air Windsurfing in Langlois will be represented in the parade with two wind surfers. Port Orford and Langlois' young people will be represented by the Junior Court. Parade entries will be accepted through Friday, July 2. You must enter if you want to be judged for a prize.

More exciting news: Port Orford and more specifically Battle Rock Park will

see a flyover from the Oregon National Air Guard the night of July 4 at around 9:20pm. This according to Clayton Lyons who arranged it. Then the darkness will settle in and the fireworks will begin!

### Council Goes Ahead By Evan Kramer

The Port Orford City Council took a major step Thursday night toward replacing the Agate Beach sewer drain field. City Administrator Johnny Alexander led off with an overview of the situation. He said KCM Engineering estimated the replacement cost for an ocean outfall is \$1,840,000. The granting agencies would come up with \$1,250,000 in grants with city coming up with \$150,000 from the sewer and water construction fund and \$440,000 to be repaid by either ratepayers or taxpayers. Alexander presented a chart with a 20 year repayment cycle with a \$36,819 annual payment if the City goes with user fees to repay the debt. In his letter to the council Alexander stated that for the city to qualify for the grant money the city sewer rates have to equal the statewide average of \$30 per month. The current average in Port Orford is \$27.87 per month. Alexander's figures showed an increase of \$12.00 per billing cycle would

**Natural Gas**

HB2153, which included the Natural Gas Pipeline to Coos Bay passed out of the full Ways and Means Committee this morning. The bill will now go to the House floor and then to the Senate.  
 "I am very encouraged by the unanimous committee vote," said Rep. Ken Messerle (R-Coos Bay.) Messerle also stated for the record at the hearing, that the state \$20 million bond leverage is contingent on Coos County approving a \$20 million bond measure and Northwest Natural Gas building a \$10+ million grid to provide service within the community. This will provide over \$50 million for the project. Attending the committee meeting from Coos County this morning were Commissioner Nikki Whitty, Lawton Verger, Doug Fletcher, Tim Bishop, Harry Davis and Roy Perry.

**Wiggins Responds**



## Dock Project Goes to Bid By Evan Kramer

The Port of Port Orford Commission met last Tuesday night and at the top of the agenda was the permanent dock project.

Port Manager Gayle Paige said the last permit for the new dock had been received and that 50 bid packets have been printed. She said the advertisements for the new dock would be printed in the newspapers that week. The two most important dates in the bid process are July 8 when there will be a pre-bid conference at the Premium Pacific Seafood office for interested bidders and sub-contractors. The bids will be received at the Port of Port Orford office until 4:00pm, July 22, 1999 and at that time publicly opened and read aloud.

Paige said until a contractor is selected it won't be known if the Port will use a trestle system to put boats in and out of

the water. She said she expects major grumbling but the Port will stay operational during construction.

Mike Ashdown said he was concerned about the effect on the crab season. Scott Mecum said he was concerned that the opening month of crab season would be the worst time for construction. Ashdown told the Commission he was concerned with safety on the dock with an influx of additional boats and the time it would take to get them out of the water. Paige reiterated the Port cannot afford to shut down. Ashdown asked for a safety net for fishing boats that use the Port year round. He said he didn't want to see anybody drown. Paige told him the Port has no control of who goes out in the water. Port Commissioner Leesa Cobb asked if the Port could limit use of the facility. Commissioner Scott Macdonald described the trestle system as a really poor set-up. Paige said she has plotted usage of the Port from year to year and

said there was no good window of slow usage at the Port. She said the Port needs to proceed legally. Macdonald suggested the fishermen work out a rotation amongst themselves for dock lift use.


Port Commissioner Chris Hawthorne made a motion to allow fishing vessels to be removed from Port property during construction and retain their seniority. It passed 4-0.

The Commission next heard about the dredging situation from Gayle Paige. She said three or four Army Corps of Engineers employees would be in Port Orford at her office on June 29 to discuss the situation. She had stated earlier in the meeting the Corps was not through dredging and would be back and here through September.

The Commission considered the Port lease with the Division of State Lands for \$647 a year. Leesa Cobb made a motion to approve the lease and it passed 4-0. A second motion to transfer \$1950 from the insurance deductible to pay the land lease passed.

Paige talked a lot about the amount of public contact she has at the Port office. She told the Commission she needs more undisturbed time at the office to do her work. Several ideas were exchanged including getting caller I.D. to screen nuisance calls, looking into an answering service, turning the workshop area into an office and hiring a temporary office worker to help answer the telephones.





### Fire Season Begins

Effective at 12:01am, Wednesday, June 30, 1999, the official forest fire season begins in the Coos Forest Protective Association district. This closure effects all state, county, private and BLM lands within CS-1, CS-2, CS-4, CS-5, SK-1 and SK-2. This action puts the Coos district at a Level 1 closure. After this date, logging operators must have their fire tools and equipment as required by law and all open burning will require a permit.

Burning permits will be issued at the site. Plan any burning in advance to allow ample time for an inspection by the Forest

Officer. Call the nearest Coos Forest Patrol office listed in the telephone directory to request permits. Permits for open burning are issued for no more than ten days and incinerator permits may be issued for extended periods of time. All permits must be signed by the permittee and Forest Officer at the burning site.

The Coos Forest officer for Port Orford and Langlois is Joanne Ruoff. She can be reached at 332-1625 by people needing new permits or old ones renewed.





### **Commission Delays Decision By Evan Kramer**

The Oregon Parks and Recreation Commission met at Honeyman State Park on Friday and considered the Curry County State Parks Master Plan among other issues.

Several people from Curry County attended because of this and interest in the Canopy Project. John Black, vice-chairman of the commission turned the meeting over to Kathy Schutt to give an overview of the Curry County Master Plan. She reviewed the four major development sites including Cape Blanco State Park which she described as a place that could offer typical state park and growth opportunities. She moved on to Crissey Field, located off Highway 101 at the Oregon-California border. She talked about the opportunity for beach access and the potential development of a 4,000 square foot welcome center in what she described as a "potential flood area." The other two major potential development sites she talked about were Otter Point and Samuel H. Boardman. These two state parks are both listed as potential sites for the Canopy Project Discovery Center.

The Commission then heard from members of the public speaking on the Curry County plan. Keith Pepper, a Brookings City Councilor and Canopy Project vice-president of the Canopy Board said the Canopy Project had been evolving for 4 years. He described it as eco-tourism in a sustainable manner. He talked about the Discovery Center in one of the coastal sites and the ability of visitors to purchase the forest experience of their choice. He said the Canopy Board wanted to make it well known that they appreciate State Parks for working with them. Commission member June Spence asked Pepper if the board had looked at private land for their project. Pepper said they had looked at two privately owned pieces of land but both have already been purchased. Pepper said the Canopy Board had always anticipated the County would step back from the project and that they were looking for another agency to partner with.

Henry Lustig, one of the chief petitioners for citizens in Curry County to vote on the Canopy Project told the Commission the Curry County commissioners realized a majority of people didn't want the Canopy Project. Lustig described the Canopy Project as a giant Disney-like amusement

park. He said he found it incomprehensible that the State Parks would continue with it knowing the citizens are against it. Lustig told the Commission "You don't own the parks, citizens own the parks." He finished by asking the Parks Commission to take the Canopy Project out of the Master Plan.

Jane Cramer spoke next as a private citizen and not as city councilor. She said she and her family had been camping in Curry County for 22 years and that she and her husband had spent countless hours in the state parks volunteering. She said she was against giving property that belongs to the State to a for-profit group. She told them State Parks should not go into competition with private enterprise, mentioning the four RV parks in Port Orford. She said the Parks should concentrate on maintenance. She said the siting of Crissey Field Welcome Center adjacent to the Winchuck River disregards common sense and the area was at the risk of nature. She said a lot of good work had gone into the Master Plan.

George Ciapusci spoke next. He is a member of the Canopy Board and a Brookings City Councilor speaking on behalf of the council. He said Brookings supports the Canopy Project and asked the commission to please leave it in the Master Plan. He said the Brookings City Council supported moving the Welcome Center to Crissey Field.

Brookings/Harbor Chamber of Commerce president Les Cohen said he represents 340 plus members. He said the Brookings Chamber of Commerce board of directors support the Parks Master Plan as presented including the concept of the Canopy Project and moving the Visitor Center to Crissey Field.

Kalmiopsis Audubon Society president Nathaniel Wander spoke next and was representing himself and not the city council. He spoke in favor of expanding camping opportunities. He said

Kalmiopsis Audubon was willing to support limited expansion of Crissey Field confined to the southern portion of the park but they had taken a hard line against the Canopy Project. He referred to the Project as bad public policy and called it cheap carnival thrills. He called the Portico/Runyon Feasibility Study of the Canopy pure blue sky and said losses could be up to \$1.5 million dollars a year.

Mr. and Mrs. Fokal spoke about Crissey Field. They live across the street from it and spoke in favor of a development there especially bathrooms and asked the commission that better facilities be provided for the tourists.

Parks and Recreation Department Director Robert Meinen summarized the options for the Curry County Master Plan including delaying the decision until November. He talked about bringing an amended plan back in November. He said he wants the adoption process done by next summer so they can fix or replace the road to Hughes House. Commission member John Blackwell asked to what extent of financial studies of the feasibility of the Canopy Project. Keith Pepper said they were waiting for the final market study. Robert Meinen said they can't let the Canopy Project dominate the State Parks Master Plan. Commission member Sara Vickorn asked if we could scale something smaller with the Canopy. She noted the polarizing comments that had been received about the Canopy and suggested a less ambitious project.

The Parks Commission passed a motion following Robert Meinen's recommendation of alternative 5 in his letter. It reads as follows: Delay the Oregon Parks and Recreation Commission recommendation on the master plan until the County decides whether or not to proceed with the Canopy Walk. They will reconsider the Master Plan at their November 1999 meeting.

pay off the loan in 20 years and make the average monthly sewer bill \$33.87.

Alexander said the Department of Environmental Quality (DEQ) may fine the city \$250.00 a day for non-compliance. If the City doesn't take action, the DEQ will step in and bill the city for the construction costs.

Councilor Norm Leeling asked about paying for the new ocean outfall with a serial levy. Alexander said it could be paid for with either a serial levy (which would take an election and approval of the voters) or user fees and hercommended the latter.

Councilor Nathaniel Wander suggested the council consider using part of the bed tax money to pay for the drain field replacement. Chamber of Commerce president Jay Stoler spoke to the council and told them the chamber board has voted to ask the city for an increase from 30% to 50% of the bed tax money.

Councilor Ralph Donaldson said Alexander needs to go ahead with getting the geotechnical report done at Agate

Beach and that authority to proceed with the project should be given tonight. He made a motion that City Administrator Johnny Alexander proceed with the items necessary to replace the drain field and apply for a loan with Oregon Economic Development Department for \$440,000 to be paid back with city receipts. The council voted 6-0 in favor of the motion and then adjourned.
