Council Adopts Rules

All councilors were present Monday night at the monthly council meeting.

Public Works Director Jerry McNurlin said he didn't find anything at the

Sorenson logging site that caused the recent high turbidity. City employees inspect the 140-acre property regularly.

City Administrator Johnny Alexander said the city is still working on the cost of replacing the county equipment the police department used for the LEDS and AIRS program. The department needs a new computer.

Parks Commission chairman Rick Cook displayed copies of the mockups for the two interpretive panels from Sea Reach. They will be displayed at the Wayfinder site. He said the parks commission wanted a few changes. Councilor Jane Cramer made a motion to accept the changes and ask Sea Reach to preserve as much of the original picture of Tecumtum or "Chief John" as possible. The council agreed 6-0. Cook said the parks commission had discussed a change in the bed tax ordinance. They talked about 20% of the bed tax funds going to parks maintenance off the top.

Al Geiser updated the council on the two entrance signs to the city. He said the walls and letters have been installed. He said the artwork wouldn't be installed until mid-September.

Jack Pruitt asked when the flashing lights in front of Driftwood Elementary School would be reinstalled. McNurlin told him before school starts.

County Commissioner Lloyd Olds attended the meeting and introduced new animal control officer Charles "Trig" Garayalde. Olds brought a copy of the county animal control ordinance and license fees, etc. with him. Olds said 33 dogs had been adopted in July with 6 adopted at the Curry County Fair. Olds said when it comes to dogs he's a softy. He said the county goal is not to euthanize another animal. He said they needed a holding pen in Port Orford where dogs could be held until Garayalde could take them and that they had a donation to pay for the holding pen. Olds emphasized the county would be picking up loose dogs and writing citations in Port Orford. He said there is currently a 30-day amnesty for dogs without licenses. Dog licenses can be purchased from Doreen at Port Orford City Hall. Garayalde and Chief Bill Rush will get together and discuss the situation and report back to the council.

The council moved on to the revised council rules and councilor Ralph Donaldson made a motion to accept the rules as submitted. Councilor Nathaniel Wander asked the council not to adopt rule 2.5 (Speaking by council members - time limits on speaking). Wander said Roberts Rules of Orders did not show limits for time to speak. He said the council had another mechanism to end debate. Councilor Robert Warring said he was willing to go along with time limits and wants structure in the meetings. The motion to adopt the council rules passed 4-2 with Cramer and Wander voting no.

President of the Port Orford Chamber of Commerce Jay Stoler presented the council with a request by the Chamber for an increase in their share of the bed tax funds to 50%. They need more money because of the large increase in requests for information and a need for additional paid staff. Stoler requested the council hold a special meeting in mid-September dealing with bed tax allotments. Councilor Warring said he wanted a committee to do the rough work of coming up with an agreement first. Councilor Donaldson made a motion authorizing the city to set up a committee to analyze the Chamber's request for additional funding. It passed

Services for Bill McMullen

Funeral services will be held for William S. "Bill" McMullen on Saturday, August 14, 2:00pm, at the Port Orford Christian Center with Pastor Doug Jamieson officiating. McMullen died on Sunday after a lengthy bout with cancer.

I first met Bill through our common interest in the Port Orford Fire Department and Port Orford Rural Fire District Board of Directors. I served for a time with McMullen on the Fire Department. He made a substantial contribution to the fire department. His lifetime vocation was truck driving (he worked for Safeway) and on the fire department he drove a fire tanker. He was adamant about and a stickler for maintaining the fire department vehicles and equipment. He often helped Chief George Gehrke secure additional equipment for the department. He was appointed to the Rural Fire District Board of Directors and later elected to a four-

year term of office. He resigned earlier this year due to his illness.

Bill McMullen was a committed volunteer in Port Orford. He was an active member of the Port Orford Lion's Club and past president. He helped them with their fundraising efforts. He was also an active member of the Port Orford Lightin' Bugs and was an excellent cook. When the Bugs used to put on their annual Little Reno nights I remember McMullen cooking for them and how good his food was. He was a life member of the Port Orford Masonic Lodge.

Bill and his wife Clara owned the Coastal Garden Nursery where I bought many plants. When they took the nursery under their ownership they put a tremendous amount of work and money into revitalizing it.

Bill liked animals and he and Clara have a dachshund named Scooter that was always with them at the nursery and

everywhere else they went. At an earlier time in his life Bill had a pet monkey. Even though he didn't have one while he lived in Port Orford he rented every video we got at the Fun Zone that had monkeys or apes in it.

Bill McMullen was really a great guy and the community will miss him.

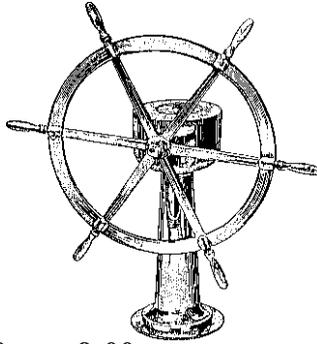
Dedication

Coffee & Cake Graeme Graydon



If you have ever been to Machu Pichu in Peru, you will know that this ancient Inca city is cradled on a mountaintop which is in turn surrounded by higher peaks. When I

was there, a small hotel just outside the city was the only accommodation available without descending thousands of feet on a wild, switch-back road to the village of Agua Caliente on the Urubamba River, far below. There had been no time to make bookings so only a few of my party found rooms at the hotel. Most of my friends went back & forth -well, up and down really, on buses to the village where they soaked in hot springs with the local people for half the night, I decided that having got myself up there and into the very heady energies, I wasn't willing to leave. Camping at Machu Pichu was completely forbidden, and anyhow there wasn't a flat spot to be seen. Finally an Inca Guard offered his front lawn for a campsite.

After the last bus headed down, my wife, Elza and I walked half a mile down the road to his house. The roof and walls were unpainted corrugated iron, I can't remember seeing any window. It clung optimistically on the steep mountainside. The front lawn was a flat area between the house and the road--maybe twelve feet wide, but no one used the road after dark. So it was with some thankfulness that we pitched our tent, ate cold rations and prepared for sleep.

A woman came to the tent and with much gesturing and pointing, invited us in for coffee and cake. There was no sign of our English-speaking Inca but we followed her behind the house to a door. She waved us in. Two steps and I couldn't see a thing, it was so dark. I became aware of candle glow in an adjoining room. Taking Elza in tow, I moved gingerly towards it. One candle lit the whole place. Hands and smiling faces came out of the shadows to guide us to two stools, obviously the seats of honour because everyone else was either standing or on the floor.

The room was full of people and pretty soon there was a lively exchange of name sharing and questions; the names were no

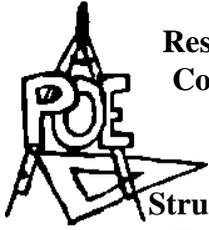

problem but everything else was untranslatable. How do you explain that you're from New Zealand and your wife is from Salzburg when your audience doesn't know where they are on our map, - but a roly-poly baby placed in Elza's arms didn't need explaining. We heard "coffee and cake" again. Now Elza was a coffee addict and was about to burst. I could see the blue flame of a gas ring and sure enough, with much Ooing and Ahing and the holy words "coffee and cake", a round disk about 1 1/2 inches thick of a sort of hard corn bread cut into wedges was thrust proudly towards us and mugs of coffee were placed in our hands. The "coffee" was sweetened, condensed milk in hot water. There was laughter and a lot of happy comments -none of which I understood. I managed to handle the brick-hard cake by dipping it in my "coffee". After we presented our last, big block of chocolate to them, there was only one thing to do - bed time for everyone, especially for us, we weren't used to the altitude. It's funny how I remember things. Lying in my sleeping bag, feeling all special from the reception of strangers, mixed up with being ticked off not only by missing out on the coffee and cake but also our last cake of chocolate. - Oh well.

A better description of the events leading up to Jim Harrison's participation in the Pacific International Grand trap meet a few weeks ago near Olympia, WA was promised. No one from our trap club in recent years has represented Port Orford as well.

On Tuesday, Jim shot a Singles 99/100, a 93/100 Handicap and an 89 Doubles. On Wednesday he again scored a 99/100 Singles; a 94/100 Handicap. Thursday, he shot a perfect 100/100 Singles and a 90/100 Handicap. Friday, Jim again scored a perfect 100/100 Singles that qualified him for a shoot-off on Saturday. His Handicap score was a 95/100.

The shoot-off on Saturday placed Jim against two professional trap shooters, Gerald Smallwood and Tim Sukers. Harrison scored 230 straight targets, dropped his 231st and scored perfect out to 250. Unfortunately, Smallwood ran all 250. Sukers was eliminated early. The reality is that Jim Harrison shot a straight 430 targets without a miss, and was runner-up to the best trap shooter in the Pacific Northwest. He has a \$700 gold and silver buckle to show for his effort.



Johnny Alexander Resigns By Evan Kramer

Port Orford City Administrator Johnny Alexander has resigned from his job with the city effective August 27 or sooner. He began working for the city on August 31, 1998. He told me the reason he has resigned is his wife Myrna has gotten a job in Salem.

My take on the year Alexander has been city administrator is that he has done an excellent job. He is the fourth person to hold the title of city manager or administrator or administrative assistant since I began covering the city for this paper. He's at the top of the class. Alexander has had good relations with the press, which in this case is mainly Port Orford Press editor Jay Stoler and myself. The World and the television stations don't show up unless they smell blood.

I frequently have questions for Alexander. When he's in the office which is most of the time I'm always welcomed in and he has an answer for any question. He doesn't give the best quotes because he sticks to the facts and doesn't engage in name calling or exaggeration. He produced a City of Port Orford tentative meeting schedule for 1999 that helped me in publicizing local meetings. His monthly administrative reports have set a standard for future administrators.

Alexander accepted the job as city administrator with the city facing several crises including their sewer and water systems. He has worked long hours to resolve them but hasn't been here long enough to see the solutions implemented. He tirelessly attended every meeting dealing with city from council meetings to parks, watershed, planning, budget and tri-city meetings. The city got a lot more than forty hours a week out of him.

I appreciate that Alexander understands he works for the council rather than the council working for him. The council now has an important job ahead of them in choosing a replacement for Alexander. Thank you Johnny Alexander for the job you've done.



Fair Success

The 1999 Curry County Fair & Rodeo were a success. Fair admission was up, the Rodeo on Saturday had the highest attendance ever, Carnival receipts were the highest ever, and the exhibits and exhibitors count was up from the previous year. Food booths were higher than ever before. The revenue from other commercial booths more than tripled that of 1998. Total Fair revenue is higher than it has been for the past four years.

Receipts from the annual Fair provide approximately 50% of the annual budget of the fairground. Other receipts are from year round facility rentals, banquets with catering provided by fairgrounds staff, state funding, and recently from grant funding for major repair and maintenance. Attendance is used by fair management in determining structuring of future fairs and is reported to the Oregon Fairs Association as an indication of the size and success.

Protest Against Fees

On Saturday, August 14, members of Oregon Shores Conservation Coalition and its CoastWatch program will be joining thousands of other people around the country in demonstrating against the federal Recreation Fee Demonstration Program as part of a National Day of Protest.

Simultaneous protests are planned from 10:00am to noon at three coastal sites: Yaquina Head (North of Newport), Cape Perpetua (south of Yachats), and Oregon Dunes Overlook (between Reedsport and Florence).

Opposition to what was to be a three-year demonstration project has been growing around the country, despite reports from the Forest Service and Bureau of Land Management that "consumers don't mind" the fees. Congressional representatives Lois Capps (D-Calif.), Mary Bono (R-Calif.) and Peter DeFazio (D-Ore.) have all introduced legislation to end this program. The California Legislature called for an end to Fee-Demo, as have many local governments.

Oregon Shores Conservation Coalition opposes "pay to play recreation for the following reasons.

Fees keep poorer Americans from enjoying hiking trails, beaches, and other public lands.

The act of paying fundamentally alters the way we relate to the outdoors, turning our love of the earth into a commodity.

Commercialism is a virtually inescapable part of American life-except on undeveloped public lands. We don't want to see our refuges turned into amusement parks.

6-0. Councilor Cramer then offered a motion designating a specific number of committee members (2 motel owners, 2 restaurant owners, 2 councilors and 2 from the general public) and advertise locally in the newspapers for members. It passed unanimously.

The council passed Resolution 9900-02 (Proposed Year 2000 Resolution). Johnny Alexander explained that the city's insurance company required the Resolution. They then passed Resolution 9900-03 (A resolution for special city allotment) dealing with state highway funds. The money

it referred to would pay for road improvements on Arizona Street between Madonna and 300 feet south of Geer Circle.

The council then considered water/waste water rate increases. Councilor Warring said the city needed to set up a committee to discuss rate increases and should advertise for an eight member committee consisting of 2 business owners, 2 renters, 2 homeowners and 2 council persons. Councilor Wander made a motion that the council appoint a committee to study and report back to the council. The task of the council will be to determine additional amounts of money if needed to pay for the cost of the wastewater outfall. It passed 5-1 with Councilor Campbell dissenting.

Mayor Gary Doran appointed Robert Warring and Norm Leeling to the bed tax committee and Nathaniel Wander and Ralph Donaldson to the sewer committee.

Councilor Campbell brought up the parking lot situation between city hall and McNair Hardware. Councilor Cramer suggested the city offer the owner of the property a \$1 a year lease with the city maintaining that part of the lot they use as well as the city having first right of refusal if the property comes up for sale.

Johnny Alexander reviewed his administrative report. Two points in it jumped out for water users. The salt content of Garrison Lake is still high with a salinity level varying between 1,580 ppm (parts per million) at the surface and 6,260 ppm at the water from the inlet. He said people wouldn't drink the water if the salinity level was above 250 ppm. Referring to the North Fork Hubbard Creek water source Alexander said he told Representative Ken Messerle the logging at the Sorenson site was going according to the rules but he believed during the first hard rain this fall the water source would turn to mud.

The city council will hold an executive session on Monday, August 16, 2:00pm, in the council chambers to discuss possible land acquisitions and pending litigation.
