Cranes are Working

The Port of Port Orford Commission held a special meeting on Friday at 4:30pm. Just before the meeting began Little Jo II, the Laskey Clifton crane and a familiar site

at the dock for over a year, was seen being towed out of town.

Present at the special meeting were commissioners Dave Knapp, Scott Macdonald, and Leesa Cobb as well as Port attorney Randall Tosh. Commissioners David Darnell and Chris Hawthorne were absent and so was Port manager Mike Nielson.

The first agenda items regarded Change Order #19. Laskey Clifton had requested two changes in the Warrant authorizing payment for fixing the two cranes. Tosh later on described the warrant as a method of securing payment for the Change Order. Laskey Clifton requested a raise in the annual interest rate on the \$165,616 warrant from 6% to 10% and that payment begins in 180 days, not as it was written "until such time as the Port of Port Orford has secured sufficient funding in the Port Dock construction fund to fully pay the amounts evidenced hereby."

Leesa Cobb asked about the funding status for this level of commitment (the warrant). Office manager Kathy Sherbourne told her that a "letter of intent was on its way" and Cobb responded that it should have been here already.

Dave Knapp made a motion to accept the changes in the warrant as stated. Attorney Tosh recommended the commissioners not execute any documents until they have a formal commitment. The commissioners then voted with Knapp and Macdonald voting yes and Cobb no. The motion was defeated due to a lack of majority (it needed three yes votes to pass on a five member board). Randall Tosh said the commission needs the change order and warrant simultaneously. He said that without the warrant the Port would have an open account (with Laskey Clifton).

Scott Macdonald then said without the warrant the Port is shut down. Leesa Cobb responded that she couldn't let the Port be shut down. Dave Knapp then made a motion to reconsider the signing of the warrant as changed and the motion passed 3-0. Leesa Cobb said it was a horrible position for the commission to be in but she couldn't vote to shut down the Port. Dave Knapp then made a motion to accept Change Order #19 and the Warrant as changed and it passed 3-0.

Bill Oleson asked the commissioner about having meetings on Friday afternoon. He said the meeting notice need to be in the papers.

The only other item on the agenda was one titled Personnel but before the commission could move forward into that one Bob Walters told them they had made a big mistake. Walters said his boat hadn't gone fishing that day because the cranes weren't working. Scott Macdonald told him the Port had a signed change order and warrant and had working cranes.

Walters asked if the taxpayer was on the line as a result of the warrant. Attorney Tosh said no, the warrant didn't obligate the taxpayers. He said the warrant was not secured by the taxpayers. Tosh said the only way the taxes could go up is by a vote of the people but that he hadn't seen the loan document.

Tosh said the Port District may be looking at a municipal bankruptcy in 3-4 years. Scott Macdonald said if the commission had started litigation (concerning fixing the cranes) it would have taken 2 years to get them fixed.

Dave Knapp made a motion to accept the cranes and use them and it passed 3-0. Leesa Cobb asked if they had been tested

Letter to the Editor,

For those of our community who have an interest in the Port of Port Orford, I suggest the Dick Hill report March 2001, as a must read. The report provides professional overall evaluation but is meek in its evaluation of existing conditions. As one Commissioner states, "It appears that some irregularities have occurred." I'll list a few for your evaluation.

On Friday, March 30, 2001, conflict in staff direction lead to no boats being launched that day. Loss to an already struggling fishing industry for the day was estimated at between \$20,000 to \$30,000. Later that day in a special session Commissioners Knapp and Macdonald, in effect, coerced Commissioner Cobb into approving a warrant in the amount of \$243,170.12 at 10% interest against the District to cover Change Order #19 for hoist repairs (work already completed) and #20 for fuel system modifications. Change orders after the fact are

like writing a blank check to the contractor, in my opinion. These items should have come to bid 8 months earlier, been bonded and completion dates specified. If funds were not available the issue should have been addressed at the time. In my opinion, Commissioners Knapp and Commissioner Macdonald owe the public a disclosure of their financial gains in their private dealings with Laskey-Clifton and an explanation, if in fact, this relationship contributed to their eagerness to approve, without question, the proposals of Laskey Clifton.

Since there has been no demand made of the engineer or contractor to cover design and construction flaws on this project it would appear that the taxpayer and users of this port will, in the final analysis, pay these costs. Our port manager who is paid \$4200/month for half of his time has taken no action in these matters, is seldom seen at the port, and in my opinion, is of little if any value to the district. His contract has been terminated yet the port will

pay \$4200/month for an additional three months for services that again will be of little benefit to the district.

We are in desperate need of any input that will help.


Visitor Center News

Through the Eyes of the Reader by Graeme Graydon.



Quite recently, a writer visited my village, Port Orford. There's a funny thing about writers, give them a little personal involvement in something, and – POOF ,

they tend to see themselves as ideally qualified, unbiased and totally fair experts – to be the ears and eyes for everyone else. No one came to Port Orford because it was perfect, and it does have a few holes in its socks, which the widely published writer noticed. I love it in spite of the holes, maybe , even, because of them, and there's a temptation to defend the town by giving the whole story, but that's not necessary —.

Years ago, any request from a journalist to visit my health resort to do a story, was very important and very scary, because we had no control over the finished article. Once, a New York journal, with millions of subscribers, sent a writer for the cover story of their weekend magazine section. He came, and he went. A couple of weeks later, before we saw the

paper, our phones went crazy with people making reservations. Within hours, I had the paper in my hands. The Front Page of the magazine was a close-up, rear view of one of our very overweight guests, in brilliant tights, participating in an outdoor yoga class, standing on one leg in a classic yoga posture, behind her, a sweeping panorama of Autumn Maple Glory on Catskill Mountains. It was meant to be funny, a parody that some people would find funny. The story inside detailed the writers scorn at our programs, especially our use of enemas for detoxing. He made fun of our guests and described how he sneaked out for a good steak after starving all day. I didn't have time to get upset, women were making more reservations than we had ever had. They had all seen the front page, but they saw beauty and dignity and strength there, they had read the story and knew for certain that the writer was a jerk but that the program was just what they were looking for. It was the greatest publicity we ever had—it brought an enormous increase in business which never fell off. The women who came were exactly the kinds of guests that we wanted. They were a wonderful lot, many of whom became regular clients and well loved friends. I don't suppose the writer

ever knew what an idiot he had made of himself, never knew that he personified traits most despised by women.



Letter to the Editor,

Elk River Land Trust (ELRT) is now one year old. We're celebrating the completion of all the paperwork required to designate the land trust a tax-exempt, non-profit organization. I want to give a big thank you to the exceptional people whose donations of time and money made it possible for us to get up and running.

ELRT is a public benefit private land conservancy. That means we buy land or conservation easements that protect and promote scenic beauty, watershed health, open space, wildlife and stewardship forestry.

A conservation easement is ownership of a specific property right, but not the entire property. For example, ERLT might buy the rights to timber along a stream, so the trees will not be cut, however, the original owner still retains title to the land, controls access and so forth. Although ERLT's primary focus is Elk River watershed, we serve all of northern Curry County. We work only with willing sellers. Participation is 100% voluntary.

Donations of money, property or easements will usually be tax deductible, minimizing or eliminating income, capi-

tal gains or estate taxes. This may allow the family to keep property which might otherwise be sold to pay taxes. Donations large and small are helpful, as funders want to see matching contributions from our local community. Please join us.



Steelhead Listing

Curry County Commissioner Lucie La Bonte received word on March 29 that the National Marine Fisheries Service had handed the court a decision on the Steelhead in our Evolutionary Significant Unit late on March 29. The decision was in support of the NMFS Biological Review Team’s determination that a listing on Steelhead is unwarranted in this region. This was majority BRT decision. According to ODFW biologist Russ Stauff the BRT is a team of scientists that support the Endangered Species Act and are not political appointees but independent scientists. Stauff provided new scientific data along with Tom Satterthwaite, ODFWW Grants Pass, to the scientific panel.

Commissioner La Bonte says, “This is a positive decision for our region and for the Endangered Species Act. Listing of a health species would have destroyed credibility of the Endangered Species Act and would have further devastated our local economy. Three things factored into the decision.

1. Large number of wild steelhead overall.

2. Wild steelhead present in all habit within the ESU.
3. Very low hatchery stray rate.

We need to thank our biologists, Russ Stauff, Tom Satterthwaite, Bob Hooten and Jay Nicholas for their data collection and hard work.”

Lions Screening Van

Volunteers from Curry General Hospital Auxiliary, Gold Beach Lioness Club and the American Red Cross checked 94 people for health problems, March 23, when the Oregon Lions Sight & Hearing Screening Van came to Gold Beach. The self-sufficient mobile health office set up shop for eight hours in McKay’s Market parking lot. During that time, Warren Heathman, chair of the Oregon Lions Mobile Screening Unit and van driver, recorded 65 people screened for blood pressure, with 26 problems uncovered. At least two individuals were sent immediately to Curry General Hospital for follow-up. Heathman also reported 47 people checked for visual acuity, with eight problems; and 40 checked for glaucoma, with four problems. Out of 43 checked for diabetes, screeners uncovered one problem. Of 73 tested for hear-

Volunteer “muscles” from the Gold Beach Lions Club helped set up and break down the mobile unit. @Harborside Update by Valerie Jean Kramer

Harborside is in the process of changing their connection to the Internet in order to provide faster, more reliable service - a goal I'm sure we all support! Because of this change, their IP addresses will be changing and you may have to change some settings in your computer in order to access the Internet.

The IP addresses can be stored in your computer in two places - either under the Control Panel, Networking, TCP/IP Protocol Properties or under My Computer, Dial-Up Networking (DUN), and buried in the properties of your DUN icon. If you don't know how to find these places or how to make changes, perhaps you should get someone to help you the first time you do this.

The change that should be made now is to the DNS (Domain Name Server) address. The DNS IP number is the physical address of a computer which acts like a phone book. When you type in an Internet

address like "www.google.com", your computer sends that string to the DNS computer and it returns the numeric IP address for Google. Your computer can then send it's request to google and receive back the web site image.

This DNS address can be obtained automagically from the Internet Service Provider (ISP - in our case Harborside) by selecting "server assigned DNS address" or by specifying one or more DNS IP addresses manually. Letting the server assign a DNS address is simpler and more flexible as the server can switch DNS servers and you don't have to make any changes. On the other hand, An extra step is involved in that you first have to request the DNS IP, then ask the DNS server to convert your web address, and only then can you actually ask for the web page you wanted.

Another advantage of using manually entered DNS entries is that there are some web sites that are accessible only if you are set up to use an extended DNS server. Not all ISP's are provide the extended service. These extended DNS servers can translate some of the more unusual web addresses which end in something other than .com, .edu, .net, .mil, .gov, or .org.

You should check your settings asap to see if you need to make any changes. If you have DNS entries of 204.214.110.225, or 204.214.110.236, they will have to be deleted and replaced with the new DNS address of 12.45.56.2. You may continue

using 192.135.191.1 as an alternate.

and Scott Macdonald told her they were up to specifications.

Incoming Port commissioner Gifford Barnes told the commission that Hallmark Fisheries and PPS had both lost \$10,000 today because of the boats not being able to go out.

The commission then moved into an executive session under ORS 192.660(I)(a) Personnel.

Port situation as of Tuesday April 3: On a bright sunny afternoon down at the dock Port lead crane operator Dave Barnes said there were 17 commercial boats out and no sport boats out. He said that on Saturday March 31 the commercial crane had overheated and been temporarily shut down but despite this 27 boats were lifted into the water. Barnes said 8 or 9 went out Sunday and 17 on Monday. Barnes said a hydraulic specialist had been brought in on Sunday to fix the overheating problem.

The yellow crane offers greater visibility to the crane operators who don't need to use a spotter when lifting boats now.

Barnes said the speed of the new crane is now 40 feet a minute.

Officer manager Kathy Sherbourne said there was a verbal commitment from Oregon Economic Development Department for the money to pay for the dock repair work.
