Council Hires Two People By Evan Kramer

The Port Orford city council held a short meeting last

Wednesday night and flexed their newly acquired muscles in the employee hiring department. The meeting began at 6:30pm with the council discussing hiring a violations clerk for the municipal court. They chose Daniel Georgson and agreed to sign a six month contract with him. Georgson is being hired and salary paid for through South Coast Business Employment Opportunities.

The council then moved on to hiring a clerk for the police department. The acting police clerk, Maggie Cotherman was chosen. Her job description will come from the Port Orford Police Department Policies and Procedures Manual. The contract with Ms. Cotherman is through May 30, 1997. She is also being hired and paid for through South Coast Business Employment Opportunities in Brookings.

The council dealt with the supervisor of the police clerk. Police Lieutenant Lew Ball spoke to the council and told them Maggie has been doing an excellent job. He said the police clerk job should be kept under the police department supervision,

whether it be the police chief or acting police chief. Ball said he wanted to qualify Cotherman on the L.E.D.S. program (Law Enforcement Data System). City Manager Dotti Myers told the council that she has never interfered with Lew Ball. A motion was made for the police chief or de facto police chief to act as direct supervisor of the police clerk. It passed unanimously.

The last piece of business dealt with the background check on officer Ball. This is part of the minimum requirements for becoming a certified police officer in Oregon. The council unanimously agreed to hire the Coastwatch Legal Services and pay them not less than \$300 nor more than \$1,000 to conduct the background check.

Race Meeting Cancelled

The Port Orford Grand Prix auto race meeting scheduled for Friday, April 18, was cancelled that morning. A notice was posted on the door of the council chambers announcing that the meeting had been cancelled due to the weather which that day was cloudy. Betsy Johnson and Lindy Zimmerman from the State Division of Aeronautics had planned to fly to Cape Blanco Airport and attend the meeting and talk about the airport and the auto races. Members of Team Continental

from Portland arrived at Port Orford City Hall Friday morning to find out their six hour drive was not going to be a fruitful one. Many members of the public drifted in and out of the city hall lobby disappointed there would be no resolution of the race situation.

I spoke with Port of Port Orford manager Gayle Paige about when the meeting would be rescheduled.. She said no firm date has been set but we'll be notified when it is and make sure to publicize the meeting for the Port, the Chamber of Commerce and the public.

Residents of Port Orford and Langlo

In the April tenth edition of the Port Orford Today, a paid advertisement written and published as a news article containing several false statements made by Joanne Ruoff, should have been labeled fiction.

Joanne Ruoff made the following false statements:

- 1. "Port Orford and Langlois get short end of the stick."
- 2. "There is another choice. The A.S.A. Committee decision is only a recommendation, it is not written in stone and the County Commissioners don't have to follow it!"
- 3. "The A.S.A. Committee rejected their bid along with Port Orford Ambulance and Central Curry Ambulances bids. Instead of bidding each town separately, as the committee wanted, Bay Cities bid the entire county as a Paramedic level of care, this would include Port Orford and Langlois."
- 4. "Bay Cities Ambulance is the only bidder willing to provide us this service."
- 5. "Bay cities Ambulance has the staff and equipment to do the job, including a medical transport airplane."
- 6. "Why should we, the residents of North Curry County, be the only people living along the 350 miles of Oregon Coast without a Paramedic level of care?"

These statements are not only false, but were made by Joanne Ruoff, an employee of Bay Cities Ambulance. Tim Novotny, another employee of Bay Cities Ambulance has made false statements regarding intermediate EMT'S. He tried to insinuate that Oregon EMT intermediates were not recognized by the National Registry, when in fact, the requirements of an Oregon EMT intermediate are more stringent and the scope of practice is much broader than that of the National Registry. This is because of the rural make up of our state.

If anyone questions this, they can call the Oregon State Health Division or Pat Schreiber the South Western Oregon Community College instructor that teaches the course and also works for Southern Curry Ambulance.

In regards to Ruoff's six false statements, I'll save number one for last.

FALSE STATEMENT # 2

The A.S.A. Committee is made up of professionals in the emergency medical field, representatives from hospitals, fire departments, doctors, ambulance services, physician advisors, members of 911 committees, local government and the public. Their recommendations should not be taken lightly, especially when the vote for A.S.A. # 3 was unanimous, and A.S.A. # 2 was twelve to one in favor of Southern Curry Ambulance. A.S.A. #1 had only one approved bid.

The A.S.A. plan was written by Commissioner Skinner and was approved by the state, which established rules of procedure and what was acceptable to our community. These rules must be followed, or why have them?

I can honestly say the A.S.A. committee members cast there motions and voted with two considerations in mind:

 Will my vote (their choice after completely reviewing the bid) save more lives? 2. The economic staying power of the bidder. In other words, if there's no profit, will they stay, and if there is profit, will it go in someone's pocket or will it provide better equipment, training, and supplies?

This decision should not be a political one. It should not be made as a result of pressure because a person may have a financial gain through the sale of his property, (near Circle K) to Bay Cities Ambulance if awarded the bid. Nor should scare tactics or false rumors be used to mislead the public.

FALSE STATEMENT #3

The A.S.A. committee rejected Bay Cities for the following reasons:

- 1. Application was incomplete.
- 2. Section A Subcontract for providing services, was Blank.
- They didn't bid any of their ambulances and no commitment on how many in each area.
- 4. No copies of training records or certification.
- Financial records were from 1994 and 1995, almost two years old, but nothing current. They included assets that have nothing to do with the Ambulance Service.
- 6. Incomplete statement of experience, with statement of annual sales greater than their financial statement, and which included businesses other than the Ambulance Service.
- Section G. The Capability to Perform, was left blank, once again no commitment.

This is a paid response to the paid submission

is, you are being lied to and conned!

- Their ambulance membership does not cover stretcher car or air services.
- Section I: Run Logs, were incomplete, having only one days worth of runs and blank forms.
- 10. No policies or procedures manual.
- 11. No protocols.
- 12. No commitment of equipment.
- 13. No established locations in the county, as required.
- 14. No inventory lists or commitment.

If this effort, or lack there of, in bidding the A.S.A. is similar to what could be expected in their medical care, would you want them taking care of your family?

FALSE STATEMENT # 4

Southern Curry Ambulance's bid provided for utilization of Port Orford Ambulance Service by subcontract, if they chose to do so. Provide no-cost advanced training to the volunteers and provides advanced life support when ever necessary. It's a significant benefit the people (Paramedics) who live and work in Port Orford caring for their friends and neighbors.

Southern Curry Ambulance was the only sensible bid, in that it would provide full 24 hour, seven days a week, paramedic service when the number of runs reach forty or more per month. Until that time we will give back up Advanced Life Support service and training to a group of medics who have demonstrated their dedication and caring service to their community, Port Orford Ambulance Service.

FALSE STATEMENT # 5

Bay Cities Ambulance Service did not have the equipment or personnel to handle the three A.S.A.'s in their bid.

FALSE STATEMENT # 6

North Curry County is not the only area along the 350 miles of Oregon Coast without a paramedic level of care.

BACK TO FALSE STATEMENT #1

Are you getting the short end of the stick when you have a professional, nonprofit ambulance service that reinvests any gains into equipment and training for the areas it serves, versus a for-profit company that still uses mostly old, inexpensive, van-type ambulances and employ's people who make false statements. We are all entitled to our opinion. It's my hope that we render that opinion on sound information and aggressive research.

I have had a few phone calls lately from people that have concerns after talking with one county official or after reading one of the ads as mentioned here. I have found it interesting that a person being concerned about Southern Curry Ambulance's ability to financially provide advanced life support service in Gold Beach with 40 runs a month, would also ask in the same conversation, why we won't put a full time advanced life support crew in Port Orford with only 10 to 15 runs per month.

Statements have been made that volunteers will no longer be used in Curry County. **This is not true!** Not only will they be utilized in conjunction with full time, but we will assist them in their training, uniforms, and equipment.

It is my hope that the people of Curry County will support the A.S.A. Committee's recommendation that any residue of the old "North against the South" will be replaced with unity and caring. We all travel within this county, lets help and take care of each other. Southern Curry ambulance has taken the first steps. We are changing the name of the association to South Coast E.M.S. (Emergency Medical Services).

Second we have bid the A.S.A.'s for the purpose of saving more lives, certainly not for financial enrichment, which should be obvious.

Third, we have and intend to continue utilizing volunteers. In fact, most of our medics started out as volunteers.

Another rumor in the air is that Southern Curry will take patients to only one hospital. We will take patients to the closest hospital of their choice. This is a requirement of Oregon Law.

We were asked to bid the A.S.A.'s by residents in each area. We have done so in a professional, complete, well thought out manner. We have not, at anytime, used false information, scare tactics, or politics in any news articles, ads, or public meetings. We felt compelled to address these false statements so the good people of this county will not be mislead by a noisy, and possibly, unethical one percent.

Coast Watch

Someone will soon be watching over every foot of Oregon's coastline, if the Oregon Shores Conservation Coalition (OSCC) achieves its goal.

Coast Watch - Mile by Mile, an OSCC project, enlists volunteers to take responsibility for a mile of beach or headland. Mile adopters keep track of both natural changes and human impacts on their stretch of shore, while helping to educate others about coastal conservation.

"We're making our final push to get the entire coastline adopted," said Phillip Johnson, an OSCC board member who serves as Coast Watch coordinator. "We're hoping to get the final mile adopted by the end of the year, or soon after that."

Currently, 285 miles have adopters, Johnson explained. (Coast Watch "miles" actually average a bit more than that. The program has divided the coast into 311 segments, although there are officially 362 miles of the Oregon coastline.) "We have adopters for about five-sixths of the coast, so our goal is in reach."

Noting that next year will be the 30th anniversary of Oregon's Beach Bill, which

protects public access to the entire shoreline, Johnson said "Think what a powerful symbol that will be of the love Oregonians have for their coast - to be able to say that our people have taken personal responsibility for stewardship over our entire coastline!"

Johnson also emphasized that the program won't be closed once all the miles have adopters. "Any number of people can co-adopt a mile," he said. "We already have co-adopters for 107 of the miles. Some day we'd love to have a team of people watching out for every stretch of coast." Given that many adopters are couples or small groups, there are already well over 495 individuals participating in Coast Watch.

The areas where adopters are most needed in Curry County are, North of Nellies Cove, The Cape surrounding the headlands at Cape Blanco, South of the New River, and the mile adjacent to Arizona Beach private campground. However, there are places where volunteers can help in every county.

Coast Watch volunteers are asked to commit themselves to visiting their mile four times a year at a minimum. Periodically,

volunteers are asked to fill out data-gathering forms provided by the program. An instruction manual is being developed, giving tips on things to observe. At least two sets of training sessions are also offered each year, emphasizing different aspects of coastal stewardship.

Volunteers are not required to be OSCC members, although the information they gather is useful to OSCC in its advocacy work in defense of Oregon's coastal resources.

"Coast Watch makes us more effective in several ways," said OSCC President Fran Recht. "It gives us an early warning system if problems arise. It also means that there are people who feel a personal connection to the place they've come to know so well, and who may be ready to speak up in defense of that part of the coast. And in the long run, it means that there will be a large number of knowledgeable people who can pass on information about the coastal environment to friends and neighbors, and to the next generation."



Letter to the Editor,

I offer this information in reference to the acceleration of the demise of the 53+ year old asphalt/macadam runway, taxiways, and apron at the Cape Blanco State Airport in connection with the effort to reinitiate the sports car racing at that location.

Vocal and published references to "scraps of rubber", created by four days of racing activity are in reality primarily asphalt from the airport surfaces according to laboratory analysis and enlightened observation. The abrasion of the high speed racing rapidly accelerates the rate of decomposition of this fragile surface which has never been sealed since initial construction. By comparison consider setting up an equivalent race course and sports car rally on the streets of Any Town, USA. Old streets, 250 hi-powered sports cars, no speed limit, running in heats of 20-30 cars, 6 hours a day for 4 days; and ask the city if they would tolerate the wear and tear on their streets.

The racing area at the airport is clearly defined by the evidence of accelerated damage to the asphalt. Ballpark estimate by a qualified contractor to resurface the entire area is \$320,000. Do the people of Curry County and the State of Oregon want to contribute to the destruction of this \$10,000,000 asset by continuing the auto racing on this airport? It would be difficult to find any airport where auto racing contributed significantly to the success of the airport.

Wayfinding Point Plans

Oregon Department of Transportation (ODOT) ideas for the Wayfinding Point at Battle Rock Park, which will be constructed this summer, were revealed and discussed at the last Community Resource Team (CRT) meeting on Thursday, April 10. Joe Paiva, who is leading the Wayfinding Point projects for ODOT, presented an overall design for the Battle Rock Wayfinding Point layout. A sketch showing the general appearance is shown in the accompanying figure.

Paiva also presented several alternatives for the details of the layout. After discussing the alternatives, the CRT voted to proceed with a layout that designates some recreational vehicle (RV) spaces and facilitates more orderly parking and traffic flow for users of the park. Exiting from the park will be safer because vehicles will approach the turn onto the highway from a normal street intersection angle. The sharp angle many drivers now use puts vehicles at a blind angle for merging northbound or too sharp a turn for continuing south.

With regard to RV's, it was noted that in addition to the designated spaces, the area

on the highway side of the parking lot could still accommodate them. In general, travelers with long vehicles hesitate to pull into Battle Rock Park because they see that it will be difficult to turn around, and it was recommended that city planning include adding more easily accessible parking for RV's near but outside of Battle Rock Park.

The design includes garbage containers secured against the wind in the rock wall. The dumpster would be moved out of the scenic view area to the highway side of the Visitors' Center. The ship's propeller will be retained in a grassy area near the Visitors' Center, Pedestrian areas will be paved with interlocking brick with some planters, possibly a compass rose, and possibly a sculpture in the center of the main viewing plaza. Paiva said ODOT is thinking of a sculpture that reflects designs in the famous McCullough Bridges along 101 and could also function as a sundial. The viewing plaza will include most of the interpretive signs.

Now that the design stage is well underway, we are moving on to development of the information for the interpretive signs. These signs should guide visitors to the best and most interesting things our area

has to offer, and community input is needed. You are invited to participate in development of the interpretive material by coming to the Thursday, May 8, meeting of the CRT at 7pm at the Senior Center. Historical, recreational, cultural, and scenic information and travel routes will be included. The number of signs will be limited, so the community needs to work on selecting the most important features and rely on the Visitors' Center to provide the rest. A professional firm is under contract with ODOT to work with the community on this part of the project. and will lead the effort at the May 8 meeting.
