"Minor Alignments" in Hwy 101 By Evan Kramer



The Oregon Department of Transportation (ODOT) held a meeting in Port Orford on Wednesday concerning the upcoming construction on Highway 101 in Humbug

Canyon. ODOT area manager for south-western Oregon Mark Usselman spoke first and described his job as overseeing construction projects. He described the upcoming road widening work in the canyon as "minor alignments." He said impetus for the road widening began when ODOT motor carrier enforcement agents noticed large trucks crossing the yellow centerlines and fog lines. They felt this safety issue needed to be addressed.

ODOT project manager Ray Cranston explained the purpose of the Wednesday meeting. He said ODOT was in Port Orford to talk about the construction aspect of the project only. ODOT already has a contract with Home II for the construction, which will begin on September 8. The cost of the project is \$1.67 million. Three curves in the canyon will be widened on the creek side. Cranston said they would work in areas with an existing concrete slope with as he put it "minimal impact on Brush creek." Cranston said

that flooding on Brush Creek is controlled with a spillway. Cranston said the Oregon Department of Fish and Wildlife wanted the project completed between June through October.

Some of the consequences of this project include closure of the side of the highway nearest the mountain for a length of six tenths of a mile during construction resulting in only one lane being open. Construction is expected to be finished by the end of October. Cranston estimated the biggest delay in traffic being 10 minutes. No permits will be issued for loads over 12' wide until the project is completed. Cranston said a 60' long truck can drive through the canyon safely now but not a 74' long one. Nathaniel Wander asked how many 74' trucks using Highway 101 now. Usselman didn't have an answer for that question. He stated he wanted to "talk about construction only."

Al Geiser rose to speak. He had copies of the Scenic Byway Management Plan and the Pacific Coast Scenic Byway Corridor Plan. Geiser said the community was supposed to get input into the highway plan. Geiser firmly stated that ODOT had promised public input. Usselman said that ODOT's #1 concern is traffic safety and he wasn't going to go any further with the issue of public input. Monty

Montgomery said he was glad ODOT was doing something about the canyon stating he had pulled many wrecks out of the area. Nathaniel Wander said he wanted to see the canvon safer and asked that ODOT look at alternatives to the road widening. One idea was paving the hiking trail that parallels Brush Creek and uses it as a bicycle lane thus getting them off the highway. The shoulder could then be used for widening the highway. Justin Bauman asked that ODOT keep the traffic delays to a minimum. Basil Andrews asked where the funding was coming from for the project. Usselman said it is part of the state highway program and money wouldn't be taken away from other projects. Usselman described this project as a Category 2 meaning it didn't have to have public input.

Nathaniel Wander told Usselman that ODOT's message is "we don't count."

After the public input portion of the meeting was over people were allowed to question Usselman "offline" as he referred to it. He told one group that if the trucks continue to cross the centerline ODOT would take other safety measures after the project is completed. He also said State Representative Ken Messerle had pushed for this road widening.

City of Port Orford is soliciting bids for the construction of the Garrison Lake-12th Street Ramp Project. The Garrison Lake-12th Street Ramp Project will be located at Garrison Lake. Principal work elements include: removal of existing ramp, construction of a cast-in-place concrete ramp, precast concrete ramp, abutment and installation of wood boarding floats. This is a public works construction project.

Estimated project cost range is \$25,000 to \$50,000. Contract Performance period is 120 calendar days.



Arrogance of Power Editorial opinion by Evan Kramer

Oregon Department of Transportation officials subjected Port Orford residents to an arrogance of bureaucratic power last Wednesday night. ODOT's hastily called public meeting was lightly publicized with notices of it not getting into the town's two newspapers until the same day as the meeting. It only appeared in our paper because of a friendly e-mail message. Thanks to the efforts of Kalmiopsis Audubon Society president Nathaniel Wander posters were printed and displayed around town notifying people about ODOT's "secret" meeting.

ODOT managers presented a fait acomplials oknown as "a done deal" to the residents of Port Orford. Many of us have been aware of the Humbug Canyon Highway 101 road widening project and had wanted a public meeting to find out more about. We got one on Wednesday night. We were told that construction would begin on Tuesday, September 8. We were told the purpose of the meeting was to discuss construction issues with ODOT, not whether or not the project was necessary or had merit. We were allowed to ask questions like what the walls of the wid-

ened part of the road would be made of it and what kind of fill they would use.

ODOT south western area manager Mark Usselman treated the citizenry like peasants in a medieval society. He tried to tell us what we could talk about and when that ploy didn't work he terminated the public input portion of the meeting. He gave us permission to speak with him "offline" about issues including lack of public input. By "offline" he meant privately so the group as a whole couldn't hear what was being said.

How arrogant is ODOT? They didn't even bother to contact Port Orford city councilor Robert Warring about this meeting. Mr. Warring is the city councilor responsible for the city's contacts with ODOT. I spoke with him two days after the meeting and was told he wasn't notified of it. Warring told me he has had many contacts with Usselman and could have contributed to the meeting.

ODOT violated their own stated purposed in the "Scenic Byway Management Plan for South Coos and Siskiyou Regions of the U.S. 101 Corridor in Oregon." Listed under Strategies for Humbug Mountain State Park is "involve local

There was a doctor who, near the end of a successful career, became totally dissatisfied with the medicines that he could legally use on his patients. His

concern was not only the effectiveness of the drugs but the new and disturbing sideeffects. It mattered to him that his patients were developing distressing symptoms unrelated to their original complaint. Worse still, the cost in terms of suffering was rarely balanced by acceptable improvement.

He considered the alternative therapies – all of them new to him. They promised safe treatments with results at least equal to conventional methods. This excited him but he was saddened to realize that he didn't have the energy or the years to learn the new ways. He would have to replace a lot of what he had been taught with perhaps the strange principles of Homeopathy, the complexity of herbal medicine, perhaps acupuncture with its foreign philosophy and invisible meridians or learn the ever changing science of



applied nutrition. He knew nothing of tissue cleansing or lymphatic drainage. To him, health could be defined as an absence of disease. After working for a lifetime with that orientation, how could he embrace the concept that health was a state of being where one is unaware of any part of the body and in which one chooses to eat or drink, do, or not do anything one wishes, without harm. He was financially secure, if he retired tomorrow, he would be just fine and he wouldn't have to deal with his problem. But he loved his work, he could not just walk away from those who needed his care. These were his peak years where his insight and wisdom were at their highest – what could be do?

He began with one simple rule - "do no harm." He stopped prescribing the dangerous drugs, replacing them with placebos. It is well known that many initial illnesses, given time, will go away by themselves. He found ways to meet the needs of his patients without interfering, intervening or otherwise starting new conflicts in their bodies. He spent more time with each person, giving hope and encouragement, challenging them to make changes in their habits, their diet and their

relationships. His research into alternative therapies had revealed practitioners and treatments that worked reliably and did not harm. He sent his patients to them. He knew surgeons who could work for him, the dangerous drugs became a measure of last resort only.

It must have taken great courage to do what he did, many will disagree with him. But wouldn't you want a doctor whose first consideration was to do no harm?

In last week's issue of Port Orford *Today!* you asked candidates for City Council to state their position on the mediation. Here is mine.

I do not believe a city should make any decisions based on the cost of litigation or the threat of litigation. Decisions should be based on facts and on what is right.

In the Battle Rock Wayfinding Point situation, the facts are that a process which involved ALL people who chose to be involved resulted in a carefully planned, beautiful asset to our city with no cost to the citizens of Port Orford. The mediation process has excluded the majority of citizens from participation. The proposed settlement would mar the beauty of and detract from the excellent workmanship of the project for the benefit of a few. The message to the people would be don't follow proper procedures – it doesn't pay. Instead you should demand your own way at any cost.

If I were a member of the City Council, I could not in good conscience support the proposed settlement. It would amount to disenfranchising the citizens who followed proper procedures and rewarding those who chose not to participate in the planning process, but want it all changed after the fact.

One solution might be to pave 5th Street and the parking deck below Battle Rock Park if non-public funds could be found to pay for the work.
