

Candidates Answer Questions by Evan Kramer



The second candidate forum was held Monday night at the Port Orford City Hall. All ten city council candidates appeared and after making

opening remarks were asked a series of questions by the public.

The candidates were asked if they believed Port Orford is ready to expand into the Urban Growth Boundary. Gordon Corbett questioned how far we should expand. Jane Cramer said she believes in infill, not sprawl and is concerned with the infrastructure. David Darnell said he would not go along with expansion because of our sewer and water problems. Carl Eskelson said no. Norm Leeling said you have to be careful because of lack of adequate sewage and water mains. He said he would want to see a request to incorporate and a study first. Sandy Sandholm saw no sense in expanding except maybe Port Orford Loop but that it creates more problems. Tom Smith said we're going to have to expand on the North side of Garrison Lake but the city is not ready. Nathaniel Wander said there is no simple answer and asked what can our infrastructure support. Robert Warring said there was no simple answer. He

invited infill and questioned if we have enough water and sewer capacity. Leon White said many cities are dealing with annexation. The said let the voters in the city make the decision on annexation.

Jane Cramer was asked if she would bring back the CRT in some form. She answered no. Other candidates spoke including David Darnell who said he agreed with Cramer 100%. Carl Eskelson said any committee must be at the discretion of the council. Norm Leeling said been there, done that and it was time to move on. Robert Warring spoke of the CRT as a very dedicated group of individuals and that the city needs the help of citizens. He spoke of the process as very effective and the city could put together a similar group. Leon White said the whole CRT system was flawed. Gordon Corbett told the public he would work for them and we didn't need a formally organized group.

Gordon Corbett was asked if the city could fix the sewer outfall without obtaining grant money and if so how would you finance it. Corbett answered he had spoken with Richard Norad of H.G.E. about the problem. Corbett recommended taking what we have left of our sewer outfall, cleaning it out and reusing it. Other candidates were allowed to answer the question. Jane Cramer said she was

Hold Those Ballots

Absentee ballots were mailed to 320 voters in Port Orford last Friday. When people started receiving them in their mailboxes on Monday it was discovered that there was an error in the ballot. Due to a clerical error the name of Port Orford city council candidate Robert Warring was left off the ballot. Calls were made to city hall, the county elections department and the Secretary of State and by Monday night a solution had been reached.

According to Julie Denney in the County Election department only the city ballot portion will be reprinted and mailed to the absentee ballot voters. It will have the names of all ten council candidates. The election's department is asking you don't fill out your absentee ballot and mail it in until you receive the amended city council portion. Any voters sending in ballots before the new ones are mailed out will not receive an amended ballot. For those voters casting their votes at the polls on November 3 the ballots will have been reprinted and be accurate.

So please hold off on voting until you receive your amended ballot.

very much in favor of using grant money to solve the problem and she doesn't want to reestablish the dune outfall system. David Darnell said it was a big problem and some people aren't paying enough. Carl Eskelson said we have to do something. Norm Leeling referred to himself as a scientist and a skeptic. He emphatically stated we can not rehook to the existing drain field and quoted from a letter from DEO, which made that clear. Sandy Sandholm said we could not fix the sewer system without grants and lots of time. Tom Smith said he didn't have an answer. Nathaniel Wander said Richard. Norad of H.G.E. had sold so many lemons to the city the town was awash in lemonade. Wander said he is working on an alternative to the drain field in the form of a wetland treatment on 75-80 acres of land. Robert Warring spoke about Canon Beach and their use of a wetland wastewater treatment system on 31 acres of land and recommended we go with a wetland system. Leon White defended Richard Norad and H.G.E.

The candidates were asked to please explain how they would handle the balance between town hall democracy and representative government.

Gordon Corbett said the council works for you the people and needs to listen to the advice of the people. Jane Cramer advised video taping the council meetings and making them available to the public. David Darnell said the people have to know what's going on and everyone must be heard. Carl Eskelson said we need public hearings at workshop meetings. Norm Leeling said he had no problems with public input and believed in public hearings for controversial issues. He said the council must vote their conscience and do what's best. Sandy Sandholm said he believed in representative government. Tom Smith said town hall government is okay but there are too many people to make it work. Nathaniel Wander referred to the CRT as a town hall style government. He said 50-70 people can destroy anything in this town. Robert Warring said we can incorporate input into the workshop sessions. Leon White said issues of major consequence should be submitted to the voters and everyone should be able to talk at council meetings.

Candidates were allowed two minutes for any closing remarks. Jane Cramer said she has the necessary skills for the job of city councilor and is ready and willing to take responsibility for her actions as councilor.

Carl Eskleson said he is pretty well up on what's going on at city hall.


Norm Leeling asked people to please examine the qualifications of the candidates. He said he would work hard for the people and always vote his conscience.

Tom Smith said Port Orford has been the focal point of his life and asked for the people's vote.

Robert Warring said he brings a thorough understanding of the water and sewer systems of this and other cities. He said he has worked with different levels of government to accomplish goals to better the city.

Sandy Sandholm thanked the people for listening.

Nathaniel Wander said he was appalled by the ignorance and recklessness of some of the candidates.

David Darnell talked about doing something about the high cost of water. His answer was let the tourists pay by having an RV tax of twenty five to fifty cents a night. He said the details have to be worked out.

Gordon Corbett said as councilor he would listen to everyone no matter where they

live. He said he we need more economic activity in town and to get that we need to advertise.

Letter to the Editor by Al Affonso

In a recent letter to the editor Martha Weaver-Britell made some to the point comments about water and sewer rates, and those candidates that think they have a simple answer to our dilemma. For the biggest part I agree with Martha's comments, but the loan payment which is referred to is not the cause of our high sewer rates. The original loan amounts that we committed to were \$900,000 payable annually, including reserve accounts, at \$53,810. This is less than \$10 per month per user or \$19.63 bi-monthly.

What is really causing our high sewer bills is the money that it takes to operate

and maintain (O&M) the sewage treatment facility. The original budget was set at \$130,000 per year. Due to increased costs of labor and equipment replacement, this budget has now reached more than \$150,000. We pay for this through a consumption method at the rate of \$3.10 per thousand gallons of water used. The more you use the more you pay.

It has been suggested by some that we go to a flat rate method based on the number of people in a residence or business. The thought being this would allow residents to use unlimited water to irrigate their properties without paying any additional sewer costs. There are several problems with this fee schedule.

#1 One of FMA's conditions to obtain the necessary funds to construct the facility was that the rates would be equitable to all and water conservation would be promoted. Unlimited usage via a flat rate does not promote conservation.

#2 If you have, as an example, home A and home B each having two residents, but home B is using twice the amount of water as home A, would it be equitable to charge home A the same flat rate? I don't think so.

#3 Insofar as businesses are concerned, how would you determine how many people are using the facility on a daily basis or during a two month billing cycle? You could, I suppose, develop a flat rate based on average usage, but now we are back to consumption.

No matter how you figure it we need to annually raise a little over \$200,000 to satisfy the debt and maintain the sewage treatment facility. Up until this year's disaster with our drain fields, it appeared that we would be able to reduce the amount of money being collected to pay the debt due to some excess in the debt service account. But as things stand right now,

it's wait and see. In my opinion the only real solution to this dilemma is a modicum of infill growth. It is my understanding that we have at least 80 dwellings that will be added to the system. At \$2,000 per hook-up this would mean \$160,000 would go immediately into the construction account. In addition, 80 homes with

an average consumption of 11,000 gallons per month would generate another \$32,736 annually to support our O & M.

A year ago a rate raise was being considered to support the growing O & M but this was avoided by legally transferring \$40,000 from the construction account. Not withstanding the disaster at the drain fields, I believe we are now over the hump.

If the City is looking for a way that allows the residents to irrigate their properties without increasing their sewer bill, perhaps a rate reduction could be considered. For example, during the dry season, say June through September, the rate could be reduced from \$3.10 per 1,000 gallons to \$1.75 or \$2.00 per 1,000. Of course, the homeowners would have to use more water to offset the loss of revenue. This temporary rate reduction would still encourage conservation because you are still paying for what you use and it would be equitable to all.

Vote for whomever you choose, but don't let such a critical issue be used as a political football.

Smith Promises Port Quota

U.S. Senator Gordon Smith visited Port Orford last Tuesday and spoke at a public forum. He had visited Brookings in the morning and the Coast Guard had given him a helicopter tour of the area including Port Orford. Smith told area residents he was "mindful of the distress you feel." He said he was here to listen to people and tell them about what he's been doing in the Senate. Smith sits on the Energy and Natural Resources Committee, which handles forest, farming and energy issues including dams on the Columbia. He also serves on the Foreign Relations Committee and talked about how dependent Oregon is on foreign trade. Smith also sits on the Senate Budget Committee and said he was hopeful the Senate and President would get a budget deal soon.

Smith then took questions and comments from the people in attendance. Jerry

Senator Smith related a story of how the government had bought out several Chetco River gold mining claims for \$3.5 million and his respect for private property rights.

Port Orford City Councilor Norm Leeling spoke to Smith about the problem with the city sewer system. Leeling asked Smith if there was anything he could do for us as Senator. Smith answered yes and said there were several programs available to rural communities.

Lyn Haller said he was concerned about the way fish are allocated. He asked Smith if he could influence what the Pacific Fisheries Management Council is doing. Haller said the actions of the 285 trawler boats may put 2,000-6,000 small fishing boats out of business. Haller said the trawlers get 85% of the fish allocation and asked who is doing the lobbying for small fishermen. Smith said that's why he was here and it was good to see a human face. Rob Ashdown, president of the Port Orford Fishermen's Association asked what happened with the Magnuson-Stevens Act. Smith said he and Senator Ron Wyden tried to get more allocations for small Oregon fishermen. Ashdown said he wanted sustainable limits and requested a community quota for our Port. Smith said, "I'll make it a priority in the 106th Congress next year."

Georgeanne White invited Smith to come back and visit and go fishing with her husband. She told Smith he could carry on the tradition of Mark Hatfield who backed the Grassy Knob Wilderness. David Wilken, chairman of the Port Orford Watershed Council told Smith the council supports the Copper Salmon Wilderness proposal. Wilken spoke about the problem with decreasing timber revenues for Curry County. Smith said all wealth comes from the earth and it is the underpinning of the U.S. economy. Smith said he doesn't want to shut down the ability to sustain us. Mary Griffin, from the Coast Chapter of TREES spoke in opposition to the Copper Salmon wilderness and asked how many times we need to revisit the issue.

Senator Smith presented a plaque to Fred Bitgood for his contributions to Port Orford including volunteer efforts and inspiration.

Letter to the Editor,

Measure 56 is yet another unfunded mandate. It imposes an annual burden of nearly \$4 million on we taxpayers to pay for sending direct mail notice to one special class of citizens – landowners.

Forget the fact that much of the notification required by 56 is already provided or made available in much less expensive ways, what is fair about granting special benefits to just one group. Why don't we, for example, require written direct notice to auto and truck owners when laws affecting them – like increased vehicle or fuel taxes are proposed.

Sure it would, but it would turn our government into a very expensive mailing house and make it far more difficult for it to serve us the way it should. And if this measure passes, that is exactly the outcome we can expect for those branches of government that apply our land use laws.

Measure 56 is a more subtle attack on Oregon's land use laws than Measure 65. Its impact will be less obvious, more akin to the "death of a thousand cuts." Mandate extra duties for one sector of government while you keep cutting its budget and it will soon lose its effectiveness. Exactly what the anti-land use planning folks want.

Look beyond shallow claims of 'fairness.' Don't allow our tax dollars to be squandered or our land use laws to be stolen. Vote NO on Measures 56 and 65.

Creighton advised he was told the investigation had been completed, and that the Secretary of State office determined that no evidence of misconduct was found. Creighton further advised that a copy of their investigation is being sent to him, and he wanted to review those documents before forwarding his investigation and complaint.

It appears there are some very serious questions left unanswered. Creighton does not feel this investigation was conducted very professionally. Creighton said from information he has seen it appears that no one from the Secretary of State Office came to Curry County to talk to anyone. It was all done by mail. It

cannot be a very good or thorough investigation if it is conducted by mail. Creighton said he had never heard of such a thing, especially when it involves something this serious.

Creighton said this is another example of our State taking the easy way out. Creighton said it sounds like a political white wash. He said this type of service is not new to Curry County.

Creighton said he is not satisfied with the type of investigation the State has done, but will wait to see what information is available from their documents. He wants to know what their investigation revealed before forwarding his investigation and complaint.






