# Lake Water Turns Salty By Evan Kramer



It came as a big surprise but last week the City of Port Orford was forced to switch its water source from Garrison Lake back to North Fork Hubbard

Creek. City Administrator Johnny Alexander explained the situation in a meeting he held with Jay Stoler and myself on Saturday morning.

Citizens started calling the city complaining about the city water on Friday, October 16 saying it tasted salty. On Tuesday, October 20, a water sample from the lake was sent to Coast Laboratory for testing and it came back that the water had 268 parts per million of salt. The city had switched to Hubbard Creek water the previous day. On Friday, October 23 the water test showed 290 parts per million of salt in the water.

An exact explanation of what caused the increase in salt in the water hasn't been determined. Two theories are there is an "underground intrusion" of ocean water into the lake and another is the lake has "turned over" due to lack of fresh water flowing into it.

What does this mean? One thing is that the City does not have a secondary source

of water at this time. The only source of water, which is North Fork Hubbard Creek, is very fragile this time of year through next spring because when it rains the turbidity in the water increases. That's why the City had already switched over to Garrison Lake water earlier this month. Alexander described the City's water treatment plant as a low turbidity plant. Unfortunately Hubbard Creek water in fall and winter is a high turbidity situation.

One result of this latest crisis is the dredging of the reservoir at Hubbard Creek will be put off until next Spring. A saving grace in this current situation is the contractor Laskey-Clifton had not started dredging the reservoir. Had that work started the City would have been in a world of hurt, as the reservoir would have had to be drained. Work will continue on the new raw water line but precautions are being taken so the city is not cut off from its water at Hubbard Creek more than one and a half days.

## **Police Bond Meeting**

A meeting was held Monday night to discuss the police bond issue on the city ballot. Curry County Sheriff Chuck Denney, Former Police Chief Russ Hunt and current chief Bill Rush answered questions from those in attendance. Councilor Jim Campbell explained the 2-year

levy would increase property taxes sixtyseven cents per thousand dollars and raise approximately \$39,000 per year.

Sheriff Denney described \$39,000 a year for an additional police officer as a pretty good deal. He said contracting out for one sheriff deputy would cost the city between \$40-45,000 a year and that wouldn't include fuel and supplies. Denney went on to a detailed description of the downsizing of the Sheriff's Department due to budget cut backs. They are down to seven patrol deputies and he explained that isn't enough to provide 24-hour coverage.

Russ Hunt said for the population base in Port Orford we would be in the top 5 statewide for crimes.

Chief Rush said without law enforcement the criminals will start moving in. He said one additional officer would really help and urged passage of the levy for an additional officer.

### **Property Taxes Go Up**

Property tax bills started showing up in people's mailboxes on Saturday. Yes, property taxes did go up but not because of actions taken by the city council or the Curry County Commissioners. They increased for property owners in the Port of

# Resignation Demand by Mark Creighton

Sheriff's Candidate Mark Creighton stated his preliminary investigation into possible election fraud has revealed some shocking new facts in regard to possible vote tampering, mishandling of ballots, and false statements. Creighton said he received a copy of Norma Buckno's completed investigation from the Secretary of State regarding allegations of vote tampering from complaints made by three Curry County Citizens. Creighton said, "The facts in Buckno's report does not clear the issue, in fact, it validates the complaints that have been filed. I do not understand how evidence this clear could have been ignored by the Secretary of State." Creighton said, "The only way a person would not see the evidence in this report is to either close their eyes, or not read the statements that were provided to them. The results of Buckno's investigation should have been turned over to the

proper authorities immediately."

Creighton further advised the extent of Buckno's investigation was a request to Renee Kolen, and her workers to answer four questions regarding what took place in the counting room on election night. In Buckno's report, he said, the four questions were mailed to the nine employees who worked at the counting board on election night. Six of the nine employees said they left the office at about 12:30 am. after all the ballots had been counted. On the other hand, Mrs. Kolen said all the ballots had not been counted, and there was only one box of about 300 absentee ballots left in the counting room, where all the ballots had been stored. One of the employee's said the counting board was released at 12:30am that night and that she left the office with the other girls, but then drove to Brookings with Mrs. Kolen "to locate" a box of ballots from Precinct 22.

Creighton said, "If this is true, it appears Renee Kolen has lied to the public and to the Secretary of State's office, and has chosen to withhold information about a box of ballots that was not left in the counting room as people were led to believe, but instead had to be retrieved from Precinct 22 at approximately 2am, from the Port of Brookings Harbor building. That box of missing ballots had been unsecured since the close of polls at 8pm for more than five hours."


Creighton said, "With this type of mismanagement from an elected office, the intentional withholding of information, and the sneaking of ballots after the counting had stopped, leaves little confidence in the continued performance of Renee Kolen. I believe she should resign before the November 3rd election to restore confidence in our electoral process. The credibility of past elections is now starting to be questioned, and certainly, the results

of any future elections will now be suspect because of what was allowed to happen and be deliberately overlooked in this case. 
#### Letter to the Editor,



#### Letter to the Editor,

Measure 56 is a live hand grenade hurled at our land use laws. According to the Secretary of State, it will directly cost taxpayers more than \$3.5 million per year, and it will cripple our local planning departments. It will actually make planning approvals harder to get.

Our counties and cities are now required to inform adjoining land owners whenever they prepare to act on a specific case, for example, to permit a sub-division or to re-zone property. They are required to hold well-advertised public hearings, to specify the legal criteria, and to make available the records on which decisions will be made. They are also required to hold advertised public hearings if they intend to change any of their land use laws.

Measure 56 would require counties and cities to individually notify any land owner who might be adversely affected by any changes in land use laws. The work time to do so would take away from the ability of local planning departments to serve the public. The cost to do so would be born taxpayers statewide.

Can you imagine a law requiring police

#### Ballot Measures By Valerie Jean Kramer

**Measure 54** – Amends constitution: Authorizes state to guarantee bonded indebtedness of certain education districts.

Permits the state to co-sign bonds issued by schools, ESD's and colleges. If the school defaults on it's bond, the state would have to pay. Because of this "insurance" the schools would have to pay less interest—an estimated savings of \$70 million over 20 years.

Arguments in favor: It saves money.

Arguments opposed: None

My opinion: Sounds like a good idea.

**Measure 55** - Amends constitution: permits state to guarantee earnings on prepaid tuition trust fund

Permits people to pre-pay college tuition. The state would pay any tuition in excess of that contracted amount.

<u>Arguments in favor:</u> Makes college more affordable. Makes college tuition more predictable.

<u>Argument opposed:</u> It could cost taxpayers money.

My opinion: I believe a good education is very important. This measure would make college more affordable. I fear it will be used most by those least in need of the help but it is probably still a good idea.

Measure 56: Expands notice to landowners regarding changes to land use laws

Requires cities and counties to mail notices to landowners of any proposals that would place new limits on the use to which the land may be put. The state will reimburse costs of notices due to state statutes or administrative rules

<u>Arguments in favor:</u> Property owners have a right to know when changes are being considered that would adversely affect their property rights. Presently no notice is required.

Argument opposed: None

My opinion: There will be some cost to the state for mailing notices but I know I'd want to be told if some agency were planning to take away some of my rights! Vote yes!

**Measure 57:** makes possession of limited amount of marijuana class c misdemeanor

This stiffens the penalty for possession of small amounts of marijuana. In addition to the present \$500-1000 fine, an offender could also receive a 30 day jail sentence. Costs of enforcement go up and revenues from fines decline. Estimated net cost about \$1.2 million per year.

Arguments in favor: Marijuana is harmful, addictive, and leads to use of harder drugs and criminal activity. Criminals are attracted to our state because of our lenient laws. Permissive laws encourage use. Drug use by children is increasing.

Argument opposed: This law could lead to forfeiture of your car, assets, or home. It violates your right to privacy. It costs too much. We don't have jail space for these offenders. Attention should be paid to violent criminals instead of pot smokers. Marijuana is safer than alcohol and less addictive than coffee or tobacco. Prohibition failed for alcohol and is not the solution for marijuana..

My opinion: I was once a heavy marijuana smoker. One day I realized that if I abused alcohol the same way, I'd be an alcoholic so I stopped using it. I felt no physical symptoms of addiction withdrawal. For many months, I felt as though a cloud was being lifted from my brain. Marijuana use had made me stupider without my realizing it and I find that scary. Fortunately, the results were reversible. Of all the marijuana users I knew, very few went on to other drugs and none used heroin or crack or anything so deadly. I

think our inconsistent laws regarding chemical substances such as marijuana, alcohol, tobacco, etc. send a clear message to children that it's all a political game and not really about the substances at all. It encourages disrespect of the law. I think we should impose sensible controls on all drugs but I think the harsh penalties of this proposed law will cause more harm than good. I'll vote no.

#### Measure 58:

Requires issuing copy of original Oregon birth certificate to adoptees

Oregon-born adoptees aged 21 or older would be able to get an original birth certificate showing their genetic parents names the same as anyone else.

Arguments in favor: Adoptees should have the same rights as anyone else. Privacy was never guaranteed to parents. Many parents never knew their children couldn't find them.

<u>Argument opposed:</u> Privacy of birth parents should be protected.

My opinion: Letting someone else adopt and raise your baby is not like turning over a used car to someone in return for them taking over payments. There are emotional repercussions. Many adoptees will never know peace until they know who they are and who their birth parents were. I cannot condone protecting the privacy of the guilty – those who bore a child they didn't want or couldn't keep – while denying peace and knowledge to the innocent child who happens to be adopted. I'll vote yes.

**Measure 59:** Amends constitution: prohibits using public resources to collect money for political purposes

Public employee time, public property or equipment and supplies could not be used to collect money used to support or oppose a candidate, ballot measure or initiative petition. Use is not permitted even if

paid for. This proposed law is construed to prohibit public employee payroll deduction for union dues.

Arguments in favor: Unions use dues money to further various political agendas. Some union members don't want their money to support those agendas. Government should remain neutral in elections. Public employee unions have taken over the system undermining democracy because of their enormous checkbooks filled by deductions collected at government expense.

Argument opposed: Private unions will still have deep pockets. 59 is vague and unclear. It prohibits police from directing traffic at political events. The voters pamphlet would become much less informative. Some restrictions in measure 59 already exist. It's unconstitutional.

My opinion: Reading the text of the law, it is clear that measure 59 will destroy the value of the voters pamphlet and other sources of information for voters. It is not about saving money since it prohibits services even if the government is reimbursed. This appears to be an attempt to stifle information so big money ads can more easily buy their way in public elections. A big NO on this one!

**Measure 60:** requires vote by mail in biennial primary, general elections

Current law prohibits vote by mail for biennial primary or general elections. Measure 60 would instead <u>require</u> it. Reduces election cost by about \$3 million for each such election.

<u>Arguments in favor:</u> Reduces costs. Increases voter participation. It's convenient.

<u>Argument opposed:</u> Various concerns about fraud including discarded ballots, lack of physical verification of voter, transportation and storage of ballots,

length of voting period, etc. Voting is trivialized and may lead to votes cast with less thought behind them. Unions, churches, spouses, or employers may coerce individuals to vote together their way.

My opinion: I like to save money but I've found that being cheap is often the road to disappointment. The arguments about coercion worry me as do the ones about fraud. I'd prefer to be safe rather than sorry on this one. I'm opposed.

**Measure 61:** changes minimum sentences for listed crimes, including certain repeat offenses

Toughens criminal sentences.

Arguments in favor: Convicted criminals should be punished. Current law sets them free. Oregon is 9th in the nation for property crime, up 25.6% since 1991 resulting in \$1.25 billion in losses during that period. Since passing measure 11 in 1994, violent crime is down 11%. The cost of imprisoning criminals is less than the cost of their continuing crimes.

Argument opposed: Someone might be unfairly sent to prison. Tough sentences don't lower crime rates. It's too expensive. We'll need another prison that nobody wants in their neighborhood.

My opinion: Personally I favor hanging the SOB's so you can see where I'm coming from. A brief research on the Internet shows that recidivism rates of about 40% are not uncommon and that's AFTER the criminal has been punished! I think our legal system has many flaws that urgently need to be fixed but until they are, I know that a convicted criminal isn't going to be a repeat offender if he or she isn't on the streets to offend! Nuff said!

**Measure 62:** amends constitution: requires campaign finance disclosures; regulates signature gathering; guarantees contribution methods

Measure requires more disclosure of campaign contributions, imposes restrictions on petitioners, and prevents measure 59 from interfering with payroll deductions for campaign contributions.

<u>Arguments in favor:</u> Reduces out-of-state influence in Oregon elections. Provides better information on who is behind what.

Argument opposed: Measure 62 seeks to overturn measure 59. It interferes with the grass-roots initiative process. Parts of it are unconstitutional and other parts duplicate already existing statutes ORS 260.522 and 260.558.

My opinion: This does, indeed, look like a sneaky attempt to protect union contributions by amending the constitution. I'm opposed.

**Measure 63:** amends constitution: measures proposing supermajority voting requirements require same supermajority for passage

The wording on this is hard to follow but what it does is prevent a group of voters from passing laws that can't be changed by an equivalent group later.

<u>Arguments in favor:</u> It is simple and fair. It protects the state from vocal minorities.

<u>Argument opposed:</u> It prevents the majority from passing some laws.

My opinion: Measure 63 closes a dangerous loophole. We've seen many issues recently where we've been nearly divided 50-50. A minority interest can whip up support to pass their measure. Once they win a majority election, they can rest because their measure requires a 2/3 vote or some such to change. Passing measure 63 means that if it takes a 2/3 vote to change, then we need a 2/3 vote to implement in the first place. I think we need this protection so I'll vote for 63.

**Measure 64:** prohibits many present timber harvest practices, imposes more restrictive regulations

Prohibits clearcutting chemical herbicides, pesticides on all lands, public or private. Limits size of trees that can be harvested. Imposes new harvest regulations. Etc.

Arguments in favor: It protects our forests, fishes, and wildlife. It stimulates ecotourism. It prevents replacing diverse forests with tree farms. Ecodamage is expensive to the public. It encourages stable, sustainable forestry instead of stripmining Oregon then leaving.

Argument opposed: Its too extreme. It reduces productivity of Oregon's forests. It doesn't leave room for judgement. It encourages cutting trees before they get to 30". It will harm our forests. It confiscates private property rights. It will encourage more lawsuits. We'll lose jobs and damage our economy. It will hurt schools

My opinion: Passage of this bill would make Oregon a greener, cleaner place to live. It would also cause disruption to the timber industry. Jobs would be lost and people's economic lives would be hurt. Is it worth the price? I don't know. I like parts of this measure and dislike other parts. Vote your conscience. . . Or your pocketbook.

Measure 65: amends constitution: creates process for requiring legislature to review administrative rules

The legislature sets up agencies who make administrative rules that have the force of law but are never voted on nor reviewed by those we elect. Measure 65 allows voters to require legislators to review specified rules.

Arguments in favor: This measure doesn't change any rules but it gives you a chance

to tell the legislature to check out things that upset us. It makes government more accountable.

Argument opposed: It's unnecessary and may be unconstitutional. It would require only 25,000 signatures and a single State Senate Committee Chairman to repeal a rule. Rules protecting farm, range, and forest lands will be repealed by minority interests. Public health rules could be repealed. It's burdensome. It introduces instability. Anyone can already ask the legislature to repeal or amend any rule without collecting any signatures.

My opinion: There's something funny going on here. Groups I usually respect are opposed to measure 65 but at the same time they tell us how dangerous and bad it is, they tell us we don't need it because we already have the right to ask for reviews. Seems like the only difference is that a few voters can REQUIRE the legislature to review a rule and they MUST take action to keep the rule. I'm not sure if I'm missing something or what. When in doubt I follow the old advice, "If it ain't broke, don't fix it!" I can live with our present system so I'll probably vote no on 65.

**Measure 66:** amends constitution: dedicates some lottery funding to parks, beaches; habitat, watershed protection

Lottery money is currently used only for job creation, economic development, or public education. Measure 66 takes 15% for parks, beaches; salmon, wildlife habitat, watershed protection.

<u>Arguments in favor:</u> Our parks and watersheds etc. need help. Assorted statistics and facts in support of this assertion.

<u>Argument opposed:</u> Measure 66 further legitimizes gambling.

My opinion: Viva Las Vegas! I bought a scratcher this morning (and lost.) I'm surprised the schools or other lottery beneficiaries didn't complain about lost revenue but if they're happy, I've got no

complaint. I'm sure the money is needed and I particularly like the fact that 65% of it will go for long-lasting capital expenditures. I'll vote ves.

**Measure 67:** Allows medical use of marijuana within limits; establishes permit system

Oregon statutes currently prohibit possession, delivery, or production of marijuana. Measure allows engaging in, and assisting medical use of marijuana.

<u>Arguments in favor:</u> It can reduce pain and improve the quality of life for a number of seriously ill people.

Argument opposed: Marijuana is bad for you. Equivalent drugs are available. Somebody other than the ill might get it.

My opinion: When a doctor can't prescribe what he or she feels is the best treatment for a patient, then there's something wrong with the system. I don't care if that treatment is herbs, drugs, prayer or a ride in a flying saucer. Lets keep our collective noses out of other people's businesses. Let's let the seriously ill have a little peace and comfort and let our existing laws take care of any abusers of the system. I'll vote yes.

#### Letter to the Editor,

The Port Orford Volunteer Fire Department conducted a test on April 20, 1998 to determine how the proposed CRT plan for Highway 101 curb extensions (Highway 101 Beautification Ballot Measure 10) would affect our work. We found that we would be unable to turn down a side street from 101 if there was an oncoming car on that side street. Our response time would be slower and a serious traffic hazard would be created.

Also it was mentioned by a member of the firm that designed the Highway 101 Beautification Plan, that fire hydrants on corners would have to be moved. Our fire hydrants are located where they are for specific reasons:

- 1) To allow for maximum accessibility for us to hook and to pull hose from them.
- 2) Maximum accessibility for more than one unit to use the hydrant
- 3) Maximum range and ease for fighting fire.

The Fire Department does not consider moving fire hydrants to be in the best interests of the community. As we are charged with the safety and protection of lives and property in our community, we are opposed to the Highway 101 Beautification Project as it will hinder us in our ability to quickly and safely respond to any call.

#### The Clay Goddess By Graeme Graydon



I don't think of myself as an artist but from time to time I get an urge to make something out of wood, stone, clay or metal. Anidea comes

into my mind and begs to become a reality. Recently I made a figurine of clay, evolved out of an idea about an age-old concept of the Mother Goddess-you will have seen some of these ancient figures in the National Geographic.

As she took form, she was soft, compliant clay. I could change her expression, move her arms, alter her pose and after as she dried I could still scrape and polish little refinements of change. Last week I took her to Paul, our village potter, to squeeze into his kiln for a biscuit firing. Later he showed her to me-she had shrunk in size, which is what clay does in a kiln, changed color from gray to pale cream and was as hard as stone. The fire of the kiln had fixed a fleeting moment of my expression into something unchangeable.

This reminds me of the ways in which I had been shaped by people or events outside of me. As a child, impressionable as soft clay, I was moved by hands that were mostly caring into shapes that met their approval. As I grew, the shapes began to harden, many of them becoming rigid beliefs and opinions that I relied on to keep me safe as I entered into young adulthood.

My father taught me to drive in the family Oldsmobile at age 14. One of his cardinal rules was to "keep both hands on the wheel except for making hand signals." It was a good, sensible rule. During the field-training stage of university days, I met a young lady and invited her to "the pictures." (that's what movies were called). Her mother insisted that we should use her son's car for the date as she didn't like the idea of her daughter on the back seat of my motorbike. Well, of course I drove with great care – it was not my car and I was doing things properly - with both hands on the wheel. Funny thing was that our next date in the car, in a flash of brilliant insight, I realized that I could drive safely with one hand on the wheel years of conditioning were broken in a very delicious moment. I wish I could dissolve all my other conditionings so easily. I suppose that it must be a lifelong process, gradually replacing old ideas and rules, which ALWAYS come from somewhere else, with wisdom that I can call my own. I like the idea that I can keep changing my rules. Today's truth might not be good enough for tomorrow's needs.

I can't change my Goddess – she's fired forever just the way she is. If I don't like her tomorrow, I can lovingly dispose of her with gratitude for what she was to me – and make a new figure. So many of my rules and truths, especially about other

people, have lost their power over me and I have made new ones to get me through today. I guess I'll be doing that till I go home when hopefully I wont have any rules left to change. And, oh yes, that young lady did become my first wife.

# The Sky Is Falling by Valerie Jean Kramer

Yep. It's true literally this fall. the sky is falling and amateur astronomers and skywatchers everywhere are looking forward to it. It began about October 8th with a meteor shower known as the Giacobinids. They appear to come at us out of the constellation Draco and are also called the Draconid shower. Two of the greatest showers of the century, 1933 and 1946 were produced by this rabble of flotsom from comet 21P/Giacobini-Zinner which rounds the sun every 6.6 vears. The best showers occur when the Earth passes its trail shortly after the comet has been and gone. This year we get there about 2 months early as we did in 1926 when an impressive display still occurred. Best time to watch is in the evenings.

Following the Giacobinids we may get to see a rare display of the taurids. Most years the debris from Comet 2P/Encke

makes a weak showing but we're in for a treat this year. We should pass thru a relatively dense clump of junk between Oct. 25 and Nov. 10. Look especially for bright, slow meteors whose paths converge on the constellation Taurus. Best time to watch is predawn hours in late October and early evening from Nov. 6 to 10.

All this is just the entree for the famed Leonids. You can expect to see a nice shower with a rate of about one meteor per minute on the mornings of Nov. 17 and 18. The sky should be nice and dark as there is a new moon on the 18th! The Leonids are remnants of Comet 55P/Tempel-Tuttle which swings around the sun every 33 years. The only true meteor storm (as opposed to shower) that has occurred during the modern age of easy astrophotography was the Leonid shower on the morning of Nov. 17, 1966 - the last pass of Tempel-Tuttle. The comet itself passed through the inner solar system

earlier this year so we should have some exciting viewing this year or next. It is even possible that we could see thousands of shooting stars each minute during the peak of the storm. Regrettably, the best place to view is eastern Asia but don't give up. You should be able to see plenty from your own back yard!

It doesn't take much to be a meteor watcher. Just go out when it's dark and clear and look up. don't use binoculars or a telescope - they restrict your field of view. Be prepared for cold weather. A lawn recliner helps too. If you want to try to take a picture try time settings of 3-15 minutes. More? Visit www.skypub.com/meteors/3showers.html

I remember when the County Sheriff Department supplied our police coverage. Then a few years ago, our City Manager at that time decided we needed our own police force and with grants from the federal government, hired a policeman. This hasn't worked out too well, because this position has been like a revolving door having already hired numerous persons as policemen. This process has taken many hours away from other business every time the City Council has to fill this position. We are now asked to pay for a policeman by voting to increase our property tax again. According to an article in the Port Orford News, Volume 41, number 41, October 14, 1998, Port Orford already pays higher property taxes than Gold Beach and Brookings. Port Orford property taxes are the highest in the county due to the Port levy and hospital levy. If you vote for a police levy, we will be paying over 30% higher property taxes next year than we did in 1997. Let us pay for our police coverage from the General Fund as we did so successfully in the past, whether it be a contract with the County Sheriff Department, or our own policeman, we do not need to raise any more property taxes.

Port Orford and Curry Health Districts because voters in these two districts approved bond issues within the last year. The Port District bond is for a twenty-year period while the Health District bond is for 5 years. The two bond issues have resulted in property taxes going up nearly 20% for those people owning residential or commercial property within both districts.

Measure 50 mandated property taxes be rolled back to the 1995-96 level less 10%. Property taxes are no longer based on real market value in Oregon. They can only be raised 3% a year unless you undertake a major remodeling on your home or business.

So there you have it; three major changes to your 1998-99 property tax bill all approved by a majority of those voting.
