Council Considers Rights By Evan Kramer



The Port Orford City Council met on Monday night and considered a Bill of Rights Resolution.

The council begins its meeting with department

reports and then followed that by putting two items of old business before citizen's concerns. The first item was the outfall construction award, which they decided they had voted on at a previous meeting and didn't need to do again. Then they considered the outfall construction project inspector selection. SHN Engineer Steve Donovan said that his company recommended the hiring of Steve Roeman and Ron Stillmaker as the resident project inspectors. Steve Roeman is a resident of Port Orford. He was a mechanical engineer with the US Navy. Donovan described Roeman as the "ideal person for inspector." Councilor Jim Auborn made a motion to accept SHN's recommendation of Ron Stillmaker and Steve Roeman to be resident inspectors of the outfall project and it passed 6-0.

The council then moved into Citizen's Concerns under which was listed Port Orford Bill of Rights Defense Committee. Mayor Gary Doran read the resolu-

tion presented to the City by the Bill of Rights Defense Committee. This resolution was previously printed in both newspapers. Florence Prescott spoke on behalf of the Bill of Rights Committee and asked for a show of hands in support of the Resolution and many in the packed council chambers raised them. Prescott said the Resolution reaffirms the City's responsibility to uphold the Constitution. She said if the council passed the Resolution it would be joining 130 other cities in upholding our Constitutional freedoms. She said this could send a strong message to Congress. Prescott said the Committee had turned in signature petitions in support of the Resolution with 110 people living in the City, 40 living outside the City and 12 business owners in Port Orford.

Norm Leeling said he viewed council adoption of this Resolution as upholding our Constitutional rights. Leeling said he was concerned about the hastily passed Patriot Act, which he described as another unfunded mandate. He told the council it was their task to check out the information and come to a reasonable conclusion. Nella Abbott described this issue as not a political or partisan one but beyond politics. She questioned whether 5% of the people who voted on the Patriot Act had read it.

Eric Johnson said he considered the Patriot Act as an attack on the Bill of Rights and that we needed to fight for our freedoms

Steve Abbott, a member of the Bill of Rights Committee, described the Port Orford Resolution as the most benign of the 130 resolutions passed so far. Abbott said the committee would be willing to drop the last sentence in the resolution to reach consensus.

Bob Elligott said his main concern with the Patriot Act II was that it erodes the court system and the Bill of Rights. He asked the city council and friends to take a stand granted us by our Bill of Rights.

Ronn Kerr spoke as a clergyman and concerned citizen. He said he was deeply troubled by things going on in this country and that our basic freedoms are under attack. He said people were troubled that their activities were being recorded and gathered in databases. Kerr told the council the Bill of Rights Resolution is an opportunity to reaffirm the liberties we cherish. He said the council could vote to reaffirm the Constitution and Bill of Rights or they could vote to allow these abuses to grow.

July Port Meeting By Jane Cramer

Commissioners Gifford Barnes, Evan Kramer and George Welch as well as Port Manager Gary Anderson attended the regular meeting of the Port Commission on July 15.

Under Unlisted Items, Kramer reported on a press release he received by fax from Peter DeFazio's office. The notice stated that funds for the Port of Brookings Harbor, the Port of Bandon, the Port of Siuslaw and the Port of Umpqua had been approved under the fiscal year 2004 Energy and Water Appropriations Act. The Port of Port Orford and the Port of Gold Beach did not receive any funding under the bill.

Several housekeeping matters were disposed of under New Business. The commissioners unanimously passed a motion that all commissioners should have check signing authority and recently

elected commissioners Kramer and Welch were sworn in by Anderson before officers were elected for the coming year.

Welch was elected President; David Knapp was elected Vice President; and Ed Dowdy was elected Secretary Treasurer by unanimous vote.

Although Dowdy will make a complete report at the next meeting, Anderson gave the highlights of the Planning Committee meeting. He spoke of the presentation by Marilyn Oberbeck and Rick McGee of a proposal for the space now occupied by the cannery building. Plans would include shops and a sea spa. Representatives of POORT (Port Orford Ocean Resource Team) spoke at the committee meeting about their concerns with the project. Anderson stated that there were many issues that needed to be addressed with regard to zoning and financing before the project could get under way. He advised that a Public Hearing would be held before any decisions were made about leasing the property to McGee.

Anderson spoke of a proposal from Moss Adams for a pre-audit engagement, stating that hiring them would cost less than paying the audit firm to do the work during the audit process. Commissioners agreed that Anderson should contact other CPA firms for proposals and that an effort should be made to use a local firm if possible.

With regard to a letter from Greg James regarding a street vacation, the commissioners decided to table the matter until the City of Port Orford has taken a stand on the issue.

An OSHA certified crane inspector will be here on July 25 to do a weight test on the crane. Cost to the Port for the testing should run about \$3,000.

Anderson advised that the State Marine Board has denied the grant for repairs to the sport crane, but the grant to repair the cannery roof has been approved.

Under Old Business Anderson reviewed documentation from the leasing agent for the copy machine, which advised the machine could be purchased outright for \$377.10. The commissioners voted unanimously in favor of the purchase.

When termination of the PPS (Premium Pacific Seafood) lease was discussed Gifford Barnes declared a conflict of interest, leaving less than a quorum for a vote. After some discussion, the commissioners reached a consensus that Anderson, as an agent of the commission had the authority to sign the Termination of Lease agreement for the Port. Mark Barnes will sign for PPS.

Anderson supplemented the written Manager's Report with an oral report on some issues he had resolved during the month. He reported some problems with a boat dragging its mooring because of the weather and a problem that occurred over July 4th with a boat from Coos Bay.

The captain wanted to use Port facilities for 20 charter divers. Anderson refused because the captain had paid no charter fees, was not licensed to captain a charter boat and had no permit. He will send a charter agreement and a copy of the Port Ordinance to the boat captain.

He advised he had received a bid of \$700 for cutting holes in the dock retaining walls to prevent flooding on the dock during winter storms. Anderson will check with the engineers who designed the dock to see if they will pay for the work.

After a discussion of the financial report, the meeting was adjourned.

Letter to the Editor:

We appreciate the vigilance of the citizens who have formed the Bill of Rights Defense Committee. Such vigilance is critical to preserving our freedoms as delineated in the Bill of Rights.

We have studied their resolution and find ourselves in agreement with the sentiments expressed up until the last sentence. In that last sentence, the Committee lists some, but explicitly not all, the activities that they evidently believe the Patriot Act (which is a law of the United States) requires, but that in their opinion are in contradiction to the Constitution, and which they hope to pressure the City Council to pledge to disobey.

All members of the City Council and city officials have already sworn to support the Constitution of the United States, the



Constitution of the State of Oregon, and the laws thereof. How can they now pledge to disobey one of them, according to the interpretation of an arbitrary group of citizens? We think this is the wrong approach.

If in the face of very real terrorist threats we have to give up some liberty for safety, it is critical that citizens be fully engaged in determining how much of one we are willing to sacrifice for how much the other. Once legislation is passed and becomes the law of the land, the proper way to test its constitutionality is to bring it to the courts. You cannot ask your elected officials to swear to uphold the law of the land and simultaneously pledge to disobey it.

DeFazio Fights Fees

Representative Peter DeFazio offered an amendment on Thursday, July 17, to the fiscal year 2004 Interior Appropriations Act to eliminate the controversial recreation fee demonstration program on public lands administered by the Forest Service, Fish and Wildlife and Bureau of Land Management. The provision kept the two-year extension of the fee demonstration program in tact for national parks. The amendment was defeated 241-184.

DeFazio said, "It's outrageous that the federal government charges taxpaying citizens a fee to take a hike on a forest trail or a walk on the beach. It's one thing to charge a modest fee for campgrounds or boat launches to pay for facilities and upkeep. But to charge a fee to park a car on the side of a logging road or at a trail head turns our public lands into the king's domain."

The General Accounting Office released a study in May that found the Forest Service spent fifty percent of all revenues collected in the fee demonstration program on administrative and collection costs.

Council Considers Rights Continued from Front Cover

Gordon Corbett said the commentaries the council had heard from the public had come from people wanting to defend our Constitution. He spoke of the danger that comes from wayward public servants. Corbett said we had voted for public servants, not masters and that the Bill of Rights was under attack.

No one spoke in opposition to the Bill of Rights Resolution.

The council then heard from city attorney John B. Trew on the legalities of the Resolution. Trew said he had not read the Patriot Act. He said the council had a right to pass Resolutions submitted by citizens. Trew's largest concern was that no city resources be expended on the Patriot Act. He cautioned the council about the Chief of Police ignoring a federal officer with a subpoena. Trew said his biggest issue with the Resolution was that it limited the activities of the police chief and librarian. (Note: the librarian is not a city employee).

Councilor Carl Eskelson said the Resolution didn't go far enough and that it should have included a commitment to support our government and troops overseas. Councilor Ed Beck said he had no trouble with a Resolution supporting our Constitution. He said he wanted to hear from Steve Abbott (in response to John Trew). Councilor Emily Francona said the councilors had sworn an oath to uphold the Constitution when they took office. She called the Resolution as "feel good measure." Francona said she wanted to seem more sentiment from a larger segment of the community. She said she had not heard from the silent majority and that the council should hear from the whole community. Francona concluded that she wanted to look at the issue some more and hear from others in the community.

Councilor Jim Auborn said he had heard from an awful lot of the community. He

said he would like to direct staff to come up with a Resolution more in accordance with the feelings of the whole community and present it at next month's council meeting. Auborn said the Resolution as presented was very sound with the exception of the last paragraph. Emily Francona said she applauded the Bill of Rights group and urged them to pursue the issue on a federal level. WillowSong Hall, publisher of the Port Orford News, asked the council how they wanted to hear from the public. A variety of ways are available from letters to the editor, emails and phone calls and personal contact.

The Bill of Rights Resolution will be taken up at the August 18, 2003 meeting. There seemed to be council consensus for voting on the Resolution with editing much of the last paragraph.

Auborn's recommendation is as follows:

Resolution in which the City of Port Orford defends the Bill of Rights and the Civil Liberties of its Residents.

The purpose of the resolution is to protect the civil rights and liberties of all people as express in the United States Constitution and ORS 181.575 and ORS 181.850, and to ensure that local law enforcement continues to preserve and protect these fundamental liberties.

Whereas, all members of the city council, City of Port Orford, have sworn to defend the United States and Oregon Constitutions, and;

Whereas, the City of Port Orford has been and remains committed to the protection of the rights and liberties of its residents as guaranteed by the United States and Oregon Constitutions and ORS 181.575 and 181.850.

Be It Resolved That the city administrator is instructed to direct the chief of police and all city officials to continue to work to preserve freedom of speech, religion, assembly, and privacy, as well as; those rights contained in the Bill of Rights of the United States Constitution and similar provisions of the Oregon Constitution.

The part that Auborn recommended be taken out of the Resolution reads as follows:

And to expend no city resources or funds for law enforcement activities not supported by the United States Constitution; Oregon Constitutional provisions, or Oregon Revised Statutes, which violate these freedoms. These "activities" include, but are not limited to: monitoring political or religious gatherings exercising free speech, obtaining library records, bookstore records or website activities, conducting covert investigation without prior court approval.
