# Chamber Goes Crazy By Evan Kramer



The Chamber of Commerce of Port Orford and North Curry County held their annual awards dinner at the Port Orford Senior Center on Monday night. Those in at-

tendance first dined on a choice of either Cornish game hen or steak catered by Bartlett's Café. The meal was served the First Community Church Bell Ringers.

Once dinner was over Chamber president Ronn Kerr began the presentation part of the dinner. He introduced Port Orford Mayor Gary Doran, a member of the America's Wild Rivers Coast (AWRC) consortium and Bill Schwartz another member of the consortium. Also in attendance was Reg Pullen from the Bureau of Land Management and Curry County Commissioner Marilyn Schafer. Pullen has been involved with the new developments at Floras Lake and Schafer has been a strong Chamber supporter. Kerr also introduced Jay Stoler who has designed the two new Chamber web sites and Paula Cracas who has written articles for those sites. Kerr called the sites "dynamic" with lots of advertising possibilities

Kerr thanked Grace Bonnell who put the dinner together and said she did a great job.

Kerr noted that one and a half years ago the Chamber had 35 members and as of Monday it has 85 members. His goal is 100 members by the end of the year. He said a year and a half ago the Chamber was broke and since then we've raised \$20,000 in grants and membership fees, much of which has been spent on advertising and promotion.

Kerr said the new Chamber brochures had just arrived and are being distributed. 30,000 were printed. Kerr said this was the first new Chamber brochure in 11 years.

Ronn Kerr thanked the Visitor Center volunteers and called out their names. Most were present for the dinner and accepted a plaque and a delightful gift basket from the Sixes River Peddler. The volunteers are Jim Auborn, Jeri Thurkow, Jo Rieber, Kay Neal, Millie North, Wayne Wesley, Mark Murray, Jim Billings, Donna Smith and Robert Speyer. Jeri Thurkow said the Chamber needed a sign pointing out where downtown Port Orford is located. She said visitors to the Visitor Center are constantly asking where "downtown" Port Orford is.

Kerr handed out two Chamber presidential awards. One went to Chuck and Cindy Schaumburg. Kerr noted they had spent a lot of time at county and state fairs promoting AWRC and Port Orford. Kerr handed out a presidential award to Kathleen Sandlin, the organizer of the Memorial Day WindFest. Kerr then presented a plaque to Mayor Doran on behalf of the AWRC consortium.

The next three award winners were determined by a vote of the Chamber membership. Kerr handed out a list of people and businesses that had received votes and it was a large list. The members voted for the Point Orford Heritage Society as organization of the year. Heritage Society president Rick Francona accepted the award. He expressed appreciation for the cooperation of other organizations in town.

Ronn Kerr then announced the volunteers of the year. They are Jon and Tobe Porter. Kerr acknowledged their activities in working to giving this town a first class library. Tobe Porter thanked the members of the Academy who voted for them providing the evening with some humor. Tobe Porter is the Port Orford Public Librarian and both her and Jon have worked tirelessly towards their goal of building a new library in Port Orford.

#### Letter to the Editor,

The City Council ducked its responsibility in the July 21 hearing on the Bill of Rights (BoR) Proposal which calls into question the constitutionality of the U.S.A. Patriot Act of 2001 (H.R. 3162). The Council seems inclined to water it down by removing the last paragraph. The BoR resolution is unremarkable except for that provision, which is the meat of the matter. It directs city officials "to expend no city resources or funds" on any activity deemed to violate the Federal or State Constitutions "without prior court approval."

The principal argument against this provision is that if a city official, such as the Chief of Police, were to comply with it, that act would amount to civil disobedience. That's the gist of a letter to this paper last week, which concludes that, "You cannot ask your elected officials to swear to uphold the law of the land and

simultaneously pledge to disobey it." That's also the gist of the City Attorney's comments, which conjured up the frightening prospect of the Council's receiving a call from a jailed Chief of Police. This is a straw man argument without legal support. Were Port Orford's police and other city officials to comply with the operative paragraph of the proposed BoR resolution they would not be disobeying any law.

Unlike the City Attorney at the July 21 meeting, I have read the USA Patriot Act. The whole thrust of the statute is to greatly expand federal powers. Nothing in the Act requires local jurisdictions to cooperate with federal law enforcement or expend resources in supporting federal actions. If the City of Port Orford elects not to cooperate with a federal agency that seeks to pursue its new powers under the Patriot Act, it is legally free to do so unless so ordered by a neutral magistrate. The specter of civil disobe-

dience is a fantasy trundled out to justify doing nothing.

If the BoR resolution is stripped of the only part that really matters, then it surely is, as one council member remarked, only a "feel good" measure. She's right and she knows what she's talking about, having been the principal organizer of a recent feel good event in which some of the "silent majority" she'd like to hear from now sat by the side of the road waving little flags and asking drivers to honk if they "support our troops."

As Edmund Burke, whose philosophical writings inspired much of our Constitution, said 250 years ago, "All that is necessary for the triumph of evil is for good men to do nothing." When the Bill of Rights measure comes again before the Port Orford City Council we will learn what kind of good people they are.

Congratulations to the authors and supporters of the Port Orford Bill of Rights Defense Committee on the resolution presented to the Port Orford City Council. Endorsement of this resolution by the City Council would be a small but very important step in repealing the ill conceived Patriot act, passed in the panic and paranoia in the aftermath of 9-11. This is, however, provided council members have the courage to endorse the resolution. Deleting the final paragraph of the resolution would amount to defeating the message it delivers.

History documents very clearly what John Adams, Ben Franklin, Thomas Jefferson, George Washington, and many other lesser known, but equally courageous individuals, would have thought about this. These framers of our Constitution put their lives and property on the line for individual freedom we enjoy that some among us today are so willing to give up. These founders of our nation also had to contend with citizenry among them who were perfectly comfortable being King George's subjects, and bowing to increasingly repressive British rule. This undoubtedly prompted Benjamin Fran-

klin's often quoted statement, "They that can give up essential liberty to obtain a little temporary safety deserve neither liberty or safety." Many of us are ashamed to fall into that category.

Americans are now, more than ever in our history, confined to our own country, unable to travel safely in much of the world. Is this due to our actions as citizens, or misguided policies of our government? A resolution such as proposed will be a small but important step in sending a message to our public servants, and demand government by the people, for the people, as intended by our Constitution. Many of us seem to forget the people in government answer to us.. We need not tolerate the government monitoring what we read, our religious affiliation, and who we communicate with. Legal mechanisms for this type of monitoring have been in place throughout our history. Monitoring suspected truly illegal activity has always been screened for necessity by properly elected or appointed officials when absolutely needed to insure individual rights are respected.

To change the wording of the resolution and eliminate the final paragraph is a cop

There were approximately 65 people in the city council audience on July 21, supporting the "Resolution In Which The City Of Port Orford Defends The Bill Of Rights And The Civil Liberties Of It's Residents". Why? It seems that the Patriot Act (282 pages) did more to eliminate civil rights than even the members of Congress were aware of such as, no more right to representation if you are arrested; eliminating the requirement that law enforcement representatives must have a warrant before entering your home; unlimited wire tapping made legal; allowing monitoring of people who are exercising free speech in political and religious gatherings; officials obtaining library records, bookstore records or website activities; and conducting covert investigations without prior court approval. All that and more, gone.

The City Council members listened carefully. Emily Francona stated that she would feel more comfortable making a decision after she had heard from the "Silent Majority".

I can understand Ms. Francona's hesitation. More resident input will be helpful.

aphids to something left behind by birds or the morning fog.

What is it that makes anyone of us assume that we know more concerning the law than anyone else? If we strip away all of our masks of professionalism and authority, we all "know", deep within each of us what the law is and is not.

I asked a lawyer once, what she had to study and know to become a lawyer. She responded, "court procedure". Now court procedure might be a form of etiquette, but it has nothing to do with the law itself.

The Bill of Rights are, limitations set upon the elected and appointed officials, the lesser power in the social contract, by the people (and state), which is the greater power in the social contract. All of the amendments since have served to construe the intent of the original ten, and to lead us to believe those rights to be

merely privilege or favor granted us by our government. The amendments taking power away from the people and states, and giving more power to the central government, prohibiting consumption of alcohol and bestowing immaculate conception and life upon the corporation so that it, wields far more right than the individual or the state is no law, it is an imposition, and an imposter of law, a forgery and a lie. Therefore the people by the power of our contract are obliged, to resist these usurpations with any and all means they possess in their power to do. To do otherwise would be negligent and folly. Common law is primary to civil or legislative law, the law of the land.



#### Port Orford Receives Millions

Senators Gordon Smith and Ron Wyden on Friday, July 25, announced that the

City of Port Orford will receive over \$3 million to modify water and waste disposal from the U.S. Department of Agriculture. The aid will be awarded in the form of a \$1,000,000 grant and a \$2.542,000 low-interest loan.

"These improvements provide a modified, more superior water management system to Port Orford," said Smith. "Oregonians benefit collectively when cleaner more effective waste management is implemented in our towns and cities."

"This community demonstrated a compelling need to improve their water and waste disposal system," said Wyden. "Funding for infrastructure improvements can only benefit the livability of Port Orford."

The USDA approved the rural development aid to be used to modify and add to the existing outfall, including an ocean discharge, new effluent pumps, and abandonment of existing wastewater filters.

The USDA approved the federal loan to be paid back at 4.25 percent over the next 40 years.
