## **Highway 101 Projects**

The Chamber of Commerce of Port Orford and North Curry County hosted Ray Cranston at their Monday, October 27 meeting. Cranston is a project manager

for the Oregon Department of Transportation (ODOT) and works in the Coquille office. His district covers the area of Highway 101 between North Bend and the California border.

Ray Cranston works in the engineering office in Coquille. He began his talk by discussing the ongoing projects on Highway 101 starting in the Coos Bay area and moving south. He talked about the Haines Inlet Sough bridge replacement project, which is nearing completion. He said ODOT's main investment along the South Coast the past ten years has been replacing or repairing bridges. South of Coos Bay Highway 101 is being realigned in the Millington area because of the high accident rate. Cranston said the north and south sides of 101 in the Millington area had been built at different times.

South of Bandon at Bethel Creek, ODOT replaced two culverts with the Bethel

Creek Bridge. Cranston said ODOT was looking at all culverts that are an obstacle to fish passage. South of Port Orford at milepost 315 contractors are working on the new Frankport viaduct. This \$5 million project will be the longest single span bridge in Oregon when it is complete at 300 feet long. Cranston said the new bridge would sit on rubber bearing devices and in effect "float" during an earthquake. ODOT reminds drivers that the speed limit through the construction detour at this bridge project is 30 miles per hour.

Cranston spoke about the \$18 million dollar repair job on the Patterson Memorial Bridge over the Rogue River in Gold Beach. Cranston said, "Oregon is blessed with historic bridges." The contractor on this project is applying cathodic protection to the bridge and is spending \$2 million to repair the footings of the bridge in a controlled environment. Cranston said they would preserve the steel in the bridge forever with a zinc coating. There is \$300,000 available for decorative lighting of the arches of the bridge but this not an ODOT project.

ODOT is involved in a project on the Chetco River Bridge in Brookings. Tide-water Contractors is constructing sidewalks on the bridge and ramps at the

south end. Lights are being added to the bridge.

Cranston then spoke about upcoming ODOT projects on Highway 101 including applying cathodic protection to the McCullough Bridge in North Bend and a bridge replacement at Isthmus Slough.

Future plans for Bandon include widening Highway 101 from Thirteenth Street to Billy Smoothboars where the 45-mile per hour speed limit ends. This ODOT project includes a continuous left turn lane and sidewalks making the area a lot safer to drive and walk in.

The City of Gold Beach will see Highway 101 repaved through town in 2005. Next year the part of Highway 101 from the Thomas Creek Bridge to Brookings will get an overlay. Downtown Brookings will get new sidewalks and new pavement.

Cranston was asked about the lack of signage for Port Orford on state highway signs both north and south of the City. They were told to speak to ODOT manager Jerry Gregory who is the superintendent at the Twelfth Street ODOT maintenance yard in Port Orford. Another question concerned whether ODOT had any plans for any more passing lanes or four lane sections of Highway 101

Recently my daughter watched our house and cared for our dogs while we were gone. This eulogy for her beloved animal companion was found on our computer. It touched me and I wanted to share it with other animal lovers. - Nella Abbott

My Red dog died peacefully at home Friday night while Arch held her. A very nice woman veterinarian came to the house to administer the drugs that would initially sedate her, then finally stop her heart. In true Red fashion, she went without any unnecessary drama and without too much trouble to anyone. It was her time, and Arch said she slipped away easily. I am heartbroken. Even though I know in my heart that she was ready to go, saying goodbye to her was the hardest thing I've ever done. Red came to me when I was 27 or 28, she was 6 months old. She was with me through my late twenties, the entirety of my thirties

and these four years of my forties. She was around through five boyfriends, two careers, three automobiles, at least a hundred pounds gained, lost and regained, numerous residential moves and the development from toddler to teenager of my nieces and nephew, now 6, 14, and 17. Red and I sat together trembling, under a doorjamb during the 1989 Loma Prieta earthquake. We spent a thousand days stalking and chasing seagulls and sandpipers along Stinson Beach, where anyone who had the pleasure of seeing her run would swear they had witness poetry in motion. We were both cocky little hard-bodies back then, but inevitably bodies change. Red's legs became somewhat spindly and she couldn't run so well anymore. Her face grew long and thin and she turned a little gray. (Me too, except for the spindly legs). And after a while she couldn't walk so well either.

While I was growing up, she was growing old. Red was the best friend I've ever

had and she loved me more than any being on this planet ever will. I will miss her terribly, but there is comfort in knowing that her lovely spirit has been set free to once again to run and bark and frolic and chase. Being here in Oregon with four other dogs under my charge, will be a good place for me to begin my healing. And even as I mourn her loss, I will celebrate the long and wonderful life of my dog Red, a beautiful and gentle companion.

## **Planning Commission Meets**

The Curry County Planning Commission will meet on Thursday, November 6, at 7:00pm in the Courthouse Annex building in Gold Beach to consider a proposal to site 3 meteorological towers on ranches west of Langlois. The study towers would be used to determine the feasibility of siting a large wind farm (60 to 100 turbines) west of Langlois in the future. The commission heard testimony about the proposal last month at a packed hearing and delayed the decision so it could properly consider the information presented.

Although the pending decision is about the 3 study towers only and not about the wind farm, local citizens in the Langlois and Floras Lake area are concerned that the study towers are direct precursors to development of a large wind farm. At last month's hearing, they raised concerns about reduced property values, the negative visual impacts of tall towers and electrical transmission lines in their scenic, rural community, noise from construction of towers and from the ongoing spinning of wind turbines. The Kalmiopsis Audubon Society raised concerns about migratory birds using the adjacent New River area. The developer says the wind farm will provide economic benefits to the county.

The planning commissioners are expected to make a decision at the upcoming meeting.



### Letter to the Editor,

The Rest of the Story: Coos Curry Electric had a most interesting non-productive meeting October 24, 2003. Board members are either just sitting there or putting obstacles in the way preventing any updating or organizational improvements. Our newest Board member, Thomas, said that there were many items on the list that needed work and perhaps the Board could work on those projects by working the entire day at their monthly meetings. Terry Hanscam stated, "Well, you know that I am not retired and I have a business to run. I have 4 or 5 projects that I have going so I can't just take a whole day off." Wanda Kasper spoke up and said that she is not retired either. No other Board member spoke up. And nothing was planned, as usual.

Now the interesting thing is that Coos Curry Electric Board Members are allowed "compensation" according to the

By-laws and ORS Statutes. The compensation amount is determined by the Board Members themselves. This is just a portion of the compensation packet that Terry and Wanda get: \$350 for each monthly meeting + \$850 Family Health Insurance monthly = \$1200 minimum monthly compensation. Now multiplying that by 12 months = \$14,400 per year each. For how much time? Let's be gracious and offer 4 hours (1/2 day) per meeting per month times 12 months = 6 days per year. 6 days for \$14,400 each. And you don't have the time????

What happened with Dale Thomas' suggestion to get outside an evaluation of

the cooperative? Jim Arntz said that he hadn't had the time since October's meeting to contact any outside evaluators. . . No time to contact someone who might come up with suggestions as to how to improve the management and organization and financial areas of our cooperative. And the Board sat there and said nothing.

Arntz doesn't have time to do the job, Hanscam and Kasper don't have time to do the job. And the rest of the Board?? Well, Vern Kolan took my picture. Does that count?



### Counties Payments Extended

The U.S. House of Representatives on October 28 unanimously approved legislation (HR 3249) introduced by Congressman Peter DeFazio and Greg Walden to reauthorize the Forest Counties Payments Committee, which was authorized by Congress in 2000. The committee was established to evaluate the impact of reduced timber receipts on communities located near federal lands and submit recommendations to Congress for compensating communities for diminished timber-related revenues.

The Walden-DeFazio legislation would extend the committee until September 30, 2007, when the Secure Rural Schools and Community Self-Determination Act of 2000 (County Payments Act) is set to expire. This legislation was passed by Congress to provide revenue for schools and roads to communities located near federal lands. The reauthorization of the

Committee is necessary to oversee the continued implementation of the County Schools Act.

The U.S. Senate must now approve HR 3249 before being sent to the President for his consideration.

Curry County Commissioner Lucie LaBonte provided some information about the amount of money the federal government would give the county in fiscal year 2003-2004. The county will receive \$3,441,200.62 in Title I funds to be used for the county general fund. The county will also receive \$364,362.42 in Title III funds for special projects that benefit the federal lands; search and rescue, emergency response, education projects, and planning. These funds are also known as O & C funds for the Oregon and California Railroad. The county tax base this fiscal year is \$1,091,723.47. The general fund balance this year is \$7,611.776. Some of the

general fund departments are the commissioner's office, county clerk and election's department, county sheriff and county corrections.


### EMT Basic Class By Evan Kramer

The fighting in World War I came to an end on November 11, 1918 at 11:00am. November 11 then became known as Armistice Day. It officially became Armistice Day in America in 1926 by a Congressional Resolution. It became a national holiday in 1938.

After the Korean War came to an end Congress decided to honor veterans of all wars and passed a bill a bill making Armistice Day into Veteran's Day. President Dwight Eisenhower signed a bill proclaiming November 11 as Veteran's Day in 1954.

liquor. OLCC regulates the hours liquor stores can be open, the holidays it must be closed on, and the prices it charges for liquor. OLCC regulates what can be sold other than liquor in the stores. Bars and restaurants serving hard liquor have to buy it through state owned liquor stores.

Cuatt said that no matter what, there will be a liquor store in Port Orford on November 14. OLCC has been contacting several businesses in Port Orford looking to contract with them to take over the liquor store business.

The City of Port Orford will receive approximately \$10,000 from the OLCC this fiscal year as part of their share of the

state liquor tax. Port Orford's liquor payment is based on the City's population, not the amount of alcohol sold.



Cranston also recommended people speak to Port Orford Mayor Gary Doran about projects like a left turn lane at Paradise Point Road and Highway 101. Doran is a member of the Southwest Transportation Commission. Cranston said people should prioritize their projects and then present them to him.
