Digital Safety

As the old joke says, "Pioneers are the ones with the arrows in their backs." Well, we're ALL pioneers on the Internet. It's hard to believe but the first ever World Wide Web page was only created in 1990. By 1993 there were still only 200 web servers (computers providing web pages) worldwide. Since then, of course, the Internet has practically exploded (about 37,000,000 servers two years ago. That was the most up-to-date number I could find.) until now it seems hard to live without. The downside of this is that there are a lot of problems that haven't been solved yet. We have spam, viruses, worms, spyware and other threats. If you don't keep up-to-date on these issues, you are not only at risk, but YOU become part of the problem because your computer may be taken over and used to attack others.

How much at risk are you? Infoworld Magazine reported last week the results of a "honeypot" test. Researchers connected a clean Windows XP computer to the Internet without a firewall and watched to see what happened. After it was compromised, they would clean it up and repeat the test, over and over. Note that the computer was just sitting there... It wasn't running email or browsing a web site. It was merely connected to the Internet. Many people think that it would take months for someone to find them. In fact, the average time for the machine to be compromised was three hours. The shortest time was 20 minutes! Other similar tests have reported times until compromise of as little as 15 minutes. How can they work this fast? Once a computer is compromised, it can be programmed to do whatever is desired. Generally it is set to scan the Internet for other vulnerable computers and then compromise them. Researchers have found networks of over 140,000 com-


promised computers set up to act as such a zombie army! At some point the person in charge may change the programming and throw his (or her) "army" at some selected site in an attempt to overwhelm it. Thus, unprotected computers are almost as big of a problem as the person initiating these attacks. In some ways, they are a bigger problem - if the perp couldn't take over other people's computers, s/he couldn't do very much damage. When such a person has tens of thousands of computers behind them, they become a force to reckon with.

For now, all you can do is to make sure your computer or computers aren't part of the problem. This requires several important steps:

1) Use the Windows Update site regularly to apply any available critical updates. Look for the "Windows Update" item on the Start Menu (older versions of Win-

dows) or Start Menu / All Programs (Windows XP). You should run this check at least once a week though Microsoft usually posts updates on the second Tuesday of each month. It doesn't take long to check when there are no updates and if one is important enough to be posted at a different time, it's probably one you don't want to miss.

2) Use a good anti-virus program and update it's definitions at least once a week. How you do that will depend on which program you choose to use.

3) If you are have high-speed Internet, be sure to use a router. It will provide NAT and have other firewall features that block most intrusion attempts before they ever see your computer.

4) If you are a dial-up Internet user (or for added security on a high-speed link) use a software firewall such as Norton Internet Security or Zone Alarm. As with antivirus software, you need to check for updates at least once a week. I like the Norton Internet Security 2003 package

which combines anti-virus software and a firewall into one package.

Note: Either step 3 and/or 4 is now as important, if not more so, than using a good anti-virus program but is often overlooked by computer users. Firewalls block worms. Anti-virus software does not.

5) Keep yourself knowledgeable about security. There are some 69,000+ mail lists on all sorts of subjects cataloged at www.lsoft.com/lists/listref.html and most computer magazines, software companies, etc. also offer their own. Subscribe to at least a couple of them that cover current computer events. You may also wish to subscribe to one or more computer magazines in that old fashioned printed form too. I like www.winxpnews.com, www.w2knews.com, www.cnet.com, www.wired.com, and www.infoworld.com/news but there are many others that are as good or better.

Lee, Johnson Plead Guilty

Long N. Lee, 52, a U.S. State Department Foreign Service Officer and career State Department employee, and her husband Acey R. Johnson, 33, who was until recently a Consular Associate employed in the consular section of the U.S. Embassy in Sri Lanka, pleaded guilty in U.S. District Court in Sacramento to one count each of conspiring to defraud the United States, to accept bribes, and to commit visa fraud; to one count of defrauding the United States of a duty of honest services; and to one count of receiving bribes. Defendants Lee and Johnson, who agree to cooperate with the Government's in-

vestigation, were the sixth and seventh defendants to plead guilty in the case. Pursuant to their plea agreements, they each face a minimum of at least five years in prison, a three-year term of supervised release, and a substantial fine. They also agreed to forfeit to the United States two homes, one located in Oregon and one in Colorado, and approximately \$361,766, including funds seized from bank accounts in Oregon, Virginia, Washington, and California, and nearly \$90,000 in cash recovered from their home in Oregon and from the pillows of a love seat they owned in Sri Lanka. Sentencing is scheduled for July 16, 2004.

Defendants Lee and Johnson admitted in their plea agreement that Lee had agreed to arrange for issuance of U.S. visas in exchange for bribes as early as 1995. From that period through early 2003, Lee and Johnson accepted hundreds of thousands of dollars in bribe payments from "visa brokers", and issued visas to scores of foreign nationals, primarily from India and Vietnam.

Johnson briefly lived in Port Orford where he and Lee owned a home and both of them were planning on opening the Lemon Grass Restaurant in Port Orford at the time of their arrests.

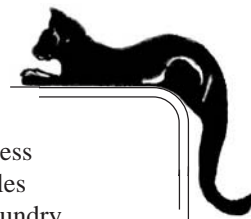

Letter to the Editor,

Your review (April 29) of "Amazing Thailand" states, "The film pointed out that Thailand did not become involved in the Vietnam-Southeast Asia war of the 60's and early 70's nor was it involved in World War II."

That will come as a big surprise to the almost 400,000 US Air Force veterans who were stationed in Thailand at one time or another between 1961 and 1975. The vast majority of American air and special operations in North Vietnam, Laos and Cambodia were conducted from seven Thai air bases. I can personally attest to that, having flown numerous

combat missions over Vietnam, Laos and Cambodia from Ubon Royal Thai Air Force Base and Nakhon Phanom RTAFB. The best book on this chapter in US-Thai relations is probably *The Secret Vietnam War: The United States Air Force in Thailand, 1961-1975*, by Jeffrey D. Glasser (see www.secretvietnamwar.com/).

The Royal Thai Air Force sent a squadron to Vietnam as early as 1964 (see the RTAF's own web site at www.rtaf.mi.th/eng/history/history11.html#4). In addition, a Thai army reinforced brigade (almost 12,000 men) fought in South Vietnam as early as 1966 (see the official US Army web site for more on the Thai

brigade at www.army.mil/cmh-pg/books/Vietnam/allied/ch02.htm).

As for World War II, Thailand fought the Japanese for one day, then ceded the Japanese army transit through the country to attack Burma and Malaya. The Thai government was forced to declare war on the United States and Great Britain in early 1942. The American Office of Strategic Services (OSS) started what became a resistance movement of 50,000 Thais (see the US Library of Congress Thailand Country Study at countrystudy.us/thailand/21.htm). There was a great movie made of the true story of British prisoners of war building "The Bridge on the River Kwai," part of the "death railway" in Japanese-occupied Thailand.

We who served there will always have a special place in our hearts for Thailand and the Thais.

Letter to the Editor,

More than 51 million people, or one in six U.S. residents, live in the now 300 cities and counties and four states (Alaska, Hawaii, Maine, and Vermont) that have passed resolutions or ordinances which denounce parts of the U.S.A. PATRIOT Act. Fifteen of the communities are among the country's 25 most populous cities. They include New York City and Washington, D.C., which were the sites of the September 11th attacks. Hundreds more communities and states are considering resolutions. Last December, the National League of Cities approved a resolution calling for amending the Patriot Act.

The continuing growth of the nonpartisan grassroots movement challenges the Bush Administration's assertion that Americans overwhelmingly approve of the Patriot Act. "That approval lasts until people open the cover and see for themselves that we're all potentially under surveillance without probable cause," according to Nancy Talanian, director of the national Bill of Rights Defense Committee.

Criminal justice experts agree. Last week, Thomson Wadsworth released the results of its survey of criminal justice experts, which shows widespread disapproval of the Patriot Act. Ninety-five percent of respondents felt that "the USA Patriot Act was passed too quickly and/or without adequate analysis on its im-

pact on other laws and public policy." Seventy-four percent believed that some of the act's provisions "violate individual rights." Sixty-eight percent felt that the government could "use existing/regular laws instead to protect the nation from terrorism."

Talanian observes that it isn't only the Patriot Act that has people concerned, but other measures and policies carried out since September 11: "Americans become skeptical when they see people being held solely on the Administration's say-so, without any judicial oversight by U.S. or international courts." She cites as examples the roundups and detentions of Arab, Muslim, and South Asian men after September 11, and the continued detentions of 'enemy combatants'—including two U.S. citizens—without charges. "If the objective of these measures is to protect us from terrorism, then policies that deny people due pro-

cess or humane treatment may have the opposite effect."

Talanian notes that people are crossing party lines in communities and in Congress to debate the Patriot Act and other measures, and to call for changes. Many candidates for public office, including the president, have been stating their positions on the Patriot Act on the campaign trail. Talanian believes that the grassroots movement will play a role in helping people make informed choices in this election year. "President Bush has warned the American people that the so-called war on terrorism could last for decades. That is a very long time to live without fundamental rights."

Please vote yes on measure 08-41 so that Port Orford residents will join those who are standing up for our rights.

Port Orford Fish Story By Evan Kramer

You never know what's going to wash ashore at Dock Beach in Port Orford. A couple of weeks ago it was a custom built tri-hulled sailboat that ran aground. On Tuesday morning it was a longnose lancetfish (*Alepisaurus borealis*). Hallmark Fisheries manager Tony Cotter rescued the breached fish, which he discovered at water's edge. The fish was taken to the Norcal space in the cannery building and put in the big live fish tank. Norcal employee Scott Spencer was busy keeping an eye on the fish in addition to his other duties.

The longnose lancetfish is normally found in deep waters but lives anywhere from the surface to one mile down and can grow up to seven feet long and weigh 35 pounds. This one was about half that size. It is a hermaphroditic fish with an impressive set of fangs – this is not a fish

you want to handle with your bare hands. Tony Cotter said this was the first live longnose lancetfish he had seen. Plans are to put the fish back in the ocean once it recovers from having been out of water.

Other things happening at the never dull Port of Port Orford include live Maine lobsters for sale. Jim and Jon Seafoods are selling fresh fish on the dock on Tuesdays and Thursday and this Tuesday had several tempting live Maine lobsters for sale at \$8 a pound. They are located at the end of the dock adjacent to Hallmark Fisheries.

The Port Commission and budget committee held their first meeting on Tuesday night, May 4. A representative from Congressman Peter DeFazio's office will be at the dock later this week at low tide to view the sanding in situation at the dock and discuss dredging with Port manager Gary Anderson and Port com-

missioners. Editorial opinion: Dredging our Port is the number one issue facing the Port of Port Orford. The clamshell dredge is not scheduled to make a return visit to Port Orford this summer because it isn't budgeted. Instead the Port will get the winter hoist contract dredging in summer and that isn't going to be enough to keep the Port open this coming winter. That is why the Port has sent letters to our elected representatives apprising them of the situation and asking for help.

Komen Breast Cancer Foundation, Oregon & SW Washington Affiliate.

Also through May, Curry General Hospital is offering a gift incentive for all those who receive mammograms. Patients can choose certificates, ranging from \$3 to \$10, for items from Bree's upscale resale — a women's clothing store located in Coos County and soon to open in Harbor. Founded in 1994, Curry General Hospital's Breast Health Network works to reduce the mortality of Curry County women from breast cancer through protection and education. So far, the best protection is early detection. All women over 40 are urged to keep up a yearly program of mammography and clinical breast exam, with monthly breast self exams.
