Juston Potter Retires

The Port Orford-Langlois 2CJ School District Board met on Tuesday, May 11, and heard from a man who has given much to this school district, Juston Potter. He is retiring at the end

of June and gave the board a three-page report on the state of things. He is the Transportation Supervisor for the School District.

He spoke to the board and told them this was his last meeting as the bus/transportation supervisor. He talked about the new bus on order from International and that the district currently has 14 school buses. He said he believes the transportation system is in the best shape it had ever been in. He recommended the district build another bus shelter so the entire fleet could be housed inside shelters.

Potter has worked for the District for 23 years and managed the transportation department for 20 years. During this time there have been two bus accidents, neither of which was the fault of the district. He spoke of the bus fleet and the way it is maintained as a billboard for the

district. He gave some examples of the quality and care our buses are given and the notice they have received from people outside the district. He praised the quality of the school bus drivers and pointed out how long many of them had been with the district.

Potter plans on being a substitute bus driver after he retires. He received a heartfelt round of applause from a very appreciative school board and public at the end of his report. Later on in the meeting after most of us had gone home the board met in executive session followed by regular session and hired Tony LaPlante as the new Transportation Supervisor.

During the public forum part of the meeting former board member John Jensen said that it had been great to work with Superintendent Phil Sword who is retiring next month.

Under new business the board heard a presentation from Port Orford News publisher WillowSong Hall. She gave them a letter of appreciation and thanks for the school board's support for the **Newspapers in Education Program**. The Port Orford News participated in the program this school year. The Port Orford-Langlois 2CJ School District was one of 12 in Oregon, which offered this program of

free newspapers to students. The Halls distributed 4,794 copies of the Port Orford News to 13 classrooms in the Blanco, Driftwood and Pacific High Schools. The paper has encouraged and printed many letters in their paper from students in the district.

Following that item on the agenda board president Virginia Hughes said that the board had a request to address the issue of the newspaper (Port Orford News). What she was referring to was a request by a parent of children in the district – Tina Merryman, requesting of superintendent Phil Sword, that the school board “address the issue of allowing the Port Orford News paper into classrooms in our district.” Merryman requested in her letter that the board keep the Port Orford News out of the classrooms because of writer Scott Thiemann’s columns entitled “Out - in the Country” which Merryman described as “one man’s self discovery of his homosexuality.”

There was no board discussion. The issue was turned over to Phil Sword who will form a committee to come up with a recommendation on the Tina Merryman’s request, which will be presented at the June school board meeting. Sword later said that the committee would consist of

**Arizona Street Reopened

One of the better pieces of news at the Port Orford City Council meeting on Monday night was that Arizona Street had been reopened between Madrona and Geer Circle. Public Works superintendent Dave Pace said that section of road was open but vehicles with a gross vehicle weight of over 10,000 pounds are not allowed on it. All council members were present. Council member Carl Eskelson and City Recorder Beverly Manes had been ill and unable to attend April's meeting. It was good to see them both back.

The council heard from Kelly Dunbar who was appealing the decision by the city administrator to make him pay the new water and sewer system development charges for the house he plans to build. Dunbar started preliminary work on it last October. This decision will add \$3,000 to the cost of building his house

but the council took no action and let stand the action of the city administrator.

Caroline Clancy spoke to the council about the upcoming increase in the base sewer rate and asked if there would be an increase in the sewer commodity rate. City administrator Ken Knight told her it wouldn't happen this upcoming 2004-05 fiscal year. Clancy asked the council to do what's best for the people of Port Orford. Councilor Jim Auburn told the council and audience that Port Orford is not alone in these rate increases and they are hitting other towns.


Cindy Myers from the South Coast/Lower Rogue Watershed Councils gave a PowerPoint presentation on recommendations by the Port Orford Watershed Council for how to deal with the 140-acre conservation easement on the North Fork of Hubbard Creek (Sorenson property). Recommendations include restricting access by motorized vehicles at all times, installing a new forest land gate

with lock protection, posting a sign at the western access explaining the need to restrict access for the protection of the city water supply, and establishing a backbone road system for firefighting access. Other recommendations include gorse removal and efforts to control erosion.

Jim Auburn made a motion to accept the recommendation of the watershed council for administering the 140-acre conservation easement and it passed unanimously. Cost to the city for their share of the matching grant will be minimal and some of it will include in-kind labor.


Councilor Auburn made a motion to approve the Garrison Lake Partnership as specified in the council packet and it passed 6-0. The agreement establishes a partnership between Oregon State Parks, Curry County and the City of Port Orford to "cooperatively address problems and solutions related to Garrison Lake." The

largest commitment to resolving the situation caused by the Garrison Lake outlet being washed away is assumed by Oregon State Parks. They will handle the engineering and design of both short term and long term measures to maintain a lake outlet.

Councilor Auburn made a motion to accept Ordinance 2004-03, which repeals the exemption, granted to recreational vehicle parks on collecting the transient lodging tax and it passed 6-0.

Ken Knight told the council he needs the council to forward their priorities to him by June 15 for the City's Needs and Issues list. This list isn't a waste of time by any means as two of the City's previous Needs and Issues – the upgrade to the sewer treatment plant and the Inflow and Infiltration study and work have been funded.

Jim Auburn, parks commission liaison, said the visitor center was short on volunteers. He said if people were interested in serving 2-4 hour shifts at the visitor center they could contact Patty Clark at the city, 332-3681.

Steve Donovan, SHN project engineer for the sewer outfall and treatment plant upgrades, gave the council an update on Phase 2 (sewer treatment plant upgrades) of the effluent disposal project. He told them the Phase 2 project has been put out to bid with the bid opening scheduled for June 2. SHN and the City held a pre-bid meeting on May 14.

Change order #4 for Phase 1 had been sent to James Fowler Construction after last month's council meeting. The company didn't get back to SHN until Monday, May 17 with their response. Jim Auburn asked Donovan if the City was still paying stand by fees for the barge (we are) and said he was disappointed by Fowler. Auburn said he would like the change order effective by June. The stand by fees for the barge are costing the city \$180 a day for total of \$5,400 for a 30 day month and we get nothing in return. Councilor Ed Beck said he was really irritated by the situation. The council passed a motion that the city administrator and mayor can approve Change Order #4 as well as negotiate Change Order #4 with the contractor.

Let's backtrack to the April council meeting where the council passed a motion

for staff to negotiate Change Order #4 with the contractor. This change order includes holding off on placing of the concrete mats on the diffuser pipe with the city taking possession of them until later disposition. This would release the barge and divers and eliminate the stand by fees. No wonder the council was annoyed.

Kucinich Packs Them In

Democratic party candidate for President Dennis Kucinich spoke at two events in the south coast last Friday starting with a public appearance at the Chetco Public Library in Brookings during the day. Kucinich, a Congressman from the west side of Cleveland, concluded his four-stop tour of southern Oregon that day by speaking to a standing room only crowd at the Barn in City Park in Bandon.

Despite John Kerry having more than enough delegate votes to win the Democratic nomination for President Dennis Kucinich plunged into Oregon with his messages. He has focused the last month on a good showing in Oregon, which he can take with him to the Democratic party platform committee.

Kucinich followed up his remark that 50% of the federal discretionary funding goes to the military budget by saying in July of 2001 he had introduced legislation in Congress to create a Department of Peace. He spoke of making war archaic and creating harmony in the world. Kucinich said it was time for America to rejoin the world.

Kucinich said he led the efforts in the House of Representatives against the Administration's war in Iraq. He said what began as a group of 5 representatives grew to 126 Democratic members of the House who voted against the war.

Kucinich spoke of his plans for Iraq which include turning over Iraqi oil assets to the UN for now; he said we must stop liquidating the private assets of Iraq; get UN help with Iraq elections and a constitution including holding free and fair elections; and pay to rebuild the parts of Iraq we destroyed.

Kucinich urged the creation of a new WPA (Works Progress Administration) to create jobs including the rebuilding of America. He advocated turning towards sustainable energy sources like wind and solar as a way of creating more jobs.

Kucinich introduced legislation in Congress for a universal single payer not for profit health care system. He said Americans spend \$1.6 trillion on health care services. He said of that one out of every four dollars goes to overhead (executives salary's, etc.) in the for profit system we have today. He said 15-30% of current medical spending by companies is on paperwork as compared to Medicare, which is 3%. Kucinich called the health care situation in American the biggest disconnect in Washington D.C. He spoke of the power of change and that change comes from the bottom. He talked

about the power of our hearts to challenge the fear and let hope begin.

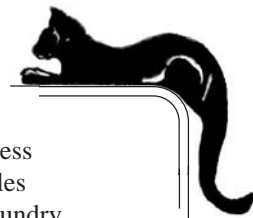

Sole Pursuits Trek

Brian McNulty, Oregon Coast Trail advocate, will lead Curry General Hospital's next Sole Pursuits hike beginning at 8:30 a.m., Sunday, June 6. McNulty has led coastal hikes for the hospital and Gold Beach Visitor Center for more than 12 years.

McNulty will lead hikers across the Thomas Creek Bridge to North Islands Viewpoint through fields of Indian paintbrush and iris "in glorious bloom." He will lead the group to an ocean cliff where—if the morning is clear—"hikers will be able to view the curvature of the earth from Cape Blanco to the Crescent City lighthouse," he says, adding that caution is advised

The hike will continue through the spruce forest to the spectacular beach at China Creek. "If we're lucky, we might see wild goats or the Canada geese that travel through the area." The hike totals about 4 1/2 miles round-trip with a moderate climb through the wild lupine. Hikers should note, however that there is an especially steep section at the end.

Carpoolers can meet at 8 a.m., at either The Brookings Clinic in Brookings, or the Curry General Hospital Annex in Gold Beach. Others can meet at the Thomas Creek Bridge, southwest parking area, by 8:30 a.m. Walkers should dress for the weather and wear sturdy shoes. Organizers suggest that participants bring

a buddy to accompany them back to the trailhead if they wish to return early.

Sole Pursuits is Curry General Hospital's incentive walking and fitness program. It features scenic hikes and quarterly prize drawings for walkers who turn in their walking cards. Cards are available free from The Brookings Clinic and Curry General Hospital. "The more you walk, the more you win." This free informational event is co-sponsored by the Curry County Board of Commissioners and the Southwest Oregon Resource Conservation & Development Council.

The purpose of this meeting is to enable South Coast residents and business owners to learn more about alternative energy sources and technologies, especially wind energy, so they can better understand and evaluate what may be useful here in the future. This will be an informational meeting, not intended to solicit public input nor to debate or make decisions about any specific projects currently being planned. This event is designed

Hospice Opportunities

Citizens throughout Curry County have an opportunity to contribute their talents to Hospice and Home Health.

Lori Kent, RN, Director of Curry County Home Health and Hospice, announces that spots are available on both the Home Health and Hospice Advisory Boards. Each of these groups have distinct roles within the context of the programs, and provide significant advisory and oversight services to the programs as well as to the Board of Commissioners.

The Hospice Advisory Board, also known as HAB consists of 8 to 12 members. It meets every month, and is a “working board”, i.e. members tend to provide other volunteer support to Hospice in areas such as consultation, patient care, fundraising etc., depending on the level of expertise, interest and availability.

The role of the HAB is to be the professional policy making committee. Members should include a wide range of professional and lay persons from throughout the county. It is helpful to have skills, knowledge, and/or interest in any of a variety of areas. For a well-rounded board, additional members might include financial background, real estate, business, consumers, or any variety of experiences. However, the primary interest must be provision of quality services, and an interest in end of life care. A strong advisory board is critical to the ongoing success of the programs.

There is one vacancy for a consumer position on the Home Health Advisory Board (PAB). The applicant may live anywhere within the county. The PAB meets quarterly and focuses primarily on program policy and quality assurance oversight.

DeFazio Questions Resources

In a House Forest and Forest Health Subcommittee hearing on May 13, US Representative Peter DeFazio called on Undersecretary Mark Rey and the Bush administration to take immediate steps to fortify firefighting resources now that we have already started what is predicted to be potentially the worst fire season in western history.

“We’ve been starving forest firefighting resources for years,” said DeFazio. “And now, at the very start of the wildfire season, the Forest Service is already reporting that they may need to start borrowing funding, they can give no assurances that we will have adequate ground crews and the entire tanker fleet has been grounded. Yet no emergency steps have been taken by the administration to strengthen firefighting resources even to minimum levels.”

“What are we waiting for?” questioned DeFazio. “We’re already 35 points behind and the game just barely started. You’re setting the Forest Service up to fail this fire season.”

“I recommend the administration take immediate emergency measures or we could face loss of life and catastrophic loss of resources and property in short order,” DeFazio said.

DeFazio has taken a leave of absence from the Resources Committee this Congress, to serve on the House Select Committee on Homeland Security, but he participated in Thursday’s proceedings at the invitation of Chairman Walden. DeFazio, a senior member of Congress and leader on forestry issues, has served on the House Resource Committee for 19 years.

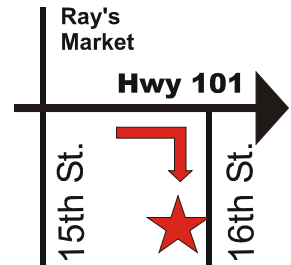

High Gas Prices

One a day when the average price for a gallon of regular unleaded gas reached \$2.33 in Oregon, one of the highest rates in the nation, US Representative Peter DeFazio joined Democratic National Committee Chairman Terry McCauliffe to call on President Bush to act immediately to bring down the exorbitant gas prices in the U.S.

“As a candidate in 2000, George Bush promised he would ‘jawbone’ the oil industry to get relief from high gas prices,” said DeFazio. “I guess he was kidding. How high do the prices need to go before the President, who has flaunted his close family ties with the Saudi Monarchy and the Texas-based oil industry, takes action? These gas prices are killing any progress made to the struggling Oregon economy. Families in Oregon are now paying over \$1400 more a year for gasoline than they did when the President took office. With prices well over

\$2 a gallon, Oregonians are being forced to cancel their family vacations.”

In March, DeFazio sent a letter with 32 House members asking President Bush to file a case with the WTO against OPEC for restricting production and colluding to raise oil prices. DeFazio has also introduced HR 1221, the “Gasoline Price Stabilization Act,” to allow the President to stabilize oil and gas prices by: imposing price caps; tapping the strategic petroleum reserve (a Federal reserve for 700 million barrels of oil a day); requiring minimum inventory levels of oil to smooth out supply distributions, and reinstating the ban on exporting oil from Alaska to Asia.
