Police Chief Interviews By Evan Kramer



The Port Orford City Council met on Tuesday, February 22 and was offered Coast Guard Hill Road. Lee Sparks from the Oregon Department of Transportation made the offer to

the council. He said Coast Guard Hill road at .7 miles in length was the shortest state highway in Oregon. He said the Oregon Transportation Commission had given ODOT the mandate to approach cities with roads that shouldn't be state highways and either pay the cities to take them over or trade property to the cities for taking over the roads. The Port Orford public works department recommendation was don't take the highway because it doesn't meet city standards. Sparks said ODOT would be willing to upgrade the road and pay the city for 20 years worth of maintenance. Mayor Auborn said the city would want the road brought up to standards and include a bike and pedestrian lane as well as being compensated for future maintenance. The city staff and council streets liaison Carl Eskelson will work on this issue. Sparks indicated these things take time.

Under council liaison reports Carl Eskelson said he had attended a recycling meeting and that Curry Transfer and Recycle reported they are breaking even on recyclables but don't have much use for glass (they still accept it).

The council discussed the recent vandalism to Buffington Park. Seven trees were sawed down and others damaged in the attack. Councilor Steve Abbott made a motion that the city put \$250 in a fund for the arrest and conviction of the perpetrators of the tree cutting in the park. The motion carried 5-0. Citizens can also put money into the reward fund and if no culprits are found the money will go the Parks budget.

Councilor Ed Beck said the final completion date for the sewer treatment plant upgrade is March 9. The City has requested 30 more hookups from DEQ. (The city received a letter from DEQ dated Feb. 25 approving the 30 additional hookups.) He said there would be a "substantial completion" walk through at the plant on Thursday, February 24. Beck is on the ordinance committee, which is working on an animal control ordinance. He said people should tell the council what they want in the ordinance.

Mayor Auborn spoke about a United States Department of Agriculture com-

munity assistance grant for further renovation of the American Legion Hall and Community Building. The city will need a local matching grant but may be able to get that in the form of donated engineering and other professional services. The money would go for the roof, ceilings and lights in the American Legion Hall and painting for the Community Building.

Steve Donovan, SHN project engineer for the sewer treatment plant upgrade said the contract is in the liquidated damage phase with the city owed \$750 a day because the project was not completed on time. The total damages could amount to \$20,000-\$25,000 which would be withheld from the contractor Laskey Clifton. The substantial completion date for the project was to have been February 4. The city can charge more than \$750 a day if their damages are more than that during this penalty phase as long as the average per day doesn't come out to more than \$750.

The council discussed the new council rules. Councilor Jim Campbell said he wanted citizens' concerns at the front of the agenda and that he could accept the other changes in council rules. Councilor Abbott made a motion that the new council rules be adopted **except** moving

the citizens concerns to the end of the meeting. It passed 5-0.

The council had reviewed the police chief applications at an executive session prior to the regular council meetings. They discussed the process at the public meeting with councilor Milton Finch making a motion to invite candidates number 2, 8, 3 and 7 to be interviewed and that number 5 would be the alternate if one of first four didn't accept the invitation. The motion passed 5-0.

Councilor Jim Campbell made a motion that the city administrator not be involved with the interviews and that the two panels reports be directed to the city council. The motion passed 5-0. A law enforcement panel and a citizen's panel will interview the four police chief candidates on March 7. The people on the citizen's panel are Nancy Fraser, Deloris

Finch, Jim Billings and Robert Mielenz. The law enforcement panel consists of Sheriff Mark Metcalf, Fire Chief Gayle Wilcox, Gold Beach Police Chief Russ Merkley, and retired law enforcement officer Jim Rhoades. The meetings will be conducted in executive session and are not open to the public.

The council adopted a series of Resolutions including a supplemental budget for the police computer system; adopting a right of way license, annexing a piece of property and home on King Street into the city and public contracting rules. A resolution to increase the budget for travel and training died for lack of a motion.

The consent calendar was approved on a motion by councilor Campbell. It includes renewal of the Port Orford Chamber of Commerce/Visitor Center lease for 12 months; Mayor Auborn's reappointment of John Lincoln and Jim Rhoades to the budget committee and Viola Cuatt, Dave Holman and Joyce

Spicer Kinney to the planning committee; appointments of Michelle Duarte to the planning commission and Gary Doran and Joanne Ruoff to the budget committee; and approval of minutes of the January 18 council meeting (which you can read at the City's web site).

Public Works Director Dave Pace told the council he had been researching prices for diesel generators for the water treatment plant and the Hubbard Creek reservoir and so far had come up with estimated costs of \$70,000-\$75,000.



CCEC Meetings by Kathy Schneberk-King

Dear Owner-Members of the Coos-Curry Electric Coop. I have been attending the monthly meetings of CCEC for two years now. I was recently appointed to the Owner Member Advisory Committee (OMAC) charged with reviewing Board composition and compensation. The OMAC met for a day with 8 of the 9 CCEC geographic zones represented. We recommended that the board be reduced from 9 members to 5 and that zones be reconfigured to better reflect the number of members in a given area. The Board approved our plan in December and decided to send the By-law changes that would be necessary to effect the change to the membership at the June 2005 annual meeting in Port Orford. If the Bylaw change is approved by owner-members, the CCEC Board will be 5 members by 2007. I applaud this change, it will save the CCEC money. The OMAC did not recommend changing Board compensation but there is some discussion of a plan to decrease the amount of money spent on Board insurance.

The CCEC broke even over the last couple of months, the first time in over two years. It may be due to the furlough of employees, the raise in fees, or the suspension of tree trimming, or a combination of all three. It is still unclear whether or not CCEC will be required to pay a \$1,000,000.00 loan to NOAA Net that the Board guaranteed. I asked about the status of the loan at the last two Board meetings, and was told this topic would be discussed in closed session. Ownermembers are not allowed in closed session.

And finally, the CCEC has instituted a new program to help low income members of the co-op. The program suggests that owner-members pay our bills in even dollars and the extra pennies we pay are put into a fund that less fortunate members may access to help pay their electric

bill. CCEC calls this program "Round it Up." As a second generation Oregonian, when you say "round it up," it means one of two things, either a great day in Pendleton at the rodeo or an activity with wild horses. I don't know what else the term means. So I propose that we gunny sack the "round it up" name and help our less fortunate neighbors by telling the CCEC to "Keep The Change" when we pay our bills. That's my two bits.

Senior News

The Port Orford Senior Center held their membership meeting on Tuesday morning, February 22. Treasure Bill Nelson reported that the Center had a total of \$11,162.88 in their CDs, savings and checking accounts with no outstanding bills. He mentioned the higher than normal electric bill for January. Nelson thanked Al Granados for his efforts at the recent Senior Center dinner.

Vice president Beverly Dunlap said the recent trip to see a play in Brookings was very successful and the bus was full. The next trip is on March 17 to the Mill Casino. The bus leaves at 10:30am and when people get to the casino they will be given free fun packets with discounts. Dunlap described this upcoming trip as a "reward trip". For people who have been on a Center trip before this one will be free or for those first timers the cost is \$5.00 for the bus ride.

President Owen Miller said the Center has applied for a \$1,000 grant to the Coquille Indian Tribe for replacing the lighting and making sound improvements in the dining room. Miller said the lumber would be delivered that day to the Center for the new fence. Western Builders Supply donated the wood, McNair True Value donated the hardware for the fence and Coos-Curry Electric donated the poles and manpower to place them. Miller anticipated volunteers would work on the fence on Wednesday. Miller said that Norm Leeling had helped replace the fluorescent light fixtures in another part of the Center.

Miller said the Senior Center has been designated Port Orford's emergency center by the Red Cross. The Red Cross will be giving the Center a 27 foot long sealed container filled with emergency supplies including blankets, generators, and flashlights. Brian Newton from the Red Cross will work with the Center on the set up and delivery of the container. The Center will have to decide on where to place the container.

Lou Mincer spoke about an insert in the March newsletter to get members to write to their Congress people that they do not want Social Security privatized. The petition includes the addresses of Senators Wyden and Smith and Congressman DeFazio. Mincer told people they didn't want to see Social Security go the way of Medicare. He said that the members need

Curry Family Medical News By Evan Kramer

I recently spoke to Curry Health District Board member Gary Anderson asking him for more information about the new, but not yet open, pharmacy at Curry Family Medical Center. He forwarded my request for information to the CEO of the Health District, Ginny Hochberg. The following is her response.

"The plans for the medical dispensing machine for pharmaceuticals at Curry Family Medical took many turns along the way. There were delays at the State level for certification and by the Pharmacy Board, as there were no others in the state like ours.

But after much work, we are looking forward to this dispensing machine to be in place in Port Orford the week of March 22. The construction is almost complete, including the electrical wiring and phone lines that connect the machine to Shindler's Pharmacy in Bandon.

Pharmacist Steve Wilson will be overseeing the project and will be connected by telephone wiring and computer wiring to our new machine. He said that the "Formulary" (which is a list of common-



2CJ School Board

The 2CJ School Board met in regular session on Monday, February 14, in the Pacific High School (PHS) Library. All board members were in attendance: Virginia Hughes (Chair), Liz Brady, Alan Brown, Joseph Brown, Nancy Dowdy, Gail Rathbun, and Shirley Van Loo. Among the public in attendance with their families were the students from Driftwood and Blanco Elementary and Middle Schools and PHS who were recognized with Leadership Awards for the second quarter of the academic year. The students were Tara Mitchell from Driftwood Elementary. Anne Maddi from Blanco Elementary, River Harlan from Blanco Middle, Michael Bennett from Driftwood Middle, and Warren manning from PHS. The board presented the students with certificates and congratulated them for their accomplishments.

The Board reviewed the progress on actions called for in the Strategic Plan. Among actions completed on schedule are establishing goals for the district, the board, the superintendent, and each employee of the district and developing written job descriptions for all employees. Evaluations will be, or where required have been, carried out based of performance against these goals and the job descriptions. The board agreed that the district would provide first aid training for teachers as required in their job descriptions.

Scheduled improvements have been implemented on communications within the district and between the district and the community. Improvements have been made in communications and computation technology and technical support.

Catch-up facility maintenance has been scheduled and is underway. Incentive and recognition programs have been established for students and employees. Art classes are available in the high school. Middle school students now have a counselor. Social occasions are encouraging new collaborations. In general, the atmosphere at the schools has improved noticeably.

Review of previous paperwork on plans and cost estimates for a single-site school for the district was rescheduled to April from January. This is the first step in developing preliminary plans and cost figures that will be needed before the task of locating possible sources of funding can be undertaken. A written charge was adopted for the committee advising the board on possible uses for the Langlois red brick school building property. Only the gym at that site is still being used for school-related activities.

Teri Pointer of the South Coast Educational Service District (SCESD), which is under contract to provide business management services to the district, reviewed the financial status to date and said the district is doing well keeping spending under control. She said the

consolidation of ESDs being discussed at the state level would create great hardship for our area because of the distances that would be spanned and the differences between the services offered by different ESDs.

Bob Lemerande was awarded a contract to oversee district participation in the Knowledge Bowl. Cancellation of the Mexican trip was triggered by difficulty in getting insurance coverage. Money that had been raised for the trip will be saved for the trip next year. It is hoped that the insurance problem can be solved by then.

The budget schedule was approved with the first Budget Committee meeting on April 18. All positions are filled on the Budget Committee. Members are Ed Dowdy, Robert Ewalt, Judy Fladger, Bill Hawkins, Steve Kalina, Scott McKenzie, and Martin Myhre in addition to the board members.

Transportation Supervisor Tony LaPlante reported that he had found a used 2002 pickup with 23,000 miles for less than the budgeted amount of \$18,000. The truck will be used to transport meals to the other schools from the Driftwood kitchen. It replaces an older vehicle that was nearing the end of its usefulness.

Superintendent Marvin Ott reported on a technology plan developed by Adam House and Mick Lane to upgrade and maintain the quality of district computation and communication equipment. An in-service day is planned for teachers to include instruction in use of video streaming and digital curriculum. PHS received accreditation from the Northwest Accreditation Association.

The board met in Executive Session under ORS 192.660 (2)(i) Evaluating Top Executive.

The next regular Board meeting is scheduled for Monday, March 14, at 7:00pm in the PHS library. Further info is available from the district office at 348-2337.


