# Jail House Options By Evan Kramer



The Port Orford Planning Commission met on Tuesday, March 8 and held a public hearing on a request to demolish the old city jail at Seventh and Jefferson Streets

City Planner Chuck Nordstrom said the staff report on the demolition request was available to the public at city hall. He said the owners of the property at Seventh and Jefferson Streets want a building permit clearance form to demolish the jail. Nordstrom said the jail was constructed in 1937 and is listed as an historic building in the City of Port Orford Comprehensive Plan. He said the property is zoned commercial and that there are no other structures on the property. He said the jail was used from 1937 through the mid 60's and that the city sold it to a private party back in the 60's/ 70's.

Nordstrom said there were three things the Planning Commission could decide. They could decide that historic significance no longer exists, that the interests of the owners outweigh the public interest involved that historic values can be preserved by issuing the permit either with or without conditions, or that compensation should be awarded to the owners for losses sustained in preserving historic values. This information is out of the Port Orford Municipal Code Section 17.16.070 Historical site provisions.

Nordstrom said the owners say the structure is a safety hazard. Nordstrom pointed at a later time in the meeting that the demolition of the jail was a "condition of sale" by the prospective new owners.

Planning commission member Joyce Spicer Kinney excused herself as a commissioner from the hearing because of her connection to the sale of the property and the other commissioners all declared ex parte contact meaning they had discussed the issue with people in town.

Chuck Nordstrom said one option was for the city to buy the property back and move the jail to Buffington Park. He said the building is not listed as a state or federal historic site so grants are not available.

People from the audience addressed the commission. Lou Dunn told them he moved here because he saw photos of the jail and that when a city destroys its history tourists won't visit. The commission was presented with the idea of the property owner giving that part of the

property containing the jail to the city and then the city giving the property owner a part of Jefferson Street. It was brought up that Eight Street adjacent to the back of the property has never and probably never will be developed and that it would be an alternative to Jefferson Street. Jack Pruitt asked if a decision would be made that night and Nordstrom said the planning commission can make suggestions but the decision will go to the city council.

Linda Smith read the description from Becky Flake's calendar about the old city jail and then told the commission it would be a shame not to salvage the jail. Gayle Wilcox urged people to work together to save the jail.

Planning commission member Frank Smith reminded people the property is privately owned and it's not the city that wants to tear down the jail. Commission member Erna Barnett said if the jail became city property the city would have to maintain it. She said the city could deed the jail and property to a group of people who would maintain it. Commission member Doug Jamieson asked if the city was willing to cover the building insurance for the jail and pointed out what we do needs to be expedited.

# Jail House Options Continued from Front Cover

Joyce Kinney said this was only the beginning regarding historic structures and that there are six other historical buildings listed in the comprehensive plan.

People were asked if they would donate their time and labor to save and fix up the old jail and everyone in the audience agreed. No one of the twenty some people at the meeting wanted to see the jail demolished.

Commission member Frank Smith made the following motion. The permit clearance be forwarded to the city council with three options. The city can contact the applicants with the possible suggestion of trading 40 feet of Eighth Street to them and then the property owners would vacate the jail site to the city. Secondly the city council can contact the property owners about allowing a citizen's committee to move the jail with the concur-

rence of the council. Thirdly the city council can make a decision to purchase the property or authorize demolition. The city has 120 days to act on the permit clearance to demolish the jail. The planning commission voted 5-0 in favor of the motion.

The commission discussed making Idaho Street a collector street by changing the stop signs "to allow more efficient travel north/south through the city. The consensus of the commission was to have stop signs on Idaho at Ninth, Twelfth and Fourteenth streets and remove the others. The reason for having stop signs at those three streets is the amount of traffic going to Agate Beach, the fishing dock and Buffington Park and Geer Circle. Frank Smith made a motion that the city council designates Idaho Street as a local collector with stop signs at Ninth, Twelfth, and Fourteenth as per the City's transportation plan. The vote was 6-0 in favor of the motion.

# Understanding DVD's By Valerie Jean Kramer

Last time we talked about CD-R and CD-RW disks. Now let's look at DVD's. In some ways DVD's are a bit simpler. The main thing you need to know is whether your DVD drive can write DVD-R (and DVD-RW) or DVD+R (and DVD+RW) disks or both - and + disks. The + and disks are NOT made the same and cannot be interchanged so make sure you get the right kind for your drive. From what I've read, the – disks are technically superior but the + disks are more compatible with older DVD players. Even though DVD's are the same physical size as CD's, they cannot be played on CD drives. A standard DVD can hold 4.7Gb or 120 minutes of video in SP (Standard Play) mode (though the actual amount of video may be more or less depending on image size and quality.)

DVD drives range in speed up to 16x. That sounds slow compared to the 52x CD drives but one has to remember that we're talking about the time to record 7.23 times as much data. Factor that in and a 16x DVD drive is comparable to a 115x CD recorder! Like CD's the drives are rated with respect to real time so a 1x

drive would take 2 hours to record a full DVD while a 16x drive would take only 120/16 = 7.5 minutes. Neither CD's nor DVD's are likely to get much faster because beyond their present speeds, there is too much chance of the disk fracturing in the drive! That can be hazardous to equipment and even to nearby people!

The newest drives can now write "dual layer" disks with capacities up to 8.5Gb per disk! Unfortunately, the second layer can only be written at 2.4x and the disks are hard to find and very expensive (nearly \$10 each). This will probably change with time.

Like CD's, you use Nero or Easy Media Creator to burn DVD+/-R disks. You will need a newer version than you may have been using for CD's but one should come with most drives. You should also get some program, usually Power DVD, to play DVD movies on your DVD drive. Like CD's DVD+/-RW disks are slower to write than DVD+/-R, but they don't have as much problem with compatibility though there is a very good chance they won't play in most standalone DVD players.

Most commercial movies are copy protected and may not play in all DVD drives nor will you be able to easily copy them though there are plenty of sites on the web that will provide information or tools to help you if such be your need. One big problem is that most commercial disks won't fit on a single 4.7Gb disk and splitting them across two disks messes up the menu. The new dual layer 8.5Gb disks promise to help solve that issue.

DVD-R/RW drives can often (but not always!) read DVD+R disks and some DVD+R/RW drives can read DVD-R disks and may be able to read DVD-RW disks. DVD-RAM is very rarely seen. It can be a good format for data storage on a computer but if I were betting, I'd bet on it to go the way of 8-track and Betamax tapes. In general you will want to use a DVD rated at or above the speed of your drive. However, drive speeds increased rapidly in the last six months while prices fell quickly. It's now easy to get a 16x drive but 16x disks may be hard to find. I routinely find myself using 4x disks in my 12x drive and I've had good success with that. Just be sure to set the recording speed in your software so it doesn't exceed the speed of the medium.

#### Police Chief Hiring By Evan Kramer

The Port Orford City Council met in special session on Friday, March 11. The meeting was requested by three councilors and dealt with further discussion of hiring of the new police chief. The job has been offered to Mark Creighton.

Councilor Jim Campbell told the council he had called DPSST (Department of Public Safety and Standards Training) and he was told a psychological examination was not required for the police chief. Mayor Jim Auborn said he had attended a League of Oregon Cities meeting and at that it was recommended a psychological test be given to whomever the city hired for its police chief.

City administrator Ken Knight was asked what kind of check was done on interim police chief George Simon and he described it as minimal. He said phone interviews had been conducted but no check of his personnel files was done because the position was only to be an interim one.

Mayor Auborn said the day-to-day administrative support for the police would

come from the city administrator with the hiring and firing from the council. He suggested the public safety subcommittee could supervise the police department.

Councilor Campbell made a motion that the mayor and city council take over supervision of the police department/ chief and to get the proper documentation from the city attorney to have this done. The motion passed unanimously.

Campbell said Mark Creighton would begin as police chief before the end of the month.

Ken Knight has submitted a report to the council on the situation. He requested it be placed permanently in his personnel file. Knight said in his report that Creighton has "refused to sign a Personal Inquiry Waiver for the Curry County Sheriff's Department." Knight wanted his opinions on file in case of a lawsuit regarding the hiring of Mark Creighton.

Former Mayor Gary Doran spoke about the recent hiring of Mark Creighton and said it was possibly illegal and unethical on the part of the council. He said the psychological exam was a good idea and

referred to two unsubstantiated incidents from Creighton's past with the Curry County Sheriff's Department. Doran then said Creighton was not the number one choice of the two police chief search committees and that the committee's recommendations hadn't been taken. He accused the council of not following their own hiring procedures. He urged them to have integrity and be honorable men. The information about the two panels was from the executive board session and was not to have been disclosed outside of the executive session.

Dr. Corey from Portland will conduct the psychological testing for Creighton at Gleneden Beach. Knight said he comes highly recommended. The cost will be \$375 for the test. Creighton's physical examination and drug testing was scheduled for March 15 at Curry Family Medical.





Dee Finch has a list of warning signs for other dog owners if their dogs eat rat poison. Look for broken blood vessels in the eyes, the gums will turn white, there will be blood in the urine and stools, massive bruising in the chest and groin areas, a loss of appetite and unusual restlessness. The first 1-3 days after they eat rat poison is the most important as if you can catch the symptoms early and get them to a veterinarian there is a chance to save the animal.

Please other dog owners be aware of your dogs whereabouts and any symptoms of poisoning. This isn't the first dog poisoned in Port Orford in the past six months. So far no one has been arrested

in the other dog poisonings, which occurred in the area of Idaho Street between Eleventh and Thirteenth Streets. Everyone in town can help by paying attention to what's going on around them. This is a tragic situation and can't continue going on in Port Orford. Stop the violence.

The Finch's are offering a \$500 reward for information leading to the arrest and conviction of the person or persons who killed their beloved dog Ace. They had him since he was a puppy. You can contact them at 332-4400 or visit them in person at the Port Orford Liquor Store.



#### Are We Prepared?

"Earthquakes/Tsunamis Are We Prepared?" a public forum will be held on Wednesday, March 23 at the Port Orford Community Center beginning at 7 PM. The forum is sponsored by Curry County Emergency Services, Citizens for Emergency Preparedness and the City of Port Orford. Invited speakers include: Jay Wilson -Oregon Emergency Management, Tom Wiley - Department of Geological and Mineral Industries, Mike Murphy-Curry County Emergency Services, Phil Barker - Ham Radio, Karyn Dagenais - American Red Cross, - Lauren Porsch - Coos Curry Electric, Lori Kent - Curry County Home Health Hospice, Georganne Greene - Curry County Health and Human Service Department, Sheriff Mark Metcalf - Curry County, Ken Knight - Port Orford City Manager, Wayne Moore - Sixes Rural Fire Protection District, Gayle Wilcox - Port Orford Ambulance/Port Orford Fire District, Jack Nottingham - Citizens For Emergency Preparedness, Gary Anderson -Port of Port Orford and Jan Henault -Southcoast Humane Society.

Each speaker will discuss what their organization's role will be if an earthquake and or tsunami hit the Oregon Coast. Tom Wiley (DOGAMI) and Jay Wilson (OEM) will give presentations that will be the latest information on what Curry County could expect should an event occur. Curry County Emergency Coordinator Mike Murphy will show clips from the Indonesian event. Curry County Commissioner Lucie La Bonte will moderate the forum. Forums are being held in all three areas of Curry County to educate the public as to how the agencies have been preparing. "A lot of what happens in such an event is up to individuals and how well they have educated themselves to be prepared", says La Bonté. "We hope the information we can provide will help in these public safety efforts."

After the speakers have spoken there will be a question and answer period. This is a public information forum and the public is encouraged to attend and participate.

#### **Wastewater Treatment Plant**

The City of Port Orford received a letter from SHN project engineer Steve Donovan last week full of good news regarding the sewer treatment plant upgrade.

According to Donovan the Department of Environmental Quality and the US Department of Agriculture representatives did a walk through at the sewer treatment plant on March 9. Donovan goes on to say, "Both agencies agreed that the project had achieved substantial completion and as soon as the control system is approved by the instrumentation engineer and the RAS gear changed out, the project can proceed to final completion."

Donovan continued in his letter, "According to Jon Gasik with DEQ, the terms of the MAO (Mutual Agreement and Order) will expire in 60 days following his march 9 site visit regardless of DEQ notifications to the City or not. Jon can expedite the expiration date by providing the City of correspondence from the DEQ director."

#### Port Manager's Report By Gary Anderson

The ice machine was delivered on time on Wednesday, March 9, without incident and should be in production by April 1. It was placed in the upper floor of the ice house on Friday by Budwyn Powers of Budywyn's Custom Shop and port employee Ed Schriver. The machine will produce five tons of ice in a 24-hour period and the insulated storage bin will hold ten tons. The \$25,000 to purchase the ice machine came from a grant from the Coos Curry Douglas Regional Investment Board. We started work on the upper lot and the trailers have been disassembled and several loads of scrap have gone out. We are waiting on the excavator to pop the tires off from the rims and pull out some of the gorse. We purchased a high power brush cutter/ weedeater for \$458 from the \$2,000 beautification grant from the City and the crew has been cutting brush along the road. Coos-Curry Electric has replaced several light fixtures, as the existing ones were very high maintenance with expensive bulbs. The auditor will be at the Port office on Thursday to pick up our reports and go over the details.
