City Hall Departures By Evan Kramer



The Port Orford City Council met in special session on Wednesday, July 6, at 5:00pm, to discuss city administrator Ken Knight's separation agreement. Mayor Jim Auburn said that Terry

Hatfield would be serving as city recorder pro-tem in the absence of Beverly Manes.

Council Jim Campbell asked that an item be added to the agenda for a discussion of the police department.

The council went into executive session briefly and then back into regular session.

City Administrator Ken Knight asked if the city would pay his registration for the OCCA (Oregon Counties and Cities Association) conference. Registration for the conference is \$305 and Knight did not ask the council to pay for his lodging, transportation or food. Mayor Auburn said if the council paid for Knight's registration fee for the conference it might help him find another job. Councilor Carl Eskelson made a motion to pay for Knight's registration fee and the council voted 4-2 in favor of the motion.

The terms of the separation agreement between Ken Knight and the city were then read into the record. The six-part agreement includes a section that Knight will continue to work for the city until September 1, 2005 and that his employment with the City will be terminated on September 1, 2005. Knight may resign as city administrator before September 1, 2005. Sections 4, 5 and 6 dealt with releasing both parties from legal claims against each other. The agreement was the result of negotiations worked out by Knight and city councilors Steve Abbott and Jim Campbell with consultation by city attorney John Trew and Knight's lawyer. Councilor Campbell made a motion to approve the separation agreement between Knight and the city and it passed 6-0. Knight was hired in February 2004.

Mayor Auburn said he had enjoyed working with Knight the past year and a half. He said he hoped the council could do better next time. Auburn said he would like the council personnel subcommittee to discuss the city administrator's job description when they meet and how the city would go about recruiting a new city administrator.

Mayor Auburn then dropped a surprise announcement into the meeting when he said the part-time city planning director

Chuck Nordstrom has submitted a letter of resignation effective August 31, 2005. Auburn asked the personnel subcommittee to work on a replacement for Nordstrom. Councilors Milton Finch, Jerry Steinhorst and Carl Eskelson are on the personnel subcommittee and they will look at their schedules and plan a meeting, which the mayor wants to be held soon.

Ken Knight said the current city administrator job description is more of a city manager's description and the council should look at other job descriptions during the hiring process.

Knight asked the city council not to sabotage him in his search for a new job and that he wanted an amicable leaving. He said he wanted to leave Port Orford and look at it as a learning experience.

Councilor Abbott asked if Knight could help the city find a new planning director. Knight said he had already put out a Request for Proposal message looking for a part-time city planner. Knight told the council he would work for them until he wasn't working for them.

The council then took up the subject of the police department. Jim Campbell said it was unclear to him if the three-person council public safety subcommittee (Jim

Campbell, Ed Beck and Steve Abbott) was handling the police department. Mayor Auburn said the mayor would oversee the day-to-day operation and that they needed one person responsible for the police chief on a day-to-day basis, not a committee. Auburn said he didn't want any more squabbling and that he would mediate between the police chief and city staff.

Former Mayor Gary Doran told the council he had problems with the chief spending so much time at the liquor store. Doran said it didn't look right and that other people have also complained about it. Councilor Milton Finch asked who the other people were Doran was speaking of but received no answer. Doran said he had a problem with Chief Mark Creighton ever since the council hired him and didn't check his personnel records. (Chief Creighton is on salary

and works 50-60 hours a week and lives in the city. On his way home he sometimes stops in and speaks with councilor Finch who owns the liquor store. Chief Creighton also stops in and speaks with people at many other businesses. In the opinion of this newspaper, Chief Creighton is doing the best job of any police officer we've seen in this city.)

Councilor Finch made a motion that the public safety subcommittee oversee the police department. Ken Knight suggested the council speak with the city attorney about the idea. Mayor Auburn said he didn't like the idea. He said if the council took away his responsibilities as mayor he might leave the job of mayor. He told the council if they didn't want a mayor they could do without one. Auburn said he thought the police chief should report to the mayor. He continued that if he got into a pissing contest with the subcommittee he would dissolve it. Councilor Jerry Steinhorst said the chief should

take direction from one person. Councilor Finch said the Chief Creighton wants to know who to take directions from. The vote on Finch's motion was 4-2 against with Finch and Campbell voting yes and Ed Beck, Jerry Steinhorst, Carl Eskelson, and Steve Abbott voting no.

Other than that nothing much else went on at the one hour-long meeting.

and Port Orford Police. The search was the result of an investigation by police into a possible identity theft where a male subject was found to have in his possession bank receipts of several local people. ATM receipts belonging to several people were seized. The case is currently under investigation.

Automated Pharmacy

More than \$50 in drug store supplies and gifts were raffled off to Willowsong Hall of Port Orford when Curry Family Medical and Shindler's Automated Pharmacy co-hosted an informational booth at a health fair last month sponsored by Curry General Hospital and Coos Curry Electric Co-op. Port Orford is the first city in Oregon to claim an "automated pharmacy."

Opened in March, the system offers many patients the option of obtaining prescription medication locally, without the expense and inconvenience of traveling to pharmacies out of town.

The system is located in the Curry Family Medical clinic off Highway 101, 525 Madrona, in north Port Orford. Curry Health District managers worked with Tom Pitchford, M.D., and Carol Milne, FNP, to restore pharmacy services and

accommodate the system at the clinic location following the closure of Port Orford's only pharmacy two years ago.

The automated pharmacy is so unique that the state legislature had to enact special rules before allowing Shindler's (a Bandon-based pharmacy business) and the Curry Health District to establish the much needed service.

The system stores more than 90 of the most commonly used medications in Port Orford. At this time, however, the federal government does not allow storage of controlled substances. "We are hoping this will change in the near future," Sue Runberg, pharmacy tech, says.

Pharmacy customers do not need to be patients of Curry Family Medical to use the pharmacy services. All health providers can write prescriptions for patients who can fill the prescriptions there, as long as the system stores those particular medications. Prices are the same as

in the Shindler's Pharmacy in Bandon, Runberg says.

Customers who do not find their medication in the system are encouraged to request that it be carried in the future. "If there are enough requests, the medication might be placed in the automated system," Runberg adds.

As an option, she says, a health provider can change a patient's medication to an alternate one that is currently carried in the system. All medications in the system are listed on a free handout available in the Curry Family Medical lobby.

Car Crusher Coming

The South Coast and Lower Rogue watershed councils are sponsoring a Community Car Crush Clean Up project for the Port Orford area. The project is funded by the Oregon Watershed Enhancement Board. The community clean up provides an opportunity to dispose of useless automobiles. This service, provided by Rebel Savage, will eliminate sources of pollution in our watersheds and enhance properties by removing old cars.

Cars and scrap metal such as washers/dryers, old bikes, culverts, etc. will be accepted free of charge. Cars with tires on will be charged \$3.75 per tire.

Refrigerators and freezers are not accepted at this time due to issues with Freon.

If a title is available please attach it to the vehicle's dashboard. **If the title is not available** and the vehicle's value is estimated at under \$500, then the vehicle can be disposed of. State certified appraisers are available to make this determination if necessary.

Tires without rims will be accepted on site for a fee of 75 cents to cover the disposal cost. Tires with rims will be accepted for \$3.75 (disposal cost).

If you remove the tire from the rim – the rim can be crushed as scrap metal and the tire can be disposed of for 75 cents.

Fluids will be drained and properly stored on the site. The fluids will be disposed of and recycled by the watershed councils.

Batteries and catalytic converters from vehicles will be removed on site and recycled. Other intact car batteries can be brought to the site and will be recycled by the watershed councils.

The car crusher does not take trash. Please empty any non-metal trash from your vehicle.

Towing will be available through the services of Rebel Savage at a cost of \$35 per car. Other towing services may be available. Please contact Steve Smith of Rebel Salvage at 541-592-4526 or Beth Pietrzak, project manager, at 541-661-4242. Cars and scrap metal disposed of at the crushing site will be hauled by Rebel Salvage to the Portland area for shredding and recycling.

Board member and president of America's Wild Rivers Coast, Cindy Schaumburg said the AWRC Visitors Guide is out and in Visitors Centers on Statewide basis.

Ed McQuade was back after an illness and had an insight into the "lagooning" problem of Garrison Lake. McQuade said that without some kind of effort the lake would be overgrown with reeds and vegetation like the section on the east side of Arizona. McQuade said there is a natural cure for this by stocking the lake with sterile grass eating carp. Everyone thought this was a good idea.

Marilyn Oberbeck talked about handling some details for the planned OctoberFest on October 8, in conjunction with a Road Rally.

Oberbeck and Judy Taylor will be working on creating Welcome Baskets for the new chamber members and merchants in town.

Jay and Rusty Gibson will take care of getting the Chamber Trailer back to the city lot later in the week. The trailer will then get an additional paint job to trim it out.

Secretary Judy Taylor proposed two items. First was a Promotional Guideline Proposal that the chamber would follow

when asked for donations or in conjunction with a co-sponsored promotion. Events and donations will need to meet certain criteria. Taylor and Stoler will refine the document for final board approval.

The second item was a proposed change of bylaws to change the term of a board member from 3 to 2 years. The board passed the recommendation. Stoler will draft a letter to the members for a general vote.

Cindy Schaumburg made a motion that the chamber should skip the August board meeting due to vacations and other obligations of board members. The next chamber meeting will be on September 12.

Administrator Ken Knight thanked the board and said this was his last chamber meeting as he was moving on and would be gone by September first. He was thanked by the board members for his attendance at most chamber functions. Mayor Auburn was also thanked for his chamber meeting attendance and interest.

Parks Meeting

The Port Orford Parks Commission met on Monday, July 5. They covered a lot of ground and approved several recommendations that will be sent to City Council.

First up was a Chamber of Commerce and Arts Council proposal to utilize Buffington Park on Labor Day to present a Seafood Bar-B-Q, Arts and Crafts exhibits and 154th Birthday Party for Port Orford to commemorate being the oldest town site on the coast. The Parks Commission approved the request on a motion made by Commissioner Millie North and seconded by Commissioner Jodi Bulaich, and will be sent to Council.

Next, an “exploratory” proposal to remove or improve the billboard type sign at the entrance to town was presented by Jay Stoler representing the Chamber and Anne Goetzman representing the Sunset Garden Club. Both said this was an “exploratory” idea as neither had the definitive answer of how to beautify the area, other than the improved display by the Garden Club. Stoler said the message on the billboard is “perfect” but said the sign itself is old and warped and faded. Commissioner Joanne Ruoff said the sign just needs to be refurbished and will look fine. Stoler said that perhaps some combined fundraising efforts could be done to get the money to refurbish the large sign. In addition, Chairman Jim Billings reminded everyone that the sign sits in a precarious location with part of the struc-

ture on land controlled by ODOT and the other part of the sign on land owned by CK Markets. Permission to improve or remove would have to come from both parties. The commission recommended that a way be found to refurbish the sign.

Next came the Parks Updates which included:

- Aggressively pursuing more grants by grant writers Jim Billings and Millie North for park improvements, tourism funds, and general beautification grants to upgrade facilities.
- Discussion on the Horse Arena and the drainage problems there. Jodi Bulaich suggested a slopping grade to deal with the runoff. It was also suggested to have the industrial arts students at Pacific High School build a set of bleachers for the arena, like they did for the Skate Park. Bulaich will follow up on those items and report at next meeting.
- The BMX Bicycle Park is coming along and had three more dump trucks full of dirt added to it.
- The Commission will be looking into getting the necessary electrical outlets in place at Buffington Park so that a permanent Park Host can be found. The Park Host would be responsible for some grounds keeping duties and security check at the Park. Administrator Ken Knight said that there might be some Gateway grants that could help get the tennis courts resurfaced.

- A new park bench dedication is in the works for Battle Rock Park and will be another sturdy bench like the last one.

- Joanne Rouoff announced that a proposed culvert to help drain Garrison Lake will delay the installation of the Pinehurst Boat Docks by 18 months.

- The Port Overlook will get a new park bench and interpretive sign.

Finally, under new business, there was discussion of a Responsible Parties Agreement for anyone or group that needs to be covered by City insurance, like the Chamber of Commerce or Jubilee festivities. The agreement would specify exactly what the event(s) were and who the responsible parties were and their phone numbers so they could be contacted by anyone with questions and the city could better monitor the activities covered by their insurance policy. It was mentioned by Chairman Billings that there were many calls about Jubilee activities to the Visitor's Center, Chamber and City offices for which no one had answers nor the phone numbers of those who had the answers. After some discussion it was decided to write a letter to the Jubilee Committee to ask for better documentation.

Jim Billings announced that it was legal for the Parks Commission to hold fundraisers, but the monies raised must go into the General Fund.

The meeting adjourned about 8:30pm.

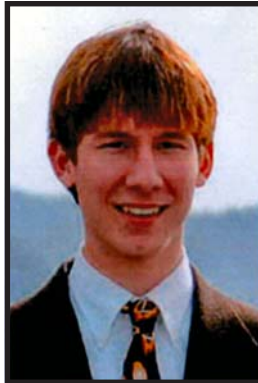

Blood Supply Low

A reduced number of blood donations in the southern Oregon area over the last few weeks is seriously threatening the ability of the Red Cross to supply blood products for patients in local hospitals. Last week in southern Oregon and throughout the Pacific Northwest area, the Red Cross collected about 1000 fewer blood donations than we should have collected to meet patients' needs. Each donation can potentially help up to three individual patients.

In the Pacific Northwest area, the Red Cross needs to collect about 1,000 blood donations each business day. Overall, our current blood inventory stands at about a half-day supply for most blood types, especially type O. A three-day supply is the minimum desirable level and provides a high degree of confidence in our ability to respond to an emergency

or trauma situation while also meeting routine patient needs.

If blood donations do not increase very soon, physicians and hospitals may have to consider canceling elective surgeries so the blood supply will be available for trauma and emergency cases.

We ask eligible donors in southern Oregon, especially those with blood type O, to call 1-800-GIVE-LIFE to schedule an appointment or to find a convenient blood drive location. Please call today; don't wait for the Red Cross to call you.
