### Restoration Pros and Cons By Evan Kramer



Oregon State Parks held a meeting last Thursday night led by State Parks Coastal Coordinator Calum Stevenson. He explained that the purpose of the meeting was to discuss an ocean shores permit application for dune bulldozing and lowering, and creating a Snowy Plover habitat on a part of the Elk River spit. Stevenson said State Parks was a "neutral party" regarding the issue. He said State Parks goes by the laws set forth in the 1967 Oregon Beach Bill.

Stevenson said State Parks asks several questions about a project in deciding whether to approve or reject it. Some of them are: is a project needed, are there reasonable alternatives to the project and can conditions be put on it. Does the project comply with LCDC goals for the Oregon coast? Other questions include the impact of the project on the scenic standards on the Elk River and does the project impact recreational use standards including recreational access. Another question State Parks has to answer is does the project impact historical and archaeological sites.

Stevenson emphasized the narrow focus of the Thursday night meeting as looking at the ocean shore application for Snowy Plover restoration habitat. He told the 80 or so people at the Community Building that their comments would be part of the process for making a decision. The majority of people at the meeting were opposed to the application. Stevenson said Oregon State Parks has three options as they can approve the application, deny it or approve it with conditions. He said the decision in this case would be made by the Director of Oregon State Parks in Salem and that it would be made within 45 days. Stevenson said written comments on the application were due by Thursday, October 27.

Fred Seavey, representing the United States Fish and Wildlife Service, is working with the permit applicant, rancher Scott McKenzie, and answered questions about the project. Seavey said that they were attempting to restore the Snowy Plover habitat on the Elk River spit by removing the European beach grass and lowering the dunes thus increasing breeding habitat for the shore bird. The Snowy Plovers breed out in the open on the dry sand part of beaches. The project area is located near the elbow of the Elk River where it turns north along the one and a half mile spit. Seavey said the bulldozed

sand would be pushed to the active part of the beach where it will then return to the ocean and migrate south. He said the dunes were nearly 30 feet tall along the spit and the goal was to lower them to 18 feet. Seavey said the work would be done in spring or fall.

Seavey was asked what would happen if the Snowy Plovers do nest on the Elk River spit. He explained that the bird's breeding season is March 15 through September 15. He said during that time vehicles would be prohibited and non-motorized access would be limited to the wet sand part of the beach. Seavey said there would be no restrictions on access from September 16 through March 14.

Ed Liszka asked Seavey if an Environmental Impact report would be needed. He was told no and the environmental assessment would be provided by DOG-AMI (Department of Geological and Mineral Industries). Seavey said the \$20,000 for the project to move 80,000 cubic yards of sand would come from the Fish and Wildlife Service. He said the plover population is increasing in Oregon and had gone from 40 to 130. He described some as resident plovers and said some migrate to Central California. He said the New River Snowy Plover population is moving north. He described

the threat to plovers as coming from predators (crows and ravens), human disturbance and habitat destruction.

Seavey was asked about any financial gain for the landowner. He said Scott McKenzie would be paid \$20,000 to remove part of the dune and that McKenzie would donate 15% extra value in work. Later on McKenzie told me that 10% of the \$20,000 would go the South Coast Watershed Council and another 10% to DOGAMI and that he would be donating 25% in extra value.

Seavey was asked how many Snowy Plovers he expected back on the Elk River spit in five years. He answered that it was difficult to get Plovers to pioneer new areas and the goal was two breeding plovers within five years.

The meeting then went into a formal public comment session with people di-

recting their remarks to Calum Stevenson. Don Peabody from North Bend spoke first and read from a several page long statement. He spoke against the permit application and cited several reasons including it would reduce public access; removal of the foredune would cause the Elk River to change course, an Environmental Impact statement is needed, and that the more eyes there are down on the Elk River Spit the more monitoring of illegal fishing activities will go on.

Jim Peck from Coos Bay said he was representing the steelheaders and that he couldn't see much benefit to the public. He said he couldn't see the project being done for a one time fee and that it would be an ongoing maintenance issue for a long time. Port Orford Watershed Council Chairman John Leuthe said the council had reviewed the project and decided it had merit. He said the council wants to promote this type of project and supports it.

Jim Peck Senior, a board member of the Northwest Steelheaders group and a member of the Ocean Policy Advisory Council referred to the project as junk science and that it was designed to close the beach to people. Peck expressed concern about the effect on the estuary of removing part of the dune. He said if the application is approved the Northwest Steelheaders will file a lawsuit against it.

Jim Rogers, a 37 year resident of Port Orford, said the dune is way built up from what it used to be like. He said it wasn't a natural thing and was caused by the European beach grass. He said he was in favor of the permit application if it brought the Snowy Plover back from the brink of extinction. Jerry Becker, Director of the Elk River Land Trust, said we needed to provide more nesting areas for the Snowy Plover and he thought it was a good project that should go forward. The deadline for submitting comments was Thursday, October 27.

## **Book Signing in Gold Beach**

This Sunday, October 30, at 2:00pm, Oscar winner Elmo Williams will sign copies of his late wife Lorraine's newly published book, for which he wrote the Forward, *The Letters that Hollywood Loved*, at Gold Beach Books. The free event will begin with the exhibition of Williams' short film, *Christmas in Tyrol*.

Williams and his wife moved to the Brookings area several years ago after Williams' successful globe-trotting career as a filmmaker. Williams won the Academy of Motion Picture Arts and Sciences Award (the Oscar) for editing the classic film, *High Noon*. He also produced and directed many other enduring movies, including *20,000 Leagues Under the Sea*, for which he received another Oscar nomination, and *The Longest Day*.

After his wife's death last year, Williams began assembling the holiday letters

Lorraine had written over many decades during her world travels with her movie-making husband. Those letters were eagerly anticipated by family and Hollywood stars alike. The new book is a collection of those letters along with photos from the Williams' life together. Fans of Lorraine's letters included Frank Capra, Red Buttons and Darryl Zanuck. Ernest Borgnine, another admirer, recently wrote: "In the midst of all the hustle and bustle of Christmas and all the cards we received, the most awaited were Lorraine's, her words like descriptions of heaven itself! This is a book that should be in everyone's library!"

The collection has received praise from advance reviewers, including local artist Jan Marney, who says, "This book is for husbands and wives, for fathers and mothers, sons and daughters, lovers and best friends;" she adds, "If you want to learn how to paint a landscape using the printed word, Lorraine's letters will take

your breath away; she'll make you marvel at the kaleidoscope of life!"

The film which begins the event, *Christmas in Tyrol*, was inspired by Williams' family, some of whom appear in the story about a special holiday in the Austrian Alps. After the film, which runs about 20 minutes, Williams will discuss his wife's new book and sign copies.

**Watershed Council News

There were two meetings on Wednesday, October 19 at City Hall in relation to Watershed business. The first meeting; from 6pm to 7pm was led by Cindy Myers of the South Coast Watershed Council with the prospective Steering Committee applicants and grant writers.

Myers said she had communicated with Mary Pfauth and Dr. Mark Systema from Portland State University and they regretfully declined to get involved with this particular grant because they had a time crunch problem and the proposed grant needed to be reworked into a full-fledged Lake Management Plan, not just an Aquatic Vegetation Management Plan, which only addressed one issue.

Myers also said she spoke with Pam Blake of the DEQ who affirmed that after review, she also said there had to be full, long-term plan directed at bringing the quality of the water back up to drinking standards.

While there was a great deal of disappointment among participants, the group consensus was to forge ahead and get the Steering Committee in place and start

laying the groundwork for next year's grant cycle. It was also believed that by forming the committee right away, there would be the possibility of being in line for other grants aimed at lake and water restoration projects.

Meyers said in her conversation with Dr. Systema, he promised to make two visits to Port Orford, at his expense, to survey the lake and do first hand research. Meyers said Systema is committed to Garrison Lake, but has to work within certain time frames and University parameters.

The Watershed Council meeting started at 7pm led by Chairman John Leuthe. All other Council members were present and there were less than a dozen attendees.

Here are the meeting's highlights:

- The Watershed Council picked the members of the Steering Committee, which is now called the Garrison Lake Restoration Committee. The members will be County Commissioner Lucie LaBonte, Lakeshore Drive resident Dennis Miller, Geer Circle resident Ed McQuade, Watershed Council member Steve Taylor, City of Port Orford Administrator, Chamber of Commerce President, and a representative of an Oregon State agency

to be named by Governor Kulongoski at the request of the Watershed Council.

- Discussed and gave support to Scott McKenzie and an Elk River Dunes project that will be occurring on McKenzie riverfront property with an easement. Included in the project is habitat protection for the Snowy Plover, and that may mean closure or limited access to the river from May to September. Watershed Council member Steve Taylor said he wanted McKenzie to be mindful of anglers and sportsman who have a right to cross the easement. McKenzie said he would be mindful and the Council voiced unanimous support and Jennifer Bastian commended McKenzie on good land stewardship practices.

- Beth Pietrzak announced the final results of the Car Crusher project and showed some interesting slides of various land plots that had been cleaned up, not only in Port Orford, but all over Curry County. Beth said from Port Orford there were 220 cars towed and crushed, 335 car batteries, 1200 tires, 13 barrels of toxic fluids and a trailer load of hazardous material. The most junk cars towed from one location was eleven in the Port Orford area.

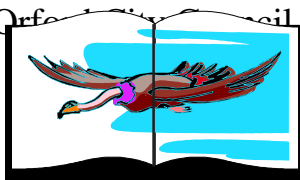

[Last week we got from Port Orford to Eureka, CA.]

Our next stop was the Founders Grove along the Avenue of Giants just north of Weott, California. The giant redwoods made for a great place to walk the dog, stretch our legs, and take some photos. The temperature couldn't have been better. It felt both warm and cool at the same time, if you can imagine such a thing and the trees filtered the sunlight into a beautiful gloom. Truly a magic place.

Speaking of magic, as Evan drove along Hwy 101, Valerie was reading her Harry Potter book. (She's been re-reading the series and was on the volume 6.) She looked up in time to notice a passing car exiting at Garberville with the license plate "Hogwart". There is also a Hobbiton in this area.

By the time we stopped at a rest area just north of Willits it was getting uncomfortably warm. Other visitors at the stop told us it was 94°F on I-5. Ouch! On the other hand they also told us Hwy 1 was closed which proved to be untrue. We got to

Willits, 248.4 miles south of Brookings, just about 5:00pm. Valerie found lots of new treasures in their used book store – a favorite stop of hers. We then left Hwy 101 to take the coast road, Hwy 1 and soon had our first animal encounter as a somewhat confused gray squirrel crossed the road in front of us. (It made it safely.)

Happy to be back on the cool coast, we spent the night at the Surf Motel in Fort Bragg.

October 1, 2005 – Saturday

We took a quick visit to the port at Fort Bragg. Like Depoe Bay, OR, the Ft. Bragg port is east of the highway and well below the bridge over the inlet. There is a dry dock, a boat ramp, and a LOT of boats including some very large ones. There was also a floating walkway near the western shore on which some sea lions were taking their morning naps. Valerie had fun taking photos of them.

We headed south down Hwy 1 and our next stop was Mendocino where we parked near a church with some rather interesting sculpture work on its roof. The sculpture was also functional – it was serving as a roost to a host of birds. We spent a few minutes exploring their

local hardware store. Like the Fun Zone, this was a multi-faceted store and in addition to hardware it sold Halloween costumes, stationary and art supplies, and a variety of other goods and services. 1969 to 1981, he was the principal researcher and recovery team leader for the California Condor project, which included the captive-breeding program that has made possible recent condor recovery efforts.

With a nine-foot wing span, the California Condor is the largest flying bird in North America. In 1806, the Lewis and Clark expedition recorded instances of California Condors feeding on dead salmon washed up on the banks of the Columbia River. But by 1968, the total wild population had declined to only 60 birds, and in 1985, it was down to about 10. Currently there are fewer than 100 that
