# No Crab for Christmas By Evan Kramer

The Oregon Department of Fish and Wildlife issued a report to the Oregon Dungeness Crab industry on November 14 regarding the pre-season soft shell test results for the crabs up and down Oregon's coastline and the results were very bad news for the south coast including Port Orford and Brookings.

ODF&W did the sample testing in conjunction with the Oregon Dungeness Crab Commission in five locations. The amount of meat recovery to open this year's crab season is 25% or higher south of Cascade Head and 23% or higher north of Cascade Head.

The ODF&W Astoria crab sampling came in at 22.3% fill, Garibaldi couldn't be tested because of rough bar conditions, Newport at 22.9%, Coos Bay at 23.7%. Moving down the coast to Port Orford our area sampled at 17.1% and Brookings at 16.7%. According to ODF&W's sampling report Port Orford and Brookings will not reach the 25% criteria until "well into January." ODF&W will conduct one more test in mid-December.

The crab fishermen and processors have come up with an industry wide agreement to ask ODF&W for a closure of the Dungeness Crab fishery from south of the jetty at Bandon to the California border. ODF&W will likely to follow this recommendation but as of Monday hadn't made it official. The ruling by ODF&W would mean that fishermen who fish for crab **north** of the south jetty in Bandon will not be able to fish the area south of the jetty for 30 days after the season opens here. The crab season officially opens on December 1 and crab pots can be set starting November 28.

Last year's crab season was one for the record books with the largest season total ever at 33,669,314 for the State of Oregon. Crab landings at the Port of Port Orford totaled 1,399,061 pounds with a value nearly \$2 million. The crab fishermen, the fish buyers, the Port all made money last year and from there it circulated in the community to the grocery store, hardware stores, convenience store, restaurants and other businesses.

#### **Snowy Plover Decision Coming Soon**

Oregon State Parks Coastal Coordinator Calum Stevenson said on Monday morning that he is finishing up his work on the permit application for restoration of Snowy Plover habitat on part of the Elk River spit. The permit application was requested by Scott McKenzie. The report by Stevenson will go to State Parks Director Tim Woods in Salem later this week. Woods has until December 4 to make a decision on the application permit. He will consider public comments made at the meeting in Port Orford held on October 20 as well as additional com-

ments and the staff report from Stevenson. Woods will confer with other people in the State Parks office as this decision is guaranteed to make many people unhappy whichever way it goes. The decision will be released through the State Parks website and press releases. Woods' decision will then go before the Oregon State Parks Commission which will meet later in December. The commission can overrule Woods' decision if they choose and sometimes have overturned staff decisions.

The Port Commission, with all members and Port Manager Gary Anderson present, met in regular session on Nov. 15. Here are highlights of that meeting.

Commissioners unanimously approved a lease with Starvin' Marvin for dock space. This generated a discussion between fishermen and fish buvers about the benefits of having more buyers for the fish. Buyers like Hallmark, NorCal and now Starvin' Marvin have fixed expenses for their fish buying stations because they are leasing dock space from the Port. Some buyers come in and work from their trucks and can pay more for the fish because they don't have the lease expenses. Commissioners listened to the comments and then directed Anderson to research the way other ports handle this problem. Commissioner Bob Mielenz will work with Anderson to prepare a sample resolution or ordinance outlining fees for non-tenant fish buyers and present it to the rest of the commissioners at the next meeting.

Commissioners also approved an addition to the NorCal lease agreement and received a status report on the clean bill of health for the port property at 5th Street and Harbor Drive. DEQ has promised to issue their findings soon. Commissioners urged Anderson to send a letter to DEQ stressing the need to get the hole filled as soon as possible.

Anderson announced that \$651,000 is in the budget for dredging in Port Orford. If the budget is passed without changes to the allocation, it should provide enough money for winter dredging by Nehalem Dredge and for a clamshell dredge to come in this summer.

Commissioners also approved Resolution 2005-8 regarding annexation of a specific area to the Port District. Commissioners were dismayed to learn the crab season might not open until January on the south coast. There was a lot of discussion about ways to keep large boats from up north from coming down and cleaning the crabs out of the area when crabbing is allowed. If the State closes the area, our fishermen will be allowed to crab for 30 days after the area is opened without competition from outside boats. Anderson will work with others to convince the State to take these steps if necessary and avoid a repeat of the problems encountered two years ago.

Evan Kramer spoke about using the upstairs part of the cannery building for art shows. This later proved to be infeasable at this time.

Although the Port has enough money to make a back payment on the loan from OECDD, commissioners decided it would be best to see how the crab season works out before making the back payment.

#### **Needs and Wants**

The City of Port Orford has selected a planning team to assist the City in determining the citizen's needs and wants for the southern area of the City. This area includes the Highway 101 corridor, Battle Rock City Park, the port facility and residential and commercial properties in the vicinity.

The City accepted the bid of Shoji Planning and Development, LLC, a Coos Bay firm that has specialized in facilitating meetings and developing plans on the coast and in southwestern Oregon for more than nine years. In addition to project manager and facilitator Crystal Shoji, AICP, members of the planning team include Laura Greathead, land use planning consultant from Gold Beach, Hilary G. Baker, design specialist with Crow/Clay & Associates, architects headquartered in Coos Bay, and Chuck Nordstrom Nordstrom Land Use Consulting, LLC in Langlois who formerly served as Curry County Planning Director and Port Orford City Planner.

This project is to gather input from property owners and others to determine if there is a desire to update the City of Port Orford's Comprehensive Plan for that area of the City. Because Port Orford's plan has not been updated for more than 25 years, the Department of Land Conservation and Development provided a grant to the City to carry out this public involvement process. This project provides an opportunity for the citizens to review current plans and determine where changes may be needed. If it is determined through this process that changes to the plan will help the City capture opportunities for the future, the City can then apply for a grant to complete amendments to the plan in the new fiscal year.

Three public workshops will be scheduled to take place January-May 2006.





# Garrison Lake Restoration

The Garrison Lake Restoration Committee held its first regularly scheduled meeting on Wednesday, November 23 at City Hall at 5:00 pm.

Six of the seven committee members were present. State Parks Manager Frank Eckley was not in attendance. There were about a half-dozen audience members including Harry Hoogesteger and Cindy Myers from the South Coast Watershed Council, who gave helpful input during the meeting and Harry gave a presentation on the overview of the County Watershed Master plan.

Chairman Dennis Miller called the meeting to order on time and got right into the agenda, which had nearly a dozen items.

The highlights of the meeting included:

• The committee had a discussion on finding the exact location of the Pinehurst intake pipe in the lake and looked at and discussed a map of the sewer locations within the city.

- A discussion on the strategies of funding and consideration of becoming a 501c3 non-profit corporation. The pros and cons were discussed and Mike Murphy, who was representing the County, said he would talk with the County Counsel, Gerald Herbage, and get a reading from him. Ed McQuade will also consult a local attorney, Howard Lichtig, for an opinion.
- Other forms of funding including grant opportunities were discussed by the committee with Cindy Myers, who has many years of grant writing experience for the Watershed. Myers talked about long timelines and unusually strict guidelines. Myers has already helped start a DEQ 319 grant for Garrison Lake, but it will not be submitted as it was not a comprehensive plan, which is what DEQ really wanted.
- It was unanimously decided to give the Chairman voting rights and to increase the committee size to nine to accommodate two additional groups who are interested in joining the committee, ODFW and the Confederated Tribes.

- Harry Hoogesteger gave a presentation on the overview of the County Watershed Master plan, which includes Garrison Lake as well as other bodies of water in the county. Harry said the plan would be very comprehensive and include 18 separate sections dealing with estuaries, wetlands, fish resources, landfills and recycling, agriculture and forestry and a host of other areas.
- Dennis Miller said he had spoken to Mary Pfauth at the Center for Lakes and Reservoirs and she was sending two signs for Garrison Lake. The signs are caution and warnings about the snails in the lake and the ability for them to be transferred to another lake if people don't wash off their boats and trailers. Snail infestation is one of the areas the committee is trying to address in the development of a lake master plan.

There will be no meeting for the month of December. The next meeting of the committee will be on Wednesday, January 18 at 5:00pm at City Hall. The meetings are open to the public and the committee has a website, www.garrison lake.org.


#### **Medical Fundraiser**

Make sure you select a sturdy box, preferably with no writing on the outside other than the names and addresses of the sender and recipient. Do NOT uses boxes that formerly contained alcoholic beverages, or hazardous materials such as bleach, cosmetics, aerosols, etc, or you will be required to totally obliterate these markings from the outside of the box. We sell several sizes of boxes and have free Priority and Express boxes if you are

Cushion contents with bubble wrap or Styrofoam peanuts. If you are sending something very fragile, use the box-with-in-a-box system, with cushioning between the boxes as well. Stuff glass and fragile hollow items, like vases, with newspaper or packaging material to avoid damage due to shock, and wrap glass from picture frames separately so that should it break, it will not scratch the photograph or art work.

Put a slip of paper inside the package with the names and addresses of the sender and recipient, in case for some reason the outside address gets obliterated. Address the outside of the box on ONE side ONLY to eliminate possible confusion. Make sure to have first and last names, not just Mom and Dad, etc. and complete addresses, including apartment, unit, or space number, as well as correct zip code, to avoid possible delays in delivery.

Brown wrapping paper in NOT recommended as long as the addresses on the outside of the box can be easily located and read. We recommend that you do NOT use holiday wrapping paper on the outside of the box, as it is easily torn. Our preference is that you write names and addresses directly onto the box itself.

Use tape designed for shipping, not electrical tape, masking tape, or cellophane tape, etc. Again, we sell a good packaging tape. Do not wrap packages with string – the string can catch on the conveyor belts in our processing system.

[Editor's note: Most of these packing tips apply to UPS shipping as well.]
