### Give It Up for ODOT

I have to hand it to the Oregon Department of Transportation on their handling of the Rocky Creek landslide. They held a press conference at the site where the southbound lane had fallen off to the seaward side of the hill on Tuesday January 3, at 10:00am. After letting the television and print journalists take lots of photos and Ray Cranston conducting a brief interview the crew from LTM Corporation rolled up their sleeves and went back to work. The goal: reopen one lane of Highway 101 two days later at 8:00am on Thursday, January 5. ODOT paid LTM approximately \$70,000 to get the job completed and LTM worked around the clock and the mission was accomplished.

One lane of Highway 101 reopened and allowed traffic to again move north and south, alternating between northbound and southbound traffic. The one lane area will be operated with flaggers 24 hours a day, seven days a week. The average delay has been three minutes or less.

On Sunday Honeybear and I drove down to try out the dip, as the road at the Rocky Creek fill has been lowered by 15 feet and we had very little wait going south-

bound and northbound. The temporary road had a nice bed of asphalt on it and was wide enough not to feel like you were at the edge.

ODOT officials made a commitment to the people of the south coast and the trucking industry to get Highway 101 open by Thursday morning and they honored that and are to be commended. The next step is working on a more permanent two lane fix. ODOT has committed to getting that done by spring break of this year with the least disruption possible.

Jared Castle and Lee Sparks from ODOT stopped in on Tuesday on their way to city hall to talk about the fix. Currently a contractor is drilling for core samples of the fill to determine what it is composed of and the condition. If ODOT has to remove all of the fill where the highway slid they would have to remove 50,000 cubic yards of material which equals a 28 mile long stretch of 10 yard dump trucks. Then, to put that much fill back would require another 28 mile stretch of 10 yard dump trucks. The culvert that Rocky Creek flows through under the fill has failed and needs replacing. Castle said he expected ODOT to make an announcement in February regarding the long term fix for the Rocky Creek slide.

ODOT has made it a point to get the word out that Highway 101 would be reopen on Thursday morning which is why they held the Tuesday and Thursday morning press conferences. They got the word out in the bigger papers like the Oregonian and Eugene Register-Guard. They also had reader boards on Highway 101 north of Port Orford and on Interstate 5 on Thursday notifying the motoring public that 101 south of Port Orford was **OPEN**. ODOT officials estimated in one of their press releases that the economic impact to this region from a Highway 101 closure at \$500,000 per day "based on increased travel times and transportation costs."

There are several other trouble spots south of Milepost 303 where Rocky Creek is located including the Rocky Point parking area which has seen some sloughing off and south of there where the highway is dropping and needed an asphalt fix on Monday by ODOT crews.

## Garrison Coastal Lagoon Outlet Opened

Oregon State Parks and Recreation Department hired contractor Joe Marsh and crew to re-open the Garrison lake/lagoon outlet last Thursday and they were successful but so far the water level has not receded very far. State Parks Manager Frank Eckley told us that Marsh and crew worked on the opening on Thursday and finished their work on Friday. On Monday he estimated the lake had dropped one foot but all night Monday and into Tuesday it has been raining. Eckley said he was very "impressed" with their work and that the beach really looks good thanks to the sand build up at Agate Beach. He was also impressed with the flow volume through the outlet.

For the time being Twelfth Street at the boat ramp and Arizona Street between Madrona and Geer Circle remain closed because of high waters.

## Police Report By Chief Mark Creighton

01-04 Police responded to Hamlet in Port Orford regarding a dog at large. Police determined the dog's owners were not home, and animal control could not respond to seize the dog because of the slide at Rocky Point. When the officer started to leave the area an additional dog walked up to the officer in the middle of the street, obviously to turn his owner in for permitting him to also run at large. Both owners were later contacted, counseled, and given warnings for permitting their dogs to run at large. Remember: It's not the dog's fault for being out of the yard. They can't read.

01-04 Police were contacted by Gayle Wilcox regarding a male subject walking on Highway 101 down the center of the road acting unusual. When police arrived, Fire Chief Gayle Wilcox and Assistant Fire Chief Wade Phillips were both on scene holding the male subject up. The Officer used the police vehicle for a place for the subject to sit while he received a medical evaluation. An ambulance was contacted and the subject was

transported to the hospital for immediate medical assistance. Upon interviewing several people, police determined the male subject had been flagging at Battle Rock. He began to act strange by waving the flag, and walking down the center line on the highway. Several people stopped, yelled at the man and threatened to turn him in to ODOT. One person took photos of him to send to ODOT as evidence. Thanks to the fast actions of Gayle Wilcox and Wade Phillips the man's life was probably saved. Thank both of you for living in our community. NOTE: if you're driving along and see someone acting unusual you might just save their life by calling 911.

01-05 Police received information from a mother that her daughter had been talking to a male subject (Age 17) in New Hampshire via the internet. After they got acquainted over some time, the 16 year old female was contacted via the internet by the subject's friends who told her that her friend had died, and they wanted her to have her mother fly her to another state so they could take her to the

funeral. Police contacted a New Hampshire Police Department where the subject was supposed to be living, and no one with that name existed. NOTE: Port Orford Police are coordinating with the New Hampshire Police Department to identify the person or person's involved in this suspicious act. That Police Department has reported several similar cases and is assisting our agency with an investigation. If anyone knows of any similar contacts via the internet with children, please report it to the Port Orford Police Department at 332-9013. If you reside in the county contact the Sheriff's Office at 1-800-543-8471.

01-06 Police responded to Washington and Sixth Street on a report that a vehicle stopped momentarily, two possible gunshots were heard, the rear passengers window shattered, and a male subject dove out the back door, and walked away as the vehicle sped away. The subject appeared to be injured. Police investigated the incident and determined no gunshots were fired. The male subject had broken out the window and exited the vehicle on his own. Police were not

able to locate the male who had a restraining order not to contact the female driver in the vehicle he jumped from.

01-06 the male from the previous call came to the police department with a female to turn himself in. He appeared to be injured from the fall, and an ambulance was called to the police department. The accompanying female became disruptive, and was detained. Ambulance personnel arrived and transported the male to the hospital for his injuries. ## Letter to the Editor,

This letter responds to Werner Buehler's recent "Dear Member" letter in the Ruralite. It concerns CCEC's responsibility for control of noxious weeds-particularly Gorse - in its right-of-way.

Our organization has regularly gathered as a voluntary effort annually in the spring as "Gorse Busters," to control Gorse throughout the watershed. We have worked in cooperation with the South Coast Watershed Council. Because of these efforts, this watershed is relatively free of Gorse infestation.

Gorse is an exotic, noxious weed, recognized by the Oregon Department of Agriculture as one of the prime weed species affecting the Oregon landscape. It is especially aggressive in the CCEC right-of-way - a prime avenue for Gorse invasion into new areas.

CCEC's past efforts to keep the infestation from progressing have fallen into

neglect under your administration - as is obvious in the right-of-way corridor from Elk Creek to Crystal Creek along Highway 101. Accordingly, we request the following:

1. Designate appropriate staff to attend the Curry County Weed Advisory Board's "stakeholder meeting," January 11 at the Sixes Grange from 6:30-8:00pm for further information regarding Gorse and suggestions for CCEC's role in its control.
2. Promptly direct appropriate staff to devote resources this year to control the advance of Gorse in the CCEC right-of-way between Elk River and Crystal Creek Road this year.
3. Seek funding from the Oregon State Weed Board to support a permanent program for control of Gorse in those CCEC areas where control is still feasible, such as the right-of-way discussed above.

4. Include in the CCEC's annual budget a regular line-item allocation of funds to control state-recognized invasive plant species within CCEC's rights-of-way.

If CCEC fails to address this problem, as a legal matter it will be in direct violation of Oregon state policy.

## New Electric Meters

Late last year, Coos-Curry Electric Co-operative selected approximately 200 members living in the Gold Beach area to participate in a project designed to test the effectiveness of a new, automated meter reading (AMR) technology.

“We are excited about this pilot project and the whole AMR technology,” said Werner Buehler, General Manager/CEO of the cooperative. “The last couple of years have been full of changes for CCEC. We’ve worked hard to manage local and regional challenges that are part of an ever-evolving electric utility and to control the costs that are associated with those changes. This project fits well with our desire to improve service and explore more cost-effective ways of doing business to improve our financial bottom-line on behalf of the entire membership.”

The pilot project crews have replaced approximately 170 meters served out of the Geisel substation with the new electronic meters. The majority of the meters replaced are in the area of Lobster Creek up to Mahe with others strategically placed along the remaining lines. Part of the installation work includes making changes to the communications system at the Geisel substation, which serves that area. Once the new meters are installed and substation work is completed, the technology will provide a communications infrastructure to transmit data and give CCEC the ability to read meters and monitor outages and voltage levels more effectively from remote locations. Monitoring outages becomes even more important during winter storms like those experienced the past couple of weeks. With AMR also comes the ability to reduce the cost of fuel and other costs associated with monthly meter reading activities and allow CCEC to better utilize its labor resources.

Members will receive more accurate billings for a number of reasons. First, the

AMR meters record electric consumption with 100% accuracy, unlike traditional meters that may have been in place for many years. In addition, with the new AMR meters, electric bills will be based on exact readings instead of estimates – every month. And, those with the updated meters will have daily consumption records that will help them manage their own energy loads.

“We decided to do a pilot project as a way of gaining experience with the new equipment and technology and, more importantly, to use the results of the pilot program to test our assumptions with regard to the costs and benefits we have projected for the entire program,” Buehler indicated. The costs for a system-wide installation are expected to be \$5.3 million with a payback in 5 1/2 years and an overall 10-year savings of approximately \$11 million. “If the pilot project meets our expectations, we will continue to install the new technology throughout the entire CCEC service territory.”

Training for the employees assigned to the AMR program is being conducted in the field at the same time the new meters are being installed and focuses on electrical safety as well as the AMR technol-

ogy. During this training period, members should expect to see more employees than normal in the field as CCEC prepares them for the pilot project phase and to continue on to the next stage of the AMR program if the pilot project results are as expected.

and a Eugene medical laboratory last week to make sure that urgent blood supplies and patient samples got where they needed to go – on time.

Kathy Furman, the hospital's medical lab director, said the road closure at Rocky Point south of Port Orford posed at least three problems.

First, she said, the hospital customarily gets its supply of blood from Bay Area Hospital in Coos Bay via the American Red Cross out of Portland. With Highway 101 closed, the Red Cross arranged to deliver supplies to the hospital from Rogue Valley Medical Center in Medford, Furman explained. She added that Curry General orders up to four liters a week.

Secondly, with the highway closed, the hospital was not able to send specialty tests to its Eugene laboratory. Tests such as hepatitis and some viral and bacterial cultures customarily are couriered to the Oregon Medical Laboratory (OML). "OML contracted with a courier from Brookings to pick up our samples and fly them to Eugene," Furman said.

Thirdly, the hospital was unable to receive blood samples from Curry Family Medical in Port Orford, for testing at the hospital lab. Furman said an OML courier took those samples north to Eugene, instead.

"The storm posed a lot of challenges," Furman said. "We always depend on going north instead of south for our testing and supplies. So it was great to develop contingencies."

Additionally, the highway closure prevented Curry Family Medical physician, Tom Pitchford, M.D., from traveling to his office, Tuesday, Jan. 3. The clinic's Sandra Johnson, F.N.P., however, was able to slip through the detour route over China Mountain before the detour also was closed. Unable to drive home, she spent the night in a Port Orford motel and saw patients throughout the closure.

## Where the Buffalo Roamed

The Point Orford Heritage Society is pleased to sponsor an Oregon Chautauqua program by Dennis L. Jenkins of the University of Oregon Museum of Natural History entitled *Where the Buffalo and the Camel Roamed: Oregon's Earliest High Desert Occupants*. This free, public program will take place on Sunday, January 22, at 2:00pm at the Port Orford Christian Center, 915 Washington Street, Port Orford.

Dennis Jenkins draws on his years of experience with over fifty archaeological investigations in central Oregon to illuminate the questions surrounding the earliest occupants of the High Desert region.

In the 1930s, Luther Cressman's excavations in Fort Rock Cave, Catlow Cave, and the Paisley Caves lead him to postulate that people may have lived there as early as the Late Pleistocene era.

Unfortunately, few other researchers accepted his excavation results or interpretations. Later work at the Fort Rock and Connley Caves by Stephen Bedwell suggested that they were occupied 12,000 years ago, but the tantalizing question remained whether the archaeological data supported an even earlier date for human occupation.

For the past three years Dennis Jenkins has directed reinvestigation efforts at the Connley and Paisley Caves. He discuss-

es the process and results of his investigations, bringing audiences the most up-to-date information about the two oldest known sites in Oregon.

Mr. Jenkins's program is made possible by funding from the Oregon Council for the Humanities, an independent, non-profit affiliate of the National Endowment for the Humanities. OCH is dedicated to providing opportunities for lifelong learning in communities throughout Oregon. For more information about OCH or Oregon Chautauqua, please call Carol E. The early fire board members saw the need to establish an extensive fire station on the Elk River strategically located for emergency response time.

The fire district has since then achieved many pieces of apparatus for mobile water carrying fire safety equipment. This equipment was made available through many hours of work by our volunteer firemen and Fire Chief George Gehrke and others past.

Now comes the new idea of completely stripping the new Elk River Station leaving not one piece of fire fighting

equipment able to respond out of the Elk River hall.

I will not finger point, my only goal is as follows to try and persuade the Rural Fire District board a serious mistake of judgment has been made. A large sum of tax dollars is saved and available for improvement purchasing. ### County Commissioners Report By Molly Cooley

Curry County Commissioners held a special meeting with the Fair Board on Monday January 9. The entire volunteer Board was in attendance. Commissioner Ralph Brown, who is a Fair Board Member, began the discussion with a summary of the current situation.

The Fair Manager, Tom Amsden, who has been working half time, resigned, and will not be working after next week. The Fair Board needs an interim person to keep the office open while they go through a formal hiring process. They want to get a loan from the County General Fund so that they can eventually hire a full time director. The County Fair, as a week long event, has shrinking revenues. The Fair Board recognizes that a full time manager is needed to develop a year round schedule of revenue generating events. All the money the Board made this year has gone into building maintenance, so they have no money left to spend on running events and programs.

Sharon Mitchell, Fair Board Chair, described some of what the Board members

learned while attending this year's Oregon Fair Association. She said that Josephine Co. has over 1500 events each year at their Fair Grounds compared to between 40 and 50 at Curry County's facilities. She said, "We are missing the boat by not using our Equestrian Facilities for horse shows." The Fair Grounds in Albany has an equestrian event every week in the year, and they generate revenue for the whole community. Mitchell said having our equestrian facility right next to a beach was unique in the state. Board members were advised by other Fair Boards to take advantage of the opportunity to offer beach rides during equestrian events.

The Fair Board agreed that the Fair Grounds should be seen as an economic development opportunity. They said they needed more accurate information about how much it cost to operate each building, so that they could gauge how much to charge in rent. Their last in depth business plan was done seven years ago, and, even at that time, there was an estimated two million dollars worth of deferred maintenance on the Fair Ground buildings.

Board Member Linda James said that in the past when the Fair had a full time director there was also an office assistant on staff. This enabled the Director to get out into the community to make contacts and get sponsorships while the assistant answered phones, did mailings and handled walk-in requests.

Commissioner Schafer said the Fair Board should come up with a specific proposal about how much money they needed to borrow from the General Fund. County Finance Manager, Ken McCann told the Commissioners that the Fair Board needed help in clarifying their expenses and revenues before they could come up with either a loan proposal or a new Business Plan. It was agreed that McCann and County Counsel, Jerry Herbage, would attend the Fair Board

meeting on Tuesday evening to assist them in their work.

In other business, the Commissioner's heard an explanation from Dave Pratt, Planning Director of a letter he had written to the Brookings City Commission in answer to questions they had raised about the Harbor Annexation activities. The Commissioners approved the letter with minor changes.

Commissioner Shafer brought up a suggestion she had received that the county explore creating an Urban Renewal District in South County to help with storm water drainage issues. Pratt said that he had considerable experience with Urban Renewal projects and would be happy to help her investigate the possibilities further.
