Thanks to Ed and Jerry By Evan Kramer

The Port Orford City Council met on Monday night, December 18 and that meeting marked the end of the council terms of Ed Beck and Jerry Steinhorst. Each man served one four year term of office and chose not to run for another. They will be replaced on the council by Jake Marshall and John Hewitt on Wednesday, January 3.

Parks Commission member Mark Murray read a letter to councilor Steinhorst thanking him for his work as city council liaison to the parks commission and presented him with a certificate of appreciation.

Councilor Steve Abbott spoke about the planning commission and said it was the sole province of the city council to appoint members to that commission. He said he wanted the process of appointing planning commission members open and fair. Abbott made a motion to remove item 8B from the consent calendar (appointment of several people to the planning commission and the budget committee. Councilors Beck, Jim Campbell and Abbott voted yes while Milton Finch, Carl Eskelson and Steinhorst voted no. Mayor Jim Auborn voted no to break the tie.

Citizens concerns began with city recorder Beverly Manes reading a letter from Nella Abbott to the council regarding the planning commission. She was not present but left directions that Mayor Auborn was not to read the letter. The full text of that letter was in last week's edition of the Port Orford News. It had to do with how the city council is supposed to make appointments to the planning commission. Her letter was written in support of "legal, honest process and smart growth for the community."

Pat Buffington said the council needed to appoint a well rounded group of people to the planning commission. John Hewitt said he hoped the council worked towards a more open and honest government. He said the council appoints the planning commission members and that the council should look at all the applicants and review them. Hewitt made it clear he was talking about the "process" and not the integrity of the people. Paula Cracas spoke and referred to the good old boys network.

Mayor Jim Auborn said the process for picking new members for the planning commission had included advertising the openings in the newspaper. He said people had sent in letters of interest and that he then spoke with them. Auborn said he doesn't appoint people to the planning

commission, he nominates them. He said he had discussed the nominations with the council personnel subcommittee.

Councilor Steve Abbott told the mayor that the council couldn't abdicate its responsibilities. He said Auborn wasn't totally truthful in what he was saying and called the process "legally flawed."

Councilor Abbott was referring to city ordinance 2.16.020 regarding the planning commission where it says that "members of the planning commission shall be appointed by and serve at the pleasure of the city council." The City charter says the mayor shall appoint the committees provided by the rules of the council. City attorney John Trew later on in the meeting told the council he had looked into the planning commission appointments and that they serve by and at the pleasure of the city council.

Jerry Steinhorst told city administrator Mike Murphy that they were doing a good job with the water treatment plant

but the whole system needed to be upgraded. For the month of December 6,576,000 gallons of water were produced and 3,383,000 distributed to city water users. Still a huge lost of water going on monthly.

Attorney Trew read Ordinance 2007-01 (vacating a portion of Eighth Street in exchange for the old jail partition. Jim Campbell then made a motion to adopt the Ordinance and it passed by a 6-0 vote and goes into effect in 30 days. Baring any problems with the title company the old city jail will become city property by January 18, 2007 after a long struggle.

The council passed a motion designating Crystal Shoji as the city planning director for a term of one year. They also passed a motion with changes to the city business license. It now "reflects" that business owners will be in compliance with all state and city ordinances regarding the operation of their business.

The council discussed the now temporarily closed city burn pile on Port Or-

ford Loop Road. Mike Murphy said there had been many complaints about it due to the smoke coming off it. He said it was closed now until the brush could dry out. Councilor Steinhorst recommended that the city chip the brush rather than burn it and the people at the meeting liked that idea. Mike Murphy talked about the cost of chipping the brush saying it would take two employees and spoke about costly damage to the chipper blades if people put metal in with the brush. The council will keep the temporary closure going but put it on their agenda as a continuing action item.

The council approved the consent calendar items under election proclamation and the minutes but took on the appointments to the planning commission separately. The voted to reappoint Joyce Kinney and Dave Holman by a 6-0 vote and then by three 5-0 votes with one abstention they voted to put Bill McArdle, Eric Oberbeck and Micki Snyder on the commission. Councilor Abbott abstained on all three votes.

Mike Murphy said the city public works crew was down to three people due to one person being on vacation. He said Rick Rogerson, Larry Dell and Chris Kjemperud were doing quite a bit of work. He said the public works crew was understaffed and underappreciated. [Editor's note: We appreciate you!]

Councilor Abbott thanked Ed Beck and Jerry Steinhorst for their time on the city council.

The next council meeting is on Wednesday, January 3, 6:00pm, when the new councilors will be sworn in.

Hundreds of community members and people from outside the area packed the Sixes Grange Hall to capacity, filled the dining area and stood outside during the hour and a half service.

It began with the playing of Amazing Grace on the bagpipes. Leesa Cobb told the people that the families of the fishermen thanked them for coming to the service. She also thanked the Curry County Sheriff's Department and Search and Rescue for their rescue efforts.

Fishermen Darrel Cobb rang the bell for each of the four fishermen as Orion Ashdown tearfully and emotionally read the names of each of the four fishermen including his brother Rob Ashdown, Mark Wagner, Louis Lobo and Joshua Northcutt.

Pastor Doug Jamieson spoke about three of the fishermen. He said Louis Lobo was the newest member of the F/V Ash fishing crew. Jamieson said that Lobo had a smiling personality but the past three years had been hard on him. He had moved to Gold Beach from Las Vegas to be nearer to his mother and wanted to be

part of a fishing team. Jamieson said that Lobo had found people who loved and accepted him. Jamieson said that Joshua Northcutt had been through hard times recently but was turning things around and determined to help raise his month old daughter.

Pastor Doug described Mark Wagner as "big Mark." Wagner had become a father within the past year. Jamieson then invited people to speak about the four fishermen.

Mike "Cappy" Ashdown spoke about his son Rob who he said had fished in Port Orford for 20 seasons. Ashdown thanked the people of Gold Beach including Sheriff's Department, Search and Rescue and the Coast Guard for their rescue efforts. He thanked the Port of Gold Beach for welcoming Rob and his fishing boat. He said Louis Lobo was very humble and polite and that Joshua Northcutt was like another son. He said Rob could count on Mark Wagner as the second in command of the fishing boat. Cappy described his son Rob as a wonderful person who was continually growing and learning. He looked out at the hundreds of people in attendance at the service and called them the real Oregon and said he loved all of us.



Peri Rask described her and her husband John as Mark Wagner's best friend. She said Mark knew how to live and was friends with everybody. She reminded us of Mark's loud and infectious laugh that accompanied him.

Joshua Northcutt's father talked about his son being the father of a new baby. He was happy his son had found a great town and people that he loved and trusted.

Rob Ashdown's mother Brenda Scwartz spoke about a cell phone message she discovered from her son in the past few days. She thanked the people for loving her son.

State Representative Wayne Krieger offered to help the families.

There was music interspersed with the spoken words and a particularly moving rendition of Van Morrison's "Into the Mystic" sung by George Robson.

Louis Lobo's sister called her brother the most compassionate person she had ever known. She said their family would hold a memorial service for Louis in Las Vegas.

An honor guard of three firefighters rang the bells that called firefighter Rob Ashdown home. Fire Department chief Gayle Wilcox ended the service with the reading of the poem, "An Irish Blessing." By that time countless tears had been shed inside the Grange Hall and were continuing to flow. The feeling of loss was very strong in the room.



Dredging Tops Port Agenda By Jay Stoler

With a possible opportunity to remove the shoaled sand from under the hoist at the Port of Port Orford via drag line, the Commissioners gave manager Gary Anderson the go ahead to get things rolling. This subject had been the focus of a two hour special meeting last week aimed at finding some kind of workable way for the Port to dredge itself. The option of using a clamshell to pump sand over the jetty, or to the other dump site, was ruled out. However, the idea of going back to drag line dredging, something done in the distant past, and having the sand transported away seemed to appeal to the Commissioners, who are under a lot of pressure to keep the Port operating.

Port manager Gary Anderson reported that he has been in touch with several possible dump providers and is looking into the permit process, which could take up to 200 days according to the Department of State Lands (DSL).

Commissioner Ed Dowdy said the arithmetic on the number of dump truck loads is very high and he wondered how that

could be facilitated.

Fisherman Scott Mecum and fish buyer Tony Cottor said in the past it had been done and did not create that big of a traffic problem.

Mecum said, "We need help. We got through the building of the dock. We can get through this."

Ed Dowdy agreed, but said the problem needed to be clearly defined for outside agencies to help us.

Commission Bob Milenz wanted to have an engineering company come in and help define that problem for us, as well as a solution.

The Commission gave manager Anderson a lot to work on in getting the logistical questions to the plight answered. Anderson said he would continue to keep things moving in the direction of a solution.

In other Port news:

• A moment of silence was observed for the four lost fishermen, then Evan Kramer made a motion to donate \$2,500 to the fund set up at Chetco.

- Ocean Resource Team director Leesa Cobb spoke on several subjects. Starting out with an endorsement from County Commissioner and fisherman Ralph Brown for Port Orford as a better location than Gold Beach for a research facility, one of the main goals of the Ocean Resource Team. In addition, there was a document with a list of opportunities and reasons for Port Orford as the choice selection. Endorsements were also enclosed from the Pacific Marine Conservation Council Science Director, Jennifer Bloeser, Gil Sylvia a professor of Marine Resource Economics at the Hatfield Marine Science Center and Jim Golden a marine consultant. This subject will be a continuing item and issue on the Port agenda.
- Leesa also presented a proposal to designate one of the available product hoists as a public hoist. Cobb presented examples from five near by ports including Bandon, Charleston, Brookings, Florence and Newport. The next step would be a committee to study the issue with a Port Commissioner, Ocean Resource Team, and fisherman.
- Gary Anderson discussed his upcoming trip to Washington DC and all the visits he will be making on behalf of the Port. County Commissioner Lucie La-Bonte will also be along on the same trip.

Legal Size Lowered

The Marine Sport Fishing Regulation will change the minimum legal size for lingcod from 24 inches to 22 inches, and add in a separate daily bag limit of 25 for flatfish, which includes flounders, soles, sand dabs, turbots and halibuts, but not Pacific halibut. All changes are effective Jan. 1, 2007.

The change for a more liberal minimum size limit for lingcod is due to a new federal stock assessment indicating the northern population of lingcod has rebuilt. The stock's improvement from depleted status to healthy numbers also

allows the lingcod sport harvest cap to be eliminated in 2007. The separate bag limit on marine flatfish will allow

Other changes to the 2007 Marine Sport Fishing Regulations include additional measures to protect yellow eye and canary rockfish by limiting fishing for certain species in the Stonewall Bank Rockfish Conservation Area (all year) and seaward of the 40-fathom curve (from April 1 to Sept. 30).

Letter to the Editor,

Chief Creighton elected in last week's "Police Report" to complain that two of my decisions as the Port Orford Municipal Judge were "callous and insensitive."

All of my decisions are supported by a written memorandum to the City Council and are a matter of public record. It would not be good government to engage the Police Chief in the press. However, his facts are wrong. The citations he refers to - out of more than 50 citations - were not "dismissed" for the reasons he incorrectly cites. One, a Southern California driver's September 22 citation, was not dismissed at all; only the fine was reduced for a refund of \$31.25. The other, a Canadian driver's October 8 citation, was dismissed because the officer's "affidavit is defective." Neither of these occurred in the school zone.

Historically, the police always resent judges. That is a result of our system of government – based on law, not arbitrary power. I will continue to decide cases on the law, not the whim of the police.

If Chief Creighton has concerns about how I discharge my Municipal Court responsibilities, he knows how to contact me.

Formatting Word Documents by Valerie Jean Kramer

Using proper formatting makes it much easier to modify a section of your document without messing up the rest of it. Here are a few simple tips.

You can't control what you can't see. On the menu bar, go to Tools, Options and under "Formatting marks" check the "All" box.

Vertical spacing can be set on the Format, Paragraph menu. You'll usually use 0 pt, 6 pt or 12 pt (0", .083" or .167") in the Spacing Before or Spacing after box. Avoid mixing both kinds of spacing in one document. "Page Break Before" on the "Line and page breaks" tab of the same menu forces a given paragraph to start at the top of a new page. Another way to force a page break is to use the menu Insert, Break, Page Break.
