### Filing Deadline Nears By Evan Kramer

The filing deadline for the May 18 primary election is on Tuesday, March 9, 5:00pm and the race is on.

There is one county commissioner position up for election this year in the seat occupied by Georgia Nowlin. As of Monday, February 22 three people have filed for the job including Brookings businessman David Itzen, Port Orford City Councilor David Smith and former county commissioner Lucie La Bonte. All three are running in a race that is for the first time non-partisan with no party affiliations attached to the candidates. If any candidate gets 50% plus one vote there will be no runoff in November. If not the top two vote getters will face off before the voters. La Bonte has served two terms as Curry County Commissioner and went off the commission two years ago but has decided to try for a third term. She is the only local candidate who has gone the signature petition route in filing for office. It requires 100 valid signatures from County voters to qualify for the ballot and she turned in 108 to the Elections Division according to the Curry County Elections Department as of February 23. Councilor David Smith is attempting to not only win the race for himself but be the first

person to represent North Curry County on the commission since Port Orford resident John Mayea in the late 1980's.

Other races of note are for Oregon State Representative District #1 with incumbent Wayne Krieger having filed to run for another term in the Republican primary. As of February 22 no one has filed to run against Krieger in the Democratic Party primary.

Jayne Germond has filed for the Republican nomination to run against Representative Peter DeFazio for the Fourth District Seat in the United States House of Representatives. DeFazio hadn't filed as of Monday but is expected to before March 9. Congressman DeFazio has served 12 terms in the Congress and is the Chairman of the House Subcommittee on Highways and Transportation. He lives in Springfield and loves this state so much he flies home most weekends from Washington D.C. It had been hoped by many that DeFazio would run for Governor this year but it wasn't meant to be.

The much coveted position of Governor of Oregon is bringing out lots of candidates. Bill Bradbury, John Kitzhaber, Roger Obrist and Steve Shield filing to run in the Democratic primary while Allen Alley, Chris Dudley, Bog Forthan, John Lim, Bill Sizemore and Rex O.

Watkins have filed in the Republican primary. They are vying to replace two term governor Ted Kulongoski who is term limited out of office after this year.

The non-partisan office of Superintendent of Public Instruction has two candidates running including incumbent Susan Castillo and challenger Ron Maurer.

Later on this year Port Orford voters will decide on two council races as well as the position of mayor but that won't happen until the November general election.

### Port Orford a Dark Sky Town

It's official now. Port Orford has become a Dark Sky city after last Thursday evening's city council meeting. The city council unanimously voted to pass the Dark Sky Ordinance 2010-01 at the second reading on February 18. The council added some language to the Ordinance as presented at the first reading two weeks prior and it goes:

"Any and all franchised or leased mercury vapor style security lights served

by Coos Curry Electric Cooperative, Inc. or privately operated in the public, private or commercial sectors inside the City limits of Port Orford must be retrofitted with skycaps or replaced with full cutoff fixture, or decommissioned within 18 months after the effective date of this Ordinance." Under section H.1 non conformance, a. was modified to read "Outdoor light fixtures (except mercury vapor lights) lawfully installed prior to and operable on the effective date of the requirements codified in this Ordinance are exempt from requirements except as follows." The Ordinance goes into effect 30 days after the city council passed it on February 18.

**Methamphetamine Arrest**

Larry Gene Klamroth, age 61, was arrested at his residence at about 10:00 am today and lodged at the Curry County Jail on charges of Possession of Methamphetamine, and Delivery of Methamphetamine, based on probable cause

developed during the search warrant executed at his home on 02/18/10. Additionally, at the time of his arrest Klamroth had on his person a small amount of Methamphetamine.

On 02-18-10 at about 6:30 pm law enforcement officers from multiple agencies executed a search warrant at 94695 Laurel Lane, the home of Larry Gene Klamroth, in the Hunter Creek Heights area just outside Gold Beach. The Curry County Sheriff's Office, assisted by Oregon State Police, Gold Beach Police and Brookings Police Department responded to the residence under authority of a search warrant to search for and seize evidence of illegal possession, delivery, and/or manufacture of controlled substances, and all evidence related to such activity. The search produced substances believed to be methamphetamine and other relevant evidence.

Arrested at the scene and charged with Unlawful Possession of Methamphetamine were Heather Michelle Iverson, age 21, and Loretta Ann Hendricks, age 41. Heather Iverson was also arrested

for violating the conditions of her probation. Larry Gene Klamroth, age 61, was not present at the residence and is currently sought by the Sheriff's Office for questioning.

Additionally, the Sheriff's Office initiated an investigation into what appeared to be numerous health and safety code violations on the property. A Code Enforcement Deputy was called out to conduct the investigation concerning possible suspected health, safety, and environmental code violations, which included multiple discarded vehicles, trailers, and recreational vehicles, in varying stages of decay, and other garbage and refuse piled about the property. This information will be turned over to County Counsel.

## Watershed Council Meeting

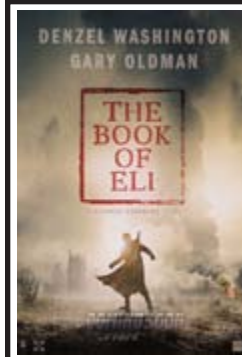
The Port Orford Watershed Council held its regular meeting on Wednesday, February 17th, at the City Hall Council Chambers. In attendance were members Phyllis Johns, Midge Hayes, Joanne Ruoff, Ed McQuade and Steve Taylor, Chair. Also present was Bill McArdle, City Council Liaison.

Ed reported on the blockage in the overflow outlet at Garrison Lake that occurred in the last storm. The lake rose to within a foot of Arizona Street, but the blockage cleared itself and the outlet is working as it should. Ed also reported that he had been in contact with Pam Blake, who manages water quality for the DEQ in the three southwest counties concerning our project to map the septic systems near Garrison Lake.

Steve reported on the Naval Test Range Proposal that was in the news about a year ago. The final EIS has still not been issued. He spoke with the Public Affairs person of the Navy, and they agreed that a better job of outreach was needed to inform the public. According to her, there is little or no activity being proposed off the Oregon coast, and nothing that hasn't been going on for years. Almost all Naval training operations are conducted off the northern Washington coast and in Puget Sound, since that's where all their northwest bases are. She stated that further announcements will be well publicized.

Steve also reported that a letter of support had been sent to the Parks Commission for their grant application for a flush restroom at the 12th Street Boat Launch. In the letter, he proposed that a hose bib be provided to create a wash station for boats, to facilitate compliance with new state directives concerning the inadvertent introduction of invasives like Eurasian Milfoil and Zebra Mussels.

Cathy Boden of the South Coast and Lower Rogue Watershed Council brought with her Emily Brokaw and Au-

tumn Althof, two students from Driftwood School. They gave a presentation about the work the students are doing on the Wetland behind the school, and asked for Watershed Council support in the upcoming Water Festival April 17th. The Council strongly supports their efforts, and will work out a tie-in for the Festival.

Featured speaker of the evening was Briana Goodwin of the Port Orford Ocean Resources Team (POORT), who gave a well-received presentation on the water testing being done in association with the Blue Water Task Force, a part of the Surfrider Foundation. Volunteers gather samples each month from Dog Beach, Battle Rock, Garrison Lake, Hubbard Creek and Brush Creek. These are then taken to Pacific High School, where they are tested for enterococcus bacteria, an indicator of serious health risks associated with septic pollution and/or animal waste. So far, the samples have all tested within allowable limits.

Briana also distributed a very informative brochure done by local writer Carol Hatcherl titled, "Wave Energy and the Southern Oregon Coast." There is currently a great deal of interest in devel-

oping this resource, and the brochure explains the topic and answers many questions about it.

The Watershed Council is seeking new members who are interested in water issues. Those who might be interested should call Steve Taylor at 541-332-0166.

## Letter to the Editor,

Measures 66 – 67 were important insofar that the bulk of the tax, 727 million, would revert to the schools sorely in need of revenue.

But in all fairness it needs to be said that there are small companies comprised of 40 or 50 employees that are experiencing extremely difficult times. Not because there is no demand for their product but rather that foreign made products entering our country tariff-free can undersell anything now made in the USA.

The ironic part is that many diverse items, such as machine equipment, electronics and virtually all food, are produced by US companies situated in China, Mexico, Japan, etc. Who have found a fertile field of cheap labor elsewhere and a government who encourages them to avail themselves of it.

There is no longer a level playing field on our own home turf whereby these vital industries can survive competitively. As a consequence, hard pressed US domestic business owners are combating both the feds, who have opened up the floodgates to foreign competition, and

the states exacting more taxes from their non-existent income. All of which leads either to their foreclosure or pulling up stakes and relocating in a low tax state hoping to outride the economic storm.

Oregon is in no position to lose what remains of its industrial base. But it appears that the powers that be, the governor, isn't unduly perturbed about that aspect of the businesses' survival since he now intimates that the kicker should be done away with, also.

Fortunately, for Kulongoski, he will soon be out of office. Asking to void the kicker is like pouring salt into a raw wound. What's next, Food Stamps? Medicaid?

The point to be made is that our small corporations are tethering on edge. We don't want to lose them. The State must seek remedial measures to alleviate their tax burden. A system of credits should be mounted that would reduce their recent tax spike on a sliding scale whereby those in greater difficulty would receive the most reduction and remediation.

If the State does nothing, thousands of more jobs will soon be lost. Oregon, in that respect, will suffer a major blow

Their very objective from the onset of the heralded Trade Agreements was to totally devastate our own manufacturing and industrial capacity, which has been accomplished. The nation is currently losing 85,000 jobs a month.

The portent of it all is that there will always be a paucity of jobs in the US for as long as our corporations remain in foreign countries. That's where our productivity resides. It took America over a hundred years to build our economic greatness and lose it all in 8 years.

### Redfish Rocks Update

The Redfish Rocks Community Team has been up and running since December. The purpose of the Team is to collaborate and develop recommendations for Redfish Rocks, considering biological and socioeconomic information, and to serve as liaisons to the community on matters regarding Redfish Rocks.

The goals of the Redfish Rocks Marine Research Reserve and Marine Protected Area, as established by the Team, are to:

- 1) Protect and where necessary, restore the natural habitats, ecological services and biological communities of Redfish Rocks Marine Research Reserve and Marine Protected Area to enhance resilience of nearshore ecosystems to natural and human-caused effects;
- 2) Enhance public awareness, understanding, and appreciation of the marine environment, the land-sea connection and the natural, historical and cultural resources of Redfish Rocks;
- 3) Support, promote, and coordinate scientific research on, and long-term monitoring of, Redfish Rocks;
- 4) Minimize significant adverse social and economic impacts on ocean users and the Port Orford community;

5) Provide opportunities for economic development around research, education and non-disturbing activities.

The Team has established four working groups to conduct the more specialized work of the Team. The working groups are Biological Science, Social & Economic, Outreach & Education, and Enforcement & Compliance.

The Community Team meets on the first Monday of every month from 6:00 – 8:00 pm in the Council Chambers at City Hall. All regular meetings are open to the public and public comment is encouraged. 

### **Superintendent Update By Mick Lane**

We need to celebrate the fact that we have not had a flood or fire for 4 months. Our District and community have experienced a large share of very serious problems this year, and we are hopeful the Spring has some good luck in store. Public support has been tremendous.

The District once again invites the public to take part in the education of our young people, and one opportunity to make a significant positive impact is to join the District Site Council. The Council has, in the past, taken on so many tasks that progress in any one area has been hampered by the limited time available and the small number of volunteer members. That is the reason the Site Council has chosen to narrow its focus to one area that will have tangible results and improve the mental and physical health of our students. By June of 2012, the Council will have devel-

oped and implemented a District Wellness Plan. Organization will include short and long term goals with specific actions and timelines. Focus areas are still being developed and include:

Physical education at all levels; Exercise; Mental health counseling K/12; Nutrition; District food service program; Healthy lifestyles; Social Skill development

Please, if you have an interest in working on the Site Council or taking part in any way, please contact the schools or District Office. We desperately need help!

The Board of Directors has declared as surplus a large number of items stored at the Langlois sites. A sale is being coordinated with the Boosters Club members who will conduct the sale and share the profits equally with the District. Many items will be placed for sale under sealed bid, and the remainder will

be sold garage sale style. Details will be forthcoming.

Board level discussions have taken place regarding the future of the closed schools in Langlois. Strong measures are being taken to maintain Blanco School, and to slow deterioration at the brick building/gym site, but our best efforts cannot indefinitely prevent the inevitable decline of unused buildings. It is quite costly to maintain the facilities and grounds. The possible sale of the properties has been considered as an option, with any proceeds placed in the budget and dedicated to facility upgrades, construction, and repair.

As the Board is taking this under consideration, public concerns and ideas are an essential part of the decision making. Plans are in place to provide opportunities for all constituents to give input to the Board on plans for the unused schools.

## Crab Season Starts Strong

One month of decent weather and good fishing has carried Oregon's Dungeness crab fishery into the new year with a boat load of momentum. In just four weeks following the crab season's opening, Oregon crabbers have harvested about 15.6 million pounds. Last season's entire eight-and-a-half month catch along the Oregon coast netted about 13 million pounds. The strong start has boosted the economies of coastal communities from Astoria to Brookings and sets the stage for what could be an excellent year for Oregon Dungeness crab. The opening price that fish buyers paid fishermen was \$1.75 per pound.

"If the season ended tomorrow, it would be an above average harvest, yet we still have seven and a half months to go," says Nick Furman, administrator of the Oregon Dungeness Crab Commission.

"What happens in January will determine whether this is a good start to a decent season or whether this will go down as a stellar season."

The fishery's historical average is about 10.3 million pounds per season. The all-time record was set during the 2004-2005 season as about 34 million pounds of Dungeness crab was harvested. That year, nearly 16 million pounds was landed in December, another nine in January. Not only is the quantity strong so far this year, the quality is high. The

size of individual crabs is generally bigger than normal and the amount of meat per crab is high. All factors are combining to produce a good economic picture at this point.

"The ex-vessel or to-the-boat value of the crab in four weeks so far this year is about \$27.5 million," says Furman. "Economists use a conservative multiplier of two to represent the personal income generated by related activities, including onshore processing. That means there has been about \$55 million in economic activity for Oregon's coastal communities thanks to Dungeness crab."

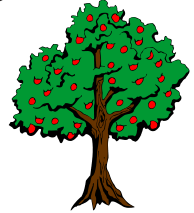

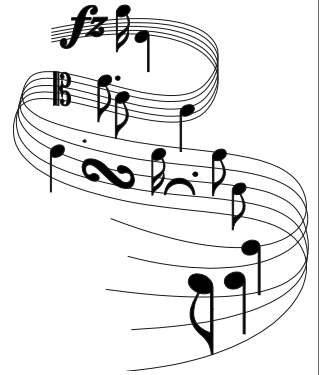
