### Candidates Front and Center By Evan Kramer

The League of Women Voters candidate forum was held in Port Orford last Wednesday night and we were treated to eleven candidates running for four offices who talked about themselves and answered questions. As usual the turnout by the public was excellent. LOWV forum moderator Shirley Nelson managed to use all the questions that were put forth by the public.

Harry Abel and Mark McKelvey running for the South Coast Education Service District board position #1 were there along with Jack H. Barnes and Marlyn Schafer running for the Curry Health District Board Position #4. David McCutcheon, Phil Colozzi, and Dianne Schofield are running for Position #4 on the Port of Port Orford Commission and Edna Auld and Kimberly Stang are running for Position #1 on the Port Orford Rural Fire District (PORFD) while Wade Phillips and Dave Bassett are contesting Position #5 on the board. One thing all candidates have in common is they are running for unpaid positions on boards where there is normally very little public interest or participation.

David McCutcheon said he has been a member of the Port Orford Ocean Resources Team since 2009 and wanted to represent the fishermen and fish resource on the Port Commission. He said the number one issue was the draggers taking over the black cod fishery noting the number one money maker for the Port and fishermen is the black cod fishery. Dianne Schofield said she is a small business owner who also serves on the city council. She said she was running for the Port Commission seat because she is a vested member of the community and 25% of the local economy comes from the Port and that she wanted to contribute to that success. She said she could be a liaison between the City and Port. Phil Colozzi said he wants to put the emphasis on fishermen totally and that they need to understand the administrative side of the fishing business. Colozzi has over 50 years of business experience and want to share that knowledge with the fishermen.

Kim Stang said she is from Sixes but has property in the PORFD. She said she wanted to be part of the business end of the fire district and would like to have a voice as well as seeing some people living within the City be more involved. Edna Auld said she takes her responsibility very seriously and has

been on the board for eight years. She is currently working on a director's handbook for board members. She described her agenda as seeing the board function as a serious group representing the taxpayers in the district, working on the handbook and providing a good environment for the firefighters.

Dave Bassett said he is pretty much living in Port Orford full time now and wants to bring a fresh perspective to the board. He called the fire department a very closed group where people are either friend or foe. Bassett said he could not see how the assistant fire chief (Wade Phillips) could serve on the board as it would be a conflict of interest. He said that Edna Auld had been around too long. Wade Phillips has been on the fire department since 1996 and is now the assistant fire chief. Back in 1996 he had witnessed a fire at a relative's house and decided at that point to get involved and joined the department. He joined the Port Orford Ambulance crew in 2000 and said he wanted to commit more to my community. Phillips said he wanted the fire board and the firefighters working together.

David Bassett was asked why he wants to be on the board and he said because of his experience and that he wouldn't

bring a conflict of interest to the board. He said we need citizens to represent the taxpayers.

The Port Commission candidates were asked what they would do about the lift fees if they were on the board now. Phil Colozzi said it would not be right for him to answer as he didn't know all the facts. Dave McCutcheon referred to the raising of lift fees as picking on the resource guys but added because of the raise in lift fees more spaces are taken now by the fishing boats. Dianne Schofield said the fee increases send the wrong message saying to the research vessels the Port didn't want them. She said the fee increases needed to be revisited.

The fire board candidates were asked if they would fire Chief Gayle Wilcox and hire Wayne Moore (Sixes Fire Chief) to replace her. All four candidates said NO with Dave Basset adding he would like to see more cooperation and mutual aid between the departments. Kim Stang said no and made it clear she wouldn't

hire Wayne Moore. Wade Phillips said the POFD already has a mutual aid agreement with both the Sixes and Langlois Fire Departments. Edna Auld said that both departments train and work as a team.

Kim Stang was asked why she wants to be on the fire board and she replied she wants to participate and be part of the community and become better informed.

Port candidates were asked how important is the collaboration between the City and Port with Dave McCutcheon saying important and wanting the two entities to work together. Phil Colozzi said we needed to bridge the gap between the City and Port. Dianne Schofield said there were many good people working in both agencies but they both need to work together.

Kim Stang and Dave Bassett were asked since George (Gehrke) and Joanne (Ruoff) support them do they agree with their letter that the fire board needs to take back control. Kim Stang said it is believed that the decisions made by the

board reflect the decisions of the fire department. Dave Bassett said he would listen to everyone and do what is best for the public.

All fire board candidates were asked if they were elected to the board what changes they would make in the fire department. Edna Auld said none. Kim Stang said the board members should have a key to each of the district's facilities so they can go in and inspect the equipment. Dave Basset said only positive changes and that he listens well. Wade Phillips said no and that the department has security issues at the buildings. He noted that the members of the city council and school board do not have keys to the their buildings.

Fire Board candidates were asked why the fire stations on Elk River and in Cedar Terrace were not in equipment readiness and ready to roll and why the assistant chief lives 12 miles out of town. Edna Auld said both fire halls are fully equipped and ready to roll. Dave Bassett said that all the stations

The Port Orford Rural Fire District – five people sit on this board. Joe Marsh, Brice Wagner, Ken Fliszar, Edna Auld and Marie Van Aart. The job of the board is to oversee that the finances that support the Port Orford Volunteer Fire Department are not squandered. At the moment we are in the process of obtaining a new “used” fire engine. The fire board approved \$100,000 to toward its purchase. Gayle Wilcox and Dave Johnson applied for a \$100,000 grant and received it, to also go toward the engine purchase. New turnouts, new lighter air tanks, new wild land fire gear, new boots all obtained by grants written by Gayle Wilcox our fire chief. We tell the fire board we have this money to make purchases. The money goes into the fire district’s account. They dole it out when we find exactly what we need. Simple. They don’t know what kind of boots we need, they don’t know exactly the size of each new turnout. They don’t know exactly what kind of engine we need. They don’t train with us. How could they know. But there are people George Gehrke, Joanne Ruoff, Brice Wagner and others who do nothing but

complain about the fire department. One breath says we applaud and support them and the next breath says the chief and her crew can’t do anything right. The Rural Fire Board runs the finances that’s all. They do not dictate policy of how we run our department. My name is Ed Tennant and I’m a fireman. One Wednesday nights when it’s cold, dark and wet I’m out training not sitting comfortably at home. I give up Saturdays and many days and nights to train, take special classes with others on our department. I ask myself why?

It’s not so we can be beat up by the George’s, the Joanne’s, the Brice’s, it is because we care about this community and everyone in it. I do not want to see Gayle Wilcox fired by the board and replaced by who knows.

A vote for Edna Auld and Wade Phillips will help ensure that this community continues to receive the best fire department ever. Yes, I’m very upset, very upset.

### Uniform Tsunami Warning

Curry County will change the current Tsunami Warning Test schedule to comply with state standards beginning in June 2011.

The pattern of sound and the duration of the test siren will remain the same up/down wail that lasts for three (3) minutes.

What is changing is that instead of Curry County sirens being tested on the first of each month at 5:00 p.m., the siren will now be tested on the first Wednesday of each month at 11:00 a.m. The first such test under the new schedule will occur on June 1<sup>st</sup> at 11:00 a.m., the second will occur July 6<sup>th</sup> at 11:00 a.m., the third will be August 3<sup>rd</sup> at 11:00 a.m. and will continue on the first Wednesday of each month thereafter.

are essential facilities and they need sprinklers. Wade Phillips said he lives in Denmark but works in Port Orford nine hours a day plus volunteer time pulling weeds at the baseball field. He said he is in Port Orford a lot and noted that the Langlois Fire Chief is also the Port Orford City Manager.

Fire candidates were asked why several Port Orford residents were serving on the Sixes Fire Department when they wanted to serve on the Port Orford Fire Department. Wade Phillips said it was because some of them can’t take constructive criticism and have bad attitudes. Dave Bassett said this situation was indicative of what he was talking about and that a reset in attitudes was needed. Edna Auld said some of the people weren’t willing to train enough.

We don’t have room for the statements of and questions directed to the SWOCC and Curry Health District candidates but will try for next week.

### Letter to The Editor,

First of all, I'd like to say that I don't enjoy politics. However I am appalled by all the negative and truly disrespectful remarks in the various letters to the editor these past several weeks. Why is the public attacking the Sixes River Volunteer Fire Department? And many are fellow P.O.C.A. and POVFD members! I find this highly unprofessional for members of a community service. You, as professionals, are supposed to uphold the bearing of a proper work ethic and attitude to the public face. This is not professional!

I am not pleased by all the letters attacking our fire department. We, just as POVFD and its rural sister, serve the community as unpaid members who risk their lives during service. We encompass a greater area than Port Orford, and include all the same studies, certifications and schooling that the members of the POVFD undergo. We are also the only station to have AR-AFFF, Alcohol-Resistant Aqueous Film Forming Foam, in the area. AR-AFFF extinguishes flammable liquid fires, but also suppresses the vapors they give off to prevent their potential re-ignition or re-flash, and is superior against combustible (A) and liquid (B) types of fires.

However, despite the fact that we provide the same services with the same

skills as Port Orford does, there are a number of people who are incriminating us. I joined Sixes because I trust the people that I work and train with, and there is no discrimination or "power trips". I would trust the men and women on the department with my life, just as I do my battle buddies in the army.

People, vote for whomever you want. Support whoever you want. But do so in a non-discriminating, inflammatory, or disrespectful way. I volunteered not only to be a fire fighter, but also to be one of the thousands of American Soldiers that will fight for your freedoms, and too often see that freedom abused!

### Letter To The Editor,

To educate the taxpayers and clarify "Facts" stated in the PON, April 27, submitted by George Gehrke & Bob Mielenz. Since neither attend Board meetings, whoever "informed" them of the "facts" was also misinformed.

1. Fact: The members of the board have been kept updated on the search for an engine, but no board member has asked to be directly involved at this time.

2. Fact: No one except firefighters with at least 6 months of continued service have the combination to the fire halls. This is a policy of the fire department to protect and safeguard the security of over a million dollars worth of equipment upon which they rely to perform their job safely. Fire board directors are aware that they may contact any firefighter and arrangements will be made for entry at a mutually convenient time. No Public entity, such as Schools, City Hall, Library, allows keys or combinations

for unlimited access to Board/Council directors.

3. Fact: The "jeep" was procured prior to 1996 as part of a Federal Excess Property Program (FEPP) by former Chief Gehrke. As it was never placed into service, by Former Chiefs or Boards, it was removed from the inventory of Port Orford Fire by FEPP. It was not a Board or Fire Dept decision. We're glad someone is making use of it.

4. Fact: It is imperative that we prevent the cross contamination of the invasive species that exists in Garrison Lake to the many other water areas, i.e. ponds, rivers and wetlands. The disinfection process is one that would put the equipment out of service for many days and would be caustic to the equipment. After research and at least three lengthy board discussions, the Board advised the Fire Department to not TRAIN with that source of water. Like ANY available water source, in an extreme emergency, Garrison Lake would be considered and used if necessary.
